Metteer. Griffiths was postmaster two years ago, and quit \$70 short in his accounts. The suit of the government is to recover this money.—Times Mountaineer.

Governor Lord made the following appointments Friday: J. W. Lawrey, Pendleton, prosecuting attorney, sixth judicial district; C. W. Parrish, Canyon City, prosecuting attorney, ninth district; Robert Enkin, Union, circuit judge, ninth district. These men are well known in Eastern Oregon, and are in every particular qualified for the positions named. J. N. Brown of Heppner was an applicant for the position of prosecuting attorney of the 6th district, but fell short of the mark.

Messrs. Ed Smith and R. H. Robinson of Arlington, two of the brightest young business men in the state, visited Condon on business the latter part of last week. Ed informed us that his father, J. W. Smith, is still sojourning at San Diego, Cal., and does not know exactly when he will come home. The coldest it ever gets down there is about 50 degrees above zero, and the warmest about 90 degrees above zero—thus making it the finest climate in the world. Mr. Robinson attended a meeting of the Odd Fellows lodge at Mayville Saturday night, and returned home Monday.

Don't send away for anything that can be bought at local business houses. Nothing breaks up and kills a town more quickly. Read what the Corvallis Times says on the subject: "Several Corvallis business houses have moved to other and fresher pastures this spring, and two or three others are preparing to follow suit. Their departure lessens the number of persons who pay rent, spend money for a living, and help to bear the common tax burden. It diminishes the town's wealth and the number of people in it. Lack of business, caused by Corvallis people sending abroad for their clothing, dress goods, groceries, printing, etc., explains why these firms are going away. If enough people persist in sending away for articles that they can get just as good and just as cheaply at home, by and by there will be no town left to tell the tale."

We hope the rumor is without foundation, but we learn that some of Arlington's citizens are trying to persuade our landlady, Mrs. Maddock, to come down there and go into the hotel business. We have not had Mrs. Maddock's opinion concerning the matter, but do know that she is not at all encouraged over the hotel business outlook at Condon. We know for a fact that Mrs. Maddock always has set her tables with the best that the market affords, and her hotel accommodations are the very best to be had in the country, for which her rates are very reasonable. But the most discouraging feature she has to contend with is that so many people prefer boarding at private houses to patronizing the regular hotel. We believe it is only right that when an enterprise of that kind is established in a place, in which a large sum of money is invested, it has a right to expect the public patronage. If it does not get the trade that is justly due to the proprietor can not be blamed for moving to a place where the public manifest more appreciation for a hotel enterprise. We hope, however, that Mrs. Maddock will conclude to stay with us.

A Case of Spitework.

Last evening Frank M. Lacey, residing in Albina, was arrested by Constable Connor on a warrant charging him with perjury. Lacey was at one time a member of the butchering firm of Lacey, Fink & Co., but sold out to C. F. Walker for \$1000, and, as alleged, agreed not to again engage in the retail butchering business. Walker had paid \$300 of the amount agreed upon, when Lacey again opening a butcher shop, contrary to stipulations, he refused to pay the remaining \$700. Suit was brought in the circuit court for the money, and was tried before Judge Shattuck yesterday, resulting in favor of Walker. Judge Shattuck directed District Atty. Hume to draw up an information against Lacey, charging him with perjury, which being done the arrest followed. Lacey's bonds were fixed at \$1000, which amount he furnished, and he was released from custody, pending examination.—Oregonian, March 16th.

F. M. Lacey, the well-known cattle buyer, is in this section this week buying beef cattle "on his own hook," to ship to the eastern markets. He bought a large number of cattle from Henry Wilkins of Clem and from W. J. Edwards and other cattlemen of the Mayville country. He informs us that his arrest at Portland is nothing but spite-work and jealousy on the part of several unsuccessful rivals, and that he does not fear any trouble from it. Mr. Lacey is well and favorably known in Gilliam county and none of the many cattlemen he has dealt with in this county has a word to say against him or his manner of doing business. He is very popular among all the stockmen, who hope to hear of his enemies getting "the worst of it" in the above suit.

Death of Mrs. Portwood.

Mrs. Sarah Portwood, aged 82, died Saturday last at the home of her daughter, Mrs. J. G. Stephens on Camp creek, Grant county, of paralysis. She had been in very poor health for several years and kept growing weaker until Saturday, 23d inst., when the good old lady peacefully passed away and joined the silent majority. The body was laid to rest in a private graveyard on Camp creek Sunday.

Mrs. Portwood was a lady of sterling qualities, of a loving and kind disposition and an exemplary mother. She and her husband moved in 1875 from Kansas to Polk county, this state, where the latter died three years ago. Five sons reside in this county—John, Ed, Joshua, Oscar and Tom, and one son, Henry, in Polk county, the latter being the only one of the children who was not present at the burial.
