L. W. Darling claims to hold the belt for the best 50 acres of wheat in this county, on his fine Hay creek ranch, six miles northwest of town. This is one of the best farms in Eastern Oregon.

Michigan has enacted a piece of sentimentality, by name a law, prohibiting "treating" in saloons. It is a mild form of prohibition, and the purpose is to protect weak men who cannot "refuse."

Another bicycle, about the same kind as that just raffled off here, will be sent out to Ed Moore today or tomorrow for raffie, and will be raffled by the same method as the other—by numbers ranging from 10 to 150.

Mr. and Mrs. F. B. Stevens returned home Saturday evening from Zillah, Wash., where they had been visiting relatives and friends. They report a very pleasant trip through a beautiful country, and over the loveliest of roads.

Gene Smith returned home Saturday from his visit to his relatives and old home in Colorado, and reports having enjoyed his visit immensely. Gene has a severe case of Colorado fever and thinks of removing to that state this fall.

The O. R. & N. Co. has taken off the 3000-mile tickets at \$75, or 2½ cents per mile, and substituted a 1000-mile book at 3 cents per mile or \$30. This change is done to accommodate travelers who find it more convenient to part with \$30 at a time rather than \$75.

First-class wheat is now selling at Arlington at 42c a bushel, with prospects of a rise to 50c within a short time. No wonder the farmers' faces are shortening up again. Their faces were so long a few months ago that the barbers charged by the yard for shaving them.

Geo. Angell and Henry Heckman left this week with Doc Brown's sheep and C. C. Grider and Robt. Carmine with Will Barker's sheep for the mountain pastures near Austin, Grant county, where they will remain until fall. Of course the GLOBE follows them.

Caldwell has purchased the Henry Ross property, south of Dunlap's blacksmith shop, on which he expects to build a butcher shop this summer, and will also build a dwelling house on his lot in the south end of town. A number of other new buildings will be built here this summer.

Everything sold at the Couture sale Saturday brought unusually good prices. W. J. Edwards bought all the cattle, 51 head and 15 young calves for \$545. The 7 head of good horses aggregated \$265. John Miller bought two of the best ones and will use them in the drive to Caldwell, Idaho, starting next week. The proceeds of the sale in all amounted to something over \$1400, which will go to J. W. Smith, through whose foreclosure the property was sold.

Of course no thief likes to be convicted—hence the howl when such verdict is rendered. Mr. Henshaw is expected home in a few days.

A La Grande exchange says: "The citizens of a number of counties in this state are again agitating the question of the county officials and their deputies being paid entirely too high salaries for the amount of work done, and are petitioning their respective county courts to cut down the deputy hire. In many instances, considering the small amount of work to do and limited ability of the officials, the salaries paid are outrageously high, and the taxpayers have just cause for complaint. It is ridiculous to pay men salaries amounting to \$6 and \$8 a day, when about all the work they have to perform is drawing their salaries, and often by men who have not ability or energy enough to make their board in private business. No man should be paid a salary amounting to more than he has ability to earn in any kind of private business."

The citizens of Arlington are agitating the question of building a telephone line from that place to Fossil, along the main road, running through Olex, Clew, Condon and Mayville. There is no question but what a telephone through this county from the railroad is very much needed, and as the cost would be very reasonable, we believe the citizens all along the route will subscribe liberally for this much-needed improvement. A line is being built from Pendleton to Long Creek and Canyon City, connecting all those interior towns, and there has been a line through Sherman county for several years. Every interior town of any importance in the state is enjoying the convenience of a telephone from their nearest railroad town, and why should Gilliam lag behind in the process of enterprise and development? By all means, let the line be built.

The Hard Times are Over.

Wheat which a few months ago was only 58 cents in New York is now quoted at 83½, twelve cents of this splendid jump having transpired in the last two weeks, and "few believe," says a well known commercial agency, "that the highest point has yet been reached in this wave." Frosts, and reports of damage to the eastern crops are assigned by the same authority as the primary cause. But it is also pointed out that reports indicate that exports of Argentine and Russia are this season to be restricted, and that countries that liberally import are short in the supply on hand. Wheat, however, is not the only product that has advanced in price, for in the past week corn rose 3½, pork rose fifty cents per barrel, lard five cents per 100 pounds, oats two cents and cotton three eighths of a cent per pound. In fact, the advance in prices is placed by Bradstreet at no less than 23 articles, including besides those mentioned, hides, leather, Bessemer pig iron, steel billets, nails, bar iron, copper, zinc, potatoes, poultry and butter. "The tone of the iron and steel market is the strongest since the depression of 1893-4." All of which goes to show that the unprecedented financial panic is over, and the good times that are sure to follow will place the country in a more prosperous condition than it has ever been before.

House Your Implements.

One of the blessings of hard times will be to teach Oregon farmers the economy of housing implements. It used to be a common thing for the traveler through Eastern Oregon or the Willamette valley to see farm machinery of all kinds, expensive harvesters and threshers, plows and all the ordinary implements, standing in the field where last used, usually without shelter from the elements. It was a common thing for the owner of large wheat and corn fields to buy new machinery in the spring or at harvest time, use it one season, leave it where used, and when the next season came round, find it in no condition for use without considerable repairs. In such cases the farmer was apt to trade off his machines for new ones, paying a large bonus, and often mortgaging them for all or part of the purchase money. Hard times is teaching the lesson of care for implements, just as it is enforcing the diversification of crops. The great thing to bear in mind is that the care of implements and the diversification of crops are not merely expedients for hard times, but essentials of a sound system of agricultural economics. The elimination of wastefulness is a necessity to us if we would thrive in the world-competition now forced upon us.

A Denial.

A number of country papers recently copied an item from a Portland paper, saying that Studebaker Bros. were about to ship 1000 bicycles to Portland to be sold for \$25 and \$30 each. A number of people wrote to Studebaker Bros. inquiring about the truth of the matter, and received the following reply: "The report that we intend to make or handle bicycles is a hoax. We have not made money enough on our wagons to indulge in the luxury of a \$25 bicycle. It will probably be some time before a good bicycle can be sold for that price. We have had thousands of inquiries in the last two weeks, and we have a shotgun loaded with pack saddles in the room for the man who started the story."
