There is a new baby at Bozzard's Bay, born to the wife of President Cleveland, and a girl too. Of course it would have been more satisfactory to Mr. Cleveland if it had been a boy, who would have handed down to posterity the historic name. But the country will rest satisfied with affairs as they are, and the event will furnish a subject for newspaper comment.

A correspondent from Drain, Douglas county, to the Roseburg Review says: Benton Mires, of Gilliam county, who has a stock ranch in that part of the state, arrived here with his family a few days ago and is visiting with his wife's brother, Horace Putnam and other relatives. County court convened last Wednesday, 3d, and the county business at this session was conducted by the two commissioners only. Judge Mariner has been sick for the last two weeks with a severe attack of a gripe and was not able to be present for court. The law and probate business that cannot be attended to by mail will have to go over until next term of county court—the first week in September.

Five bids were presented for the building of the Odd Fellows hall at Mayville, as follows: John McConnell of Mayville, \$365; S. Wattenberg of Fossil, \$347; Al McConnell and Ed Stinchfield of Mayville, \$325; N. G. Snider of Arlington, \$299.50. The latter being the lowest bidder he was awarded the contract, but as he failed to give the required bonds, the contract was let to the next lowest bidder—Al McConnell and E. A. Stinchfield, who will begin work on same at once.

Assessor M. O. Clarke informs us that the Arlington paper erred last week in stating that he was about through with his work of assessing the county. Mr. Clarke says he is a long way's off yet from being through, and has been granted by the county court on extension of time in which to return the roll. Taking the census requires an enormous amount of work which the former assessors have not had to do for the last ten years. Mr. Clarke is very careful and is doing excellent assessment work.

Married—at the residence of S. P. Shutt in Condon on July 4, 1895, Mr. John W. Clark and Miss Estella Flett, Justice Shutt officiating. A large number of invited friends witnessed the marriage and the happy young couple looked very handsome as the life sentence was imposed upon them to "take each other for better or for worse." Mr. Herbert Stephenson and Miss Minnie Clark acted as groomsmen and bridesmaid. The newly-wedded pair will begin housekeeping at once on the groom's homestead in Ferry Canyon, with the best wishes of a large circle of friends.

After several days' intense suffering, the result of giving birth to a still-born child, Mrs. Johnathan Boyer of Beecher Flat died Saturday evening about 3 o'clock. Although two doctors were in attendance—Drs. Howard and Hudson, the case seemed to be beyond their reach and skill, and a kind mother and faithful wife has joined the silent majority, leaving a husband and nine motherless children to mourn her untimely death. A very large number of sorrowing relatives and friends attended the burial at Mayville Sunday, Rev. E. Curran preaching the funeral sermon.

Coyotes have become so numerous and bold of late that "patience ceased to be a virtue" any longer with the sheepmen and stockmen, so they presented a petition to the county court last week asking for a bounty on their scalps. As will be seen in the proceedings, a bounty of \$1 a scalp has been ordered paid, provided the stockmen's union and all who wish to help rid the county of the pests will make up another \$1. In order to arrive at some conclusion in the matter, a meeting is called for July 20th, at one o'clock at Condon, and all persons interested are urgently requested to be present from all over the county.

R. E. Smith, accompanied by Justice Ebi of Arlington made a business trip to Condon and Mayville this week, stopping Thursday in Condon. Ed informs us that his brother Will expects to start next week to visit his father, J. W. Smith, in Southern California, and remain until next month, when they will both return home.

The Daily Oregonian has reduced its subscription price to \$7.50 a year, which is a considerable reduction, as it means the loss of \$2.50 on each one of its many thousand subscribers. As the Sunday edition is now furnished in connection with the daily for \$1 less than was formerly charged for the latter alone, the change will materially increase the circulation of the former. The year promises to enforce again the lesson of thorough farming upon the counties of Eastern Oregon. Thorough plowing and thorough planting will meet its due reward, but those who were lured into ease and content by the early outlook of volunteer wheat are now about to see their hopes shattered—between the dry weather and the grasshoppers. The weather bureau reports say that crops properly put in and looked after promise very well; but the volunteer-wheat farmers will be in sore straits again. Then comes a volunteer crop of populism and talk of financial tyranny.—Oregonian.

A dispatch from Moscow, Idaho, informs us that Geo. W. Goode has just brought an action against another attorney of Spokane, on a charge of criminal libel for "slandering" him through a newspaper. We learn that Mr. Goode recently was admitted to practice in all the courts of Idaho and that his enemies up there failed in the effort to have him disbarred, for which purpose C. I. Winick of Moscow was at Condon several weeks ago. In what would make a two-column article he informs us that he proved to the satisfaction of the courts up there that all those persons from Oregon who furnished affidavits against him did so purely through malice, and it is needless to add that he is not displeased at the result.

Our Celebration.

Notwithstanding the very wet and stormy weather on the 4th, about 1000 people enjoyed the festivities at Condon. The Moro Brass Band arrived here the evening before and kept the air full of "music" until Friday, when they departed for home. The entire program was carried out to perfection and each one performed their respective parts very well, the oration by Rev. Zellers being a brilliant and masterly effort. The prettiest feature of the celebration was the Liberty Car, all present being unanimous in the opinion that it could not have looked prettier, and that Louella Maddock makes an ideal Goddess of Liberty. The plug ugly parade and their program at the arbor created much merriment and was the funniest part of the exercises.

E. M. Clymer's horse from Fossil won the free for all race; Tom Keim's horse won the saddle horse race, and Roy Ebbert's the pony race. The ring race was very interesting and was won by Geo. Parman, who bagged six rings in three dashes.
