THE REPUBLIC OF CUBA.

Provisional Government Established by the Insurgents.
New York, August 9.—A special to the Herald from Nassau says: Reports from the rebel headquarters in Baire, Cuba, confirm the rumored foundation of a provisional government in the valley of Yara. General Bartolome Basso, nominated by the general-in-chief, Maximo Gomez, was proclaimed as president by the revolutionary forces, simultaneously in the central provinces and the department. Dr. Joaquin Castillo, Major Portundo, Captain Manduley, Captain Aguilera, Dr. Padron and Mariano Sanchez, delegates from the province of Santiago, have gone to Puerto Principe to meet representatives from Camagaya, Havana and Nuella Abajo, to draft a constitution for the new republic. This will include military and civil conditions.
The cabinet is not yet announced, though Antonio Maceo, it is said, has received an offer of the portfolio of war.
It is understood that Castillo may be sent to Washington to attempt to secure recognition for the provisional government.

Lord Sholto Going Home.

San Francisco, August 8.—Lord Sholto Douglass is going home. His eventful and sensational visit to this coast will terminate inside of ten days or two weeks. He is settling up his business and getting his luggage together, and Saturday, accompanied by Lady Douglass, will leave for Los Angeles. It is his intention to spend a little time in Southern California. They will be the guests of several wealthy English families in Los Angeles, and before going East will visit San Diego and all important places of interest. From Southern California, Lord and Lady Douglass will go East. They will take a hasty spin around the principal cities, and in September they expect to be steaming across the Atlantic, on their way to England. It is at the request of the Marchioness of Queensberry that the young couple are going to England.

Had Been Killed by Indians.

Waukeemiss, O. T., August 9.—The three skeletons found west of here three weeks ago have proved to be the remains of two Fowler boys and their brother-in-law, who were killed by Indians in 1875. The remains were identified by an ankle brace which was found near the remains. Relatives of the Fowlers are wealthy residents of Canton, O., to which place the remains will be taken for burial.

COLLIDED IN MIDOCEAN

The Prince Oscar and an Unknown Vessel Sunk.

NO ONE FROM THE LATTER SAVED

The British Steamer Catterhun Was Wrecked Off Cape Hawk, and Sixty Persons Drowned.

Philadelphia, August 10.—The British ship Prince Oscar, from Liverpool, Captain Henderson, collided in mid-ocean, July 13, with an unknown sailing vessel. Both ships sank in less than ten minutes. Six members of the crew of the Prince Oscar and all on board the unknown vessel were lost. The survivors, seventeen in number, were rescued by the ship Dharwar, after being in an open boat with neither food nor water for three days. They were transferred to the steamer Capac, from Pisagua, and brought to this port tonight. The names of the lost are:
William Knight, cook; Oscar Nelson, seaman; E. Peterson, seaman; August Carton, I. Relap, J. Anderson, steward; the entire crew of the unknown vessel.

The disaster occurred soon after midnight, in latitude 9:30 south, longitude 28:20 west.

The Prince Oscar was bound from Shields, where she left May 9, for Iquique, laden with coal, and was going at a clipping gait, on the port tack, before a brisk wind, and all canvas was set. It is estimated by the crew that she was making about 6-12 knots an hour, when suddenly there loomed up directly under her bow a four-masted vessel. The mate asserts that the stranger had no lights burning, and after she was sighted, it was impossible to alter the course of the Prince Oscar. The iron hull of the latter struck the unknown ship full amidships, knocking her almost on her beamends, and crashing through the woodwork until her prow was half buried. The stranger went over at once on her beamends, as the Prince Oscar backed away from the rebound.

Afterward the Prince Oscar stood by. Through the darkness, her officers saw the stranger right herself, and then she rapidly sank. They listened in vain for some sign of life, but not a cry for help nor a word of command came from the stricken vessel. In less than four minutes from the time she was struck, the stranger keeled over and plunged stern first into the depths below.

Captain Henderson, of the Prince Oscar, who was below in his berth, rushed on deck just in time to discover that his ship was also sinking. The pumps were manned, but in less time than it takes to tell, it was discovered that there was no hope from that source. Lifeboats were ordered out adrift, and the men told to jump and swim for their lives. They all went overboard, and with the exception of two unfortunates, reached the small boat.

Captain Henderson, who was the last to leave the ship, went over in his night garments and swam fully two miles before being picked up.

Both boats cruised about the scene until daylight in an effort to rescue the two missing members of the Prince Oscar's crew and any members of the crew of the stranger, who might have been fortunate enough to have kept afloat. They found no one, however, and nothing to indicate the name, home or destination of the strange ship. Finally they left the scene and headed they knew not exactly where.

Four hours later a heavy sea struck the boat commanded by Mate Lynch and capsized it. The occupants, eight in number, were thrown into the sea, and the already overcrowded craft, which Captain Henderson commanded, put quickly to the rescue. They were successful in taking four men on board, the rest drowning.

There were now seventeen men in the small lifeboat, with nothing to eat, nothing to drink and barely room to stretch their limbs. Toward evening of the second day one of the crew discovered a small case of fishoil stowed away in the lifeboat. This was dealt out to the survivors in small doses, and they used it to moisten their parched lips and tongues. Most of the men were partially naked, having had no time to secure clothes.

For three days they floated, and just as they were about to abandon hope they sighted the ship Dharwar, from London, bound to Melbourne. They succeeded in attracting the attention of those on board, and were soon on her deck. Four days later they were put aboard the Capac for this port. All of the survivors still bear evidence of the sufferings which they endured.

Sixty Were Drowned.
Sydney, N. S. W., August 10.—A boat's crew of Chinese who were landed at Forrester report that the British steamer Catterhun, from Hong Kong May 27, for Australia ports, was wrecked yesterday evening. The fate of the remainder of the crew and passengers is unknown. A tug which has returned from the scene of the wreck saved some of the passengers and crew. There is but little doubt that sixty persons were drowned, of whom forty-six were Chinese. Second Officer Langfar, who had the watch on deck at the time of the disaster, states that the night was very dark. Suddenly the steamer experienced a terrible shock, and foundered a few minutes afterward. The Chinese made a rush for the boats, but only one boatload reached the shore. The missing passengers include thirty women.

SEASON NEARLY OVER.

About as Many Cases Packed This Year as Last.

Astoria, Or., August 10.—The fishing season of 1895 will close with the present week, and the total pack will probably foot up between 480,000 and 490,000 cases. M. J. Kinney's trade circular, just issued, says:

"The season about to close has been a particularly bright one in the history of the salmon-canning industry, and, notwithstanding the great shortage at the Cascades and The Dalles, it is safe to say that the increase in the lower river catch will bring the total pack fully up to last year's figures. Fish have been unusually good in quality throughout the season, and orders have come in freely and steadily since the first shipments were made. The demand for export has been much greater this year, and shipments to England will reach 110,000 cases, as against 35,000 cases last year. The quantity of salmon left for the United States markets will therefore be 75,000 less than for the season of 1894.
"A noteworthy feature of this year's business has been the change in the laws of Washington which has permitted Sunday fishing. In the interest of the future of the canning industry, it is to be hoped a remedy will speedily be found.
"Canners are evidently more determined than ever to further the plan for the establishment and maintenance of a hatchery on an adequate scale on the Clackamas river, believing not alone that such a step is necessary to perpetuate the industry, but that it can be materially increased thereby at a comparatively small expense.
"It is of course impossible at this time to give an absolutely correct statement of the pack for the present year."

A RACE-HUNGRY CITY.

Horsing to Be Resumed on the Harlem Track.

Chicago, August 9.—After a rest of several weeks, the Chicago Fair Grounds Association, operating the Harlem racetrack, has arranged to resume its thoroughbred racing, which was interfered with by the Civic Federation. Hopes of legislative action in the direction of the turf law which would permit pool selling on the tracks have failed, and an effort will be made to conduct a meeting without public betting. There will be many handbooks at the track, but the association will derive its support from the gate and privileges. Because of a great public demand for racing it is believed that the attendance will more than pay the purses. Over 300 good horses are now stable at the track.

The management has hopes to be able to secure such patronage as will warrant the running of a \$25,000 national derby and other stake events arranged last winter, and which have never been declared off. The jealousy existing between the local tracks and that at Roby this spring is a thing of the past, and Corrihan and the Indiana track-owners will turn their full influence to make the meeting at Harlem a success.

Political Affairs in Salvador.

New York, August 9.—A special from Panama says:

Authentic advices from Salvador contradict the exaggerated reports that are circulated of the condition of political affairs there. They do not sustain the announcement that is made of riots in the republic, nor of adverse criticism of the president. A syndicate of London has offered a guarantee of \$5,000,000 to Salvador's agent to carry out practically all the railways building and projected in the republic.

To Impeach Mexican Supreme Court.

City of Mexico, August 9.—Senator Rodriguez Talvera, feeling himself aggrieved by a recent decision of the supreme court, which, he asserts, was made contrary to law, will formally present an accusation against the court before the grand jury of the nation, which is composed of members of congress, sitting to hear cases of impeachment.

Boundary Dispute Settled.

New York, August 10.—A World special from Tegucigalpa says: An agreement settling the boundaries between Honduras and Salvador, published officially, will take effect immediately. The case which has been pending regarding the boundaries and Guatemala's claim for \$120,000 loaned Honduras, plus interest, has not been decided.

Funeral of Mrs. Talmage.

Brooklyn, August 9.—The funeral of the late Susan Whittemore Talmage, the wife of Dr. T. DeWitt Talmage, took place this afternoon from the Lafayette avenue Presbyterian church. Rev. Dr. Gregg, the pastor of the church spoke in glowing terms of the life and character of the deceased. Interment took place at Greenwood cemetery.

POOR LOT OF JURORS

Judge Murphy's Troubles in the Durrant Case.

BOTH COUNSELS DISSATISFIED

Brown and Nathan Found to Have Peculiar Opinions on the Subject of Circumstantial Evidence.

San Francisco, August 9.—This was a day of surprise in the trial of Theodore Durrant, charged with the Emanuel church murders. The perturbation of Superior Judge Murphy, and the attorneys both for the prosecution and defense, was evident when the hour for opening court arrived. Counsel for the state and for Durrant had held a long conference before court opened. The judge had no sooner taken his seat than he announced a recess, and requested the opposing attorneys to accompany him to his chambers. The consultation lasted some time.

When the court session was resumed the district attorney asked for an adjournment until tomorrow, a request in which defendant's counsel joined.

The attorneys stated the adjournment was necessary for consideration of matters of importance which had arisen in the trial. The sensation was caused by the prosecution's dissatisfaction with Juror Walter S. Brown, who would not convict M. D. Howell, the counterfeiter, upon circumstantial evidence.

Another disturbing factor was the discovery that another accepted juror, Charles P. Nathan, had a record for refusing to inflict the death penalty, and for his discredit of circumstantial evidence. In granting the motion for an adjournment, the court said that a delay now would save time later on. The judge added that certain exigencies had arisen which would be disposed of at once.

While speculation was rife among the juror matters, another sensation was caused by the request from Juror Brown, who had precipitated all the trouble, for permission to address the court on a personal matter. The judge intimated his willingness to hear Brown at the proper time. It is said Brown will invite the fullest investigation as to his conduct in the Howell trial. He and Juror Nathan will both be asked, it is said, to explain their changed opinion regarding circumstantial evidence, and the infliction of the death penalty. At the examination of jurors, each gave satisfactory answers to the district attorney on both points. Another cause of trouble in connection with jurors, was the cause of the judge's unusually stern admonition to the jurors not to discuss the case with anyone. Reporters for morning papers had interviewed Jurors Brown and Nathan regarding their qualifications to serve, and their opinions on mooted points. The interviews were published, and proceedings for contempt of court are said to be under consideration by the court. A report that an attempt to bribe a juror had been discovered is generally discredited.

District Attorney Barnes announced that, for the purpose of avoiding delays that might arise in the sickness or death of a juror, fourteen jurors will be empaneled to try Durrant. Attorneys on both sides have agreed on the action from the fact that the trial is expected to last several months. The two extra jurors will attend the sessions of the court the same as other jurors, but will take no part in formulating a verdict unless called upon to act as alternates. The law authorizing the swearing in of extra jurors was passed two years ago by the California legislature.

Man and Relics Gone.

Chicago, August 9.—James H. Love, of San Francisco, owner of one-eighth in the Forty-nine mining camp, has disappeared, and, by coincidence, a lot of property and relics exceeding \$10,000 in value are missing. Among the articles are the prized James W. Marshall relics, which include a bedstead, washstand, rocking chair, saddle, clothing and weapons now held in trust by the circuit court. An effort to locate Love will be made in the belief that with him will be found the articles. On August 3, L. J. Witte was appointed receiver of the Forty-nine mining camp by Judge Horton. Witte at once employed experts to audit the accounts. Some things were found, said Witte, that strengthened the opinion that money had been carelessly handled. An inquiry at Love's boarding house elicited the information that he had gone to Atlanta. Along with the relics have gone as well all the Mexican music which had been collected by the stock company at much trouble and expense.
