Bill Livingston resigned the city marshalship and the city council has appointed W. L. Richards to that position.

Ed Tippley and Charley Busby went through town Tuesday with a band of good horses, which they intend to ship to the east.

Mitchell has been having a regular epidemic of typhoid fever, there having been nearly twenty cases within the past two weeks.

Two sheepmen, A. E. McCreedy and M. McDonald of Bickleton, Wash., were in this section last week. They left Saturday for Mitchell.

Geo. Lawrence of Portland, collector for the large harness and saddlery firm, of which he is a member, was in town Saturday on business.

S. B. Barker returned home from Portland Friday. His wife will remain in the city a few days visiting Mrs. Copner and other friends.

Surveyor Jedd Brown and his father-in-law, W. W. Kennedy, came over from Fossil and surveyed a portion of a new road several miles east of town Saturday.

It is a little early for fall fights, but the season opened up here Wednesday by a vigorous scrapping match between Bill Stephens and Hugh Hendricks. No arrests as yet.

Mr. and Mrs. B. Kiely of Eightmile came up to town Friday and visited their daughters here until Monday. Their son, Bart Kiely, came up with them and will remain here and attend our excellent school this winter.

Mr. and Mrs. Chas. B. Sears expect to leave the first of next week to be absent until the 1st of December, on a visit to relatives and friends in Portland and Vancouver. Charley expects to visit San Francisco also before his return.

Rev. Drake, of Weston, a minister with a family consisting of a wife and three children, has been appointed by Rev. C. F. Clapp to take charge of this circuit, and is expected here this week. He will likely preach here next Sunday.

John M. Brown of Lone Rock and Frank Cornett of Lost Valley each made proof on a timber culture Monday before deputy clerk, C. O. Portwood, with Geo. Knox and Riley Fraser as witnesses. Mr. Cornett left next day for his home at Albany.

Ad Renner came in Wednesday from the mountains near Monument, where he pastured his sheep all summer. He has just recovered from a severe sick spell, and reported that Howard Tobey is also very sick at Monument and not able to ride horseback. Gene Smith started out with a buggy at once to bring him home.

Geo. Thompson, who came out with his family from Montana last spring and located on Hoover creek, caught a large catamount Friday night in a trap and killed the brute. All summer it had been killing colts, calves and sheep in that section and the settlers thought it was a mountain lion until Mr. Thompson bagged him.

The school entertainment Friday night was largely attended and an interesting program rendered. A reading contest for a prize by six young ladies was won by Miss Carrie Danneman. A collection amounting to \$5.45 was taken up, to be used in buying lamps for the school house. A similar entertainment will be given every alternate Friday night, the next date being Oct. 25th.

J. S. McKinney's saw mill near Lone Rock burned Tuesday night, from some unknown cause. Only about 3000 feet of lumber burned, leaving about 20,000 feet remaining in the yard. The fossil editor in his last issue tries to create a sensation by accusing the GLOBE of libeling or slurring the district attorney. Of course with the Journal the "wish is father to the thought," but it will fall wide of its mark. Its editor backs his opinion by stating that a "well-known attorney of Gilliam county" thinks it is almost a hangable case. He forgot to state, however, if the said attorney is "well-known" for his ability as a lawyer or for dishonesty. It certainly cannot be the former, as no lawyer with any ability could see any "slur" in the GLOBE's item, unless he were blinded with malice against the GLOBE. What the GLOBE stated last week, in substance, was that, as the Rinearsons are prominent and wealthy they doubtless would make an effort to have the case dismissed or squashed somehow, when the proper time comes. And the chances are that they will try it—for the Journal stated itself that Rinearsons' brother, an attorney, came up from Oregon City a few days ago for the express purpose of trying to effect a settlement—even this early in the case. Both of them were at Arlington and it is not at all unlikely that they have already spoken to the district attorney about the matter. Our item does not say that the district attorney can be induced to dismiss the case—but that the defendant will perhaps make an effort to have the case dismissed. If anyone has a kick coming it is the Rinearsons, instead of the district attorney. If the GLOBE sees fit to criticize the actions of a public official it will do so without fear or without first consulting the Journal outfit. The public would very often get better service from public officials if the press criticized oftener when criticism is necessary.

SHOULD BE A REBATE.

There ought to be added to the taxation laws of the state of Oregon a provision for a rebate to the taxpayer who pays his taxes promptly. Under the present system prompt payers of taxes are called upon to pay not only their own taxes, but interest upon the taxes of slow payers, as well as interest and principal of the taxes of taxpayers who do not pay at all. A system of graduated rebates for prompt payers and penalties for slow payers would solve a vexed problem, and make it important to all taxpayers to be prompt. Such a system is in vogue in New York, and how well it works is clearly stated in the following from the New York Times:

"When the office of the Receiver of Taxes, in the Stewart Building, was closed, at 4 o'clock yesterday afternoon several million dollars in checks and cash had been paid into the City Treasury.

Col. David E. Austin, the Receiver, yesterday opened the books for the payment of taxes, and as soon as the doors swung open the rush that takes place every year occurred. Those who pay during this month receive a rebate at the rate of 6 per cent per annum until Dec. 1st. Those paying in November will not receive the rebate. After Dec. 1st 1 per cent will be added, and after Jan. 1st, interest will be added at the rate of 7 per cent, from Oct. 1.

If personal taxes are not paid by Jan. 15, the Receiver may issue his warrant to the Marshal for their collection by distress and sale."
