### THE SOCIAL QUESTION.

We take the following just editorial from the Corvallis Times:

"Mrs. Hannah has been taken to the penitentiary, and is serving out a life sentence for the killing of Mrs. Hiatt. It is alleged of her crime that an intimacy between her husband and the Hiatt woman was the provocation for it. Thus, with his mistress in her grave and his sinned against wife in prison for life, Hannah, the guilty man whose lecherous antics brought on the mischief, hangs from no sour apple tree but, on the contrary, is free as a bird, ready perhaps and looking for more decency to de-bauch. The manner in which this proud specimen of his race slinks out of this affair, unscathed by the law, and perhaps uncondemned by public opinion, is another evidence of how society and the law hold women accountable for what they excuse in men.

"Mrs. Hannah probably deserves all of the punishment meted out to her, but how many thousands of husbands, fired by jealousy, have shot down in cold blood the fancied rival, and been cheered by a verdict from the coroner's jury of 'justifiable homicide.' How extremely likely is it that if the man Hannah had gone gunning for another man whom he believed a meddler in his domestic affairs, that the jury would have kindly disagreed or mercifully have returned a verdict of not guilty.

"As to the social circle, let a woman make a false step and she is kicked out of society and the door closed forever against her. She may be willing to redeem herself, to wipe out the stain, but a cold and cruel world holds her at arms length, reminds her of her mistake, and slams the door in her face. The man though, who has similarly erred rarely meets rebuff. Oft he is heralded as the lion of the hour, coddled by mummies and petted by lasses. The social nose is not elevated at his approach, though it slanted Heavenward at an angle of 45 degrees at sight of his female victim. This is what society does—it always forgives the man; it never forgives the woman. It is not right; it is all wrong; but it is exactly what the world does, and it is the fair and frail side of humanity that deals most harshly with her own sex."

### THE STATE ASSESSMENT.

Twenty-nine of the 32 counties have sent in their assessment rolls to the state board of equalization at Salem. These 29 counties show a decrease of \$1,000,000 from the equalized assessment of last year. The 3 counties yet to hear from are Multnomah, Umatilla and Benton. Besides holding their own, these 3 counties must show an increase of \$1,000,000 to make the total valuation equal to that of last year.

A communication to the board from the assessor of Josephine county says that lands in that county, improved and unimproved, town lots, machinery, tools implements and merchandise, were listed at half value; horses a little below actual value; cattle at selling price last March; hogs at 2c per lb; notes and accounts at face value. Josephine's assessor reports mining lands as the most difficult to assess. He assessed mostly from the surface.

Notwithstanding the law that property shall be assessed at its true cash value, most of the assessors yet heard from are candid in their statement that property has been assessed all the way from 50 per cent of its cash value to its real value.

Lincoln county's basis was 80 per cent with notes at face value; and 75 per cent was placed on Polk county, and Gilliam aimed at true cash value, except notes and accounts, which varied from one-half to face value. Union's assessors reports horses listed above the market price, and other articles varying a little from last year.

The following decision by the supreme court of Indiana will interest young girls contemplating matrimony. A case was appealed to the supreme court wherein a wife sought a divorce on the ground that her husband was a drunkard, and the court ruled as follows: "You voluntarily choose a drunkard as your husband, and you should discharge the duties of a drunkard's wife. His failure to keep a pledge of reformation, before marriage, does not justify you to desert him. Having knowingly married a drunkard, you must make yourself content with sacred relations."

### A Music School.

Mr. Editor:—I wish to make a motion and hope it will be heard by all the citizens of Condon and the suburbs thereof.

The motion is this: Resolved, That Condon have a music school.

The need of such a school is, I think, apparent to all. We have plenty of talent, good voices and musical bent, but it lacks the power and effectiveness which comes from training. It needs development and cultivation. Our young people, and we may say many older ones, are desirous of, and even demand it. If this just demand is not met, the flower of our youth will drift away, and be lost to the town. This we cannot afford, unless we want to see our town retrograde instead of advance. In order to build up the town, as its importance as the county seat demands, we must not only restrain all the people we have, but attract other worthy and desirable people to us. This can be done in no way so effectively and certainly as by providing every possible opportunity for the cultivation and betterment of the people.

The excellence of our public school is being recognized by the people of the surrounding country, as is shown by their moving to town to enjoy it, and more would come if houses could be found; and if while attending the public school they could have access to a school of music, where both vocal and instrumental music was taught by a competent instructor, these people coming here and getting homes for themselves, would be building up our town, and this should be considered by the citizens and business men.

Then again, the home should be the center of our thoughts and aspirations of our youth. If we would keep our boys and girls from frequenting those places where their lives would be turned into the wrong channel and their finer sensibilities dulled, we must make the home beautiful, pleasant and refining and consequently more attractive to them than any other place.

What is more refining than music? What is more beautiful and helpful, than to see, as the evening shadows draw around us, the labors and cares of the day are done, father, mother and children gather around the fire-side, and with voice and instrument, forgetting the care and toil of the day, they woo the sweet angel of slumber by rendering some pure and inspiring song?

Why send our children away from home for their musical education, thus depriving ourselves of their help and companionship, to say nothing of the heavy expense, when by a little enterprise and push we can have a music school at home? There are other reasons, but let this suffice for the present, as my object is to simply bring it before the people.

But some will say that to start such a school would require quite a sum of money, and that "times are too hard." While it would, no doubt, be a good thing to have money to start with, yet it is not absolutely required. Some of the finest schools and business in the country have been started with but little capital. As to the "hard times," they are, I think, rather favorable to the enterprise. The experience of the past 2 or 3 years, would induce economy—a thing very necessary in the beginning. Besides, the hard times have so shrank the income that we have not the means to send our children away—at an expense of from \$200 up, per year. These things being true, the fact remains for us to face that unless our children get this education at home, they must be deprived of that which is thought so essential to entrance into society. This is not at all a pleasant thought to any of us.

Let the school be started modestly, and it will be stronger in the end. A room which would suffice for the present could be secured in some of the buildings in town. That which will make the school a success, is students. These are more important than a fine building, at least to begin with.

Now seems to be the opportune time, the golden moment, as it were for Condon before some of our neighbors take hold and we are left out in the cold. And especially is this true, as I am told that a music teacher of considerable experience is looking this way, and may be here shortly to interview us on the subject.

Who will second the motion? Let those of us who have children to educate think on the matter, and do the most we can to fit them for life's active duties. Who will say something on the subject? A CITIZEN.
