Mr. Fred Adlard of Ajax was in town yesterday. He informs us that school in that district began last Monday, with Mrs. Ed Palmer as teacher. At present school is being held in a private dwelling house, but a meeting will be held next Saturday to make arrangements for building a school house this spring.

Grant county is said to already have 10 candidates for sheriff on the republican ticket, and a great many precincts yet to hear from. The sack of over \$1000 that Sheriff Combs got for taking a few prisoners to Salem not a great while ago is evidently responsible for this breaking out of the office-itch in neighbor Grant.

Charley Shaw, who deserted his family at Condon four years ago, was liberated from the state penitentiary last week, after serving a term of two years. He was sent up under the name of Shaffer from Oregon City on a charge of assault with a deadly weapon, having hit a man over the head with a revolver, so he says.

The democratic and republican state conventions will be held in Portland on the same date—April 9th. The democrats are entitled to five delegates from this county and the republicans three. The apportionment for democratic delegates was made as follows: One delegate at large from each county, and each fraction of 50 votes or over cast for Hon. A. S. Bennett at the last election.

It appears that the Globe was a little ahead of time in reporting the marriage of Mr. Ben Glisan and Miss Myrtle Perrin at Antelope. It turns out that the marriage has not yet taken place, although we got the information from a party here who received a letter from Antelope saying that the affair would come off on the day named. Perhaps the parties only wanted to get married and were afraid to ask each other.

A listener one time asked what the Democrats were doing in Congress. "Oh," replied the reader, "they're playing the dickens over there. They've passed a law adding two months to the year, and the worst of it is they made both winter months." "Blast their souls," said a listener, "and I'm nearly out of fodder!"

The St. Louis Globe-Democrat estimates that the expenses of the two political conventions, for each of the political parties, to be held in Missouri this year will cost \$5,000,000, or \$2,500,000 each, and that the expense of the campaign in the state will be another \$5,000,000, making the election expenses for the year \$10,000,000. This it thinks is not extravagance, nor is it money wasted. But it is more than eight dollars apiece for every inhabitant of the state, or about \$40 for each legal voter.

The republican party in Multnomah county is in a deplorable condition. It is divided into two factions, with Joe Simon and his following at the head of one faction, arrayed against Mayor Frank, District Attorney Hume, John Minto, James Lotan and Jack Mathews. With such leaders there is little to encourage the honest element in the party. Every one of the leaders on either side is a professional politician, who is in politics for revenue, and is as corrupt as Judas. There is an old saying however to the effect that "when thieves fall out honest men may prosper," which affords a hope that Multnomah county may not be turned over, body and soul, to either of the opposing elements. A set of officers may be chosen who owe allegiance to no neither of these factions.

We are gratified to note the disposition of some of our eastern contemporaries to stand up for "man's best friend," the horse. In another column we quote from the Chicago Record words which will be cheerful to horsemen. In the past 40 years we have seen the horse go and come three times. From 1857 until the war broke out there was no market for horses. The war caused an increase in price and the market was good until 1873, when there was another decline. Prices recovered and were good until 1893, when there was another decline, since which time the export trade has been the life of the market. From past experience we look for an upward tendency now. The effect of the bicycle upon the horse market has been greatly overestimated. The slump was the natural result of the depression that affected all other lines of business.

The make-up of a ticket can, in a large degree, be determined by the result at the primaries, and it is of vital importance that representative citizens who will vote as they think and are not subject to the control of any clique, be sent to the county conventions. The man who stays away from the primaries is neglecting a duty, the performance of which is as necessary as that of voting at elections. Another thing voters should keep in mind is to select only such delegates as will surely attend the convention. The proxy system is fraught with dangers, and by it the will of the people in the locality from which the proxy is sent is often defeated. No man should be chosen a delegate unless he has interest enough in the party and community to cause him to attend the meeting of the convention. Let representative citizens be chosen to name tickets and let only those be elected who are certain to attend. In this way the ends of good government will be served.—Dallas Chronicle.

Democratic Call.
