The Astoria Herald states that the editor of that paper, E. M. Shutt, has just been reappointed deputy district attorney by Mr. Jayne. It is presumed the Herald is satisfied with the appointment; for if it wasn't, it would doubtless have said so.

A very large audience was out Thursday night to the entertainment and public installation. A very interesting musical and literary program was rendered, which was highly appreciated. A social dance was enjoyed afterwards by a number of young people.

Judge Bennett of The Dalles is billed to deliver an address before the 6th annual meeting of the Oregon Bar Association at Portland on August 20th, on the subject of "Railroad Receiverships." This, like all of his speeches, will be a brilliant and masterly effort.

Wednesday in Portland 320,000 acres of land embraced in the Northern Pacific grant, and located in Gilliam, Morrow, Umatilla and Multnomah counties, were sold at public auction by Master of Chancery Cary. The land was bid in by President Winter for the company at \$903,000.

Ed Hartman, who had been in the Willamette valley for several years and who was married last winter, arrived here this week and will make their home in this section. His father, A. Hartman, met them at Arlington with private conveyance. Ed says this country beats the valley "all hollow."

Wm. J. Bryan and Arthur Sewall, democratic nominees for president and vice-president, met in New York yesterday for the purpose of being notified of their nomination. It is almost a shame that these gentlemen have been kept in ignorance of their nomination so long. No doubt the news will be a great shock to them.

W. L. Barker was in town the first of the week, his first trip out since his severe accident of a month ago. He still walks lame and is pretty badly "out of repair" yet, having been ruptured by the saddle horn striking him in the abdomen. He thinks he will go to Portland next month and receive hospital treatment awhile.

Mr. James Parker, administrator of the estate of L. Parker, deceased, came up the first of the week from Goshen, Lane county, and sold the horses, harness and stage coaches of the Arlington-Fossil stage route to the Fossil liverymen, Reed, Buckingham & Nevins, all young Englishmen. The price paid was \$900 cash. We understand this amount will not pay the indebtedness against the estate by several hundred dollars.

About one month ago the Portland papers reported that Henry Cook, a saloon man, shot and dangerously wounded a Mrs. Marr and then suicided by shooting himself. The Portland Tribune stated that the lady's name formerly was Miss Jennie Clarno, which is a mistake. A number of papers throughout the state copied the item, the Globe being one of them. Just how the mistake was made is not known to us, but we cheerfully make the correction.

J. H. Miller and family left yesterday in a covered wagon for their new home in Jackson county. Nearly all of the young people of the town and vicinity tendered them a surprise party Monday evening, which all enjoyed very much. The best wishes of their many friends go with Mr. Miller and family to their new home. After the party, a number of young folks treated the town to a general serenade, by singing at the various residences, which was greatly appreciated also.

Mayor Pennoyer is making radical reductions in the salaries of city officials in Portland, himself included. In the police and fire departments the reductions amount to about \$25,000 per year, the mayor taking only one-half of the \$5000 a year, allowed him by the charter. He says: "The taxpayers are struggling for merely an existence and their servants should be brought to the same basis. No man has a right to revel in luxury at the expense of the taxpayers these times. There is no sense or justice in paying any official more than he has ability to earn in private business."

"The meanest man I ever saw," an irrepressible Washington judge exclaimed to a crowd of admirers, "has never appeared in my court as a defendant, and it's lucky for him. As a matter of course he was a newspaper man—a rascal of an editor. One day he was playing seven-up with a young lady friend and guess what he did? He told her that whenever she had the jack of trumps it was a sure sign her lover was thinking of her. Then he watched her, and when she blushed and looked pleased he would lead a high card and take her jack. A man who would do that would steal a hot stove."

Hon. Chas. Richardson, deputy U. S. Attorney-General, of Washington, D. C., whose business it is to take testimony in Indian war deprecation claims, arrived here Saturday for the purpose of taking testimony in the case of H. C. Strickland against the government for the loss of a large band of horses that were stolen from him by Indians in 1887 near Heppner. Mr. Strickland not having time in which to secure his witnesses, the matter was postponed until a later date, when Mr. Richardson will come over from Puget Sound and take the testimony.

Dan Cameron of Shuttler Flat, who went down to Benton county some time ago on the lookout for a new location, came back a few days ago thoroughly disgusted with the whole Willamette valley, which he traveled all over. He says that, although times are dull here, it is ten times worse in the valley and every other place he visited. He is now satisfied that no better country can be found anywhere, and will stay with us hereafter, which his many friends will be glad to learn. This ought to serve as a warning to the horde of restless, dissatisfied people who enjoy hugging the idea that "any other place beats this." They learn to their sorrow that such is not the case when they investigate.

At the institute to be held here next week, Prof. J. H. Ackerman of Portland will be the conductor, assisted by E. P. Green of Heppner. Both are expert institute workers. Mr. Ackerman will give instruction in written arithmetic, physiology, history, psychology and methods; Mr. Green in reading and orthography, mental arithmetic, geography, grammar and civics. Any special branch will be presented if enough desire it, on application to the superintendent. There will be four lectures during the week, thus affording our people a rare treat in that line. Reduced rates for board are offered at the hotel, and one fare for the round trip on the stage line, fare to be paid at starting point. Under these favorable conditions this institute ought to be a complete success. Every teacher in the county will doubtless be here, as Supt. Daggett this week personally notified each teacher.

A private letter received this week from Jay P. Lucas of Monmouth concludes thusly: "At present I am 'up to my eyes' in harvest, running a binder for all it is worth. I will finish cutting on Monday, 10th, having cut about 200 acres in 12 days. The reported failure of crops here is somewhat an error, as several of my neighbors have had a yield of 30 bushels per acre. However, the average yield will be somewhat less than usual. My health is very good and it takes a pretty fair man to keep up with me when I do work. But, seriously, the continued wet weather is pretty hard on me. Our relatives and friends have been urging my mother to move to Portland, where it would be pleasanter and where she can live with less worry. So we finally consented to lease the farm and will move in a few weeks to the city, where I have agreed to accept a position." Jay concludes by sending kind regards to his friends in general up here.
