The death of M. L. Armstrong occurred at Fossil on Sept. 20th, of Bright's disease, after several weeks' suffering. The burial took place next day in the I. O. O. F. cemetery at Fossil in the presence of a large number of sorrowing friends and relatives.

Gov. Lord has appointed Capt. Gowan, of Burns, Chas. Hilton, of the Dalles, J. M. Church, of La Grande, Jno. C. Young of Baker City, and W. F. Matlock, of Pendleton, as delegates to the national irrigation congress to be held at Phoenix, Arizona on Dec. 15, 1896.

Wm. T. Shaw and family were passengers on the northbound stage Tuesday, en route to Montana, where they will locate. They formerly resided at Barnt ranch, Crook county, but for the last four years have resided in Polk county, and had just been to their former home on a visit.

The Alabama Minstrels, consisting of three nigger tramps and a white woman, "showed" at Condon last night to a good-sized audience. All who saw it pronounce it the rottenest show and outfit that ever hit the town. The whole outfit ought to be jailed for obtaining money under false pretense.

Gene Smith has sold his stock of harness and saddlery to Tom Portwood, who has rented the building from Gene and will continue the business on his own hook. Tom has just ordered a new stock of what is most needed and is prepared to supply anything needed in his line. Give the boy a chance.

The sidewalks in town in a number of places are in a dangerous condition, the result of broken planks. It is a poor plan to wait until some one breaks a leg or gets crippled before repairing them. A few moments time and a couple of planks and nails may be the means of saving the city from a damage suit.

Lewis Barker and Brick Morris returned home last week from Grant county, where they had been with sheep since spring. Lewis had charge of his own band and also a band belonging to his brother S. B., and Brick had charge of Frank Pliter's sheep, all of which are in excellent condition. The other boys are expected home next week.

A funny typographical blunder, appeared in the Heppner Gazette recently. The editor apologized for being a day late, and concluded with this sentence: "Our failure to get out on time was on account of the physical demoralization of the editor, caused by sleeping too close to the boarding house window." The letter "n" was omitted in the word window.

J. H. Downing, who has been in California the last month trying to trade his Condon land and town property for land near Santa Clara, is expected home soon. We understand he failed to effect a swap and that he will make a trip East this fall on a similar errand. We learn that he has given up the idea of establishing a store here this fall.

Dr. Griffin, the well-known Arlington dentist, passed through town Monday on his way home from a month's stay at Lone Rock. The doctor will be 77 years old the 10th of next month, and is yet possessed of more vitality than most men of 50. He reads his Globe every week without the aid of spectacles, and says he'd feel lost without its weekly visits.

His many friends in this county are grieved to learn of the death of Wm. A. Cahoon, formerly of Olex, who died in a Portland hospital last week. His remains were taken to his old home in Ohio for burial. The deceased was a young man who was held in the highest esteem by all who knew him, and recently graduated with high honors in the state normal school at Monmouth.

J. R. Clark and W. A. Goodwin last week completed a fine school house on Rock creek, six miles below Olex. A rip-roaring discussion on the money question will take place in the school house this Friday evening, and a large crowd is expected out. Able speakers from Arlington, Olex, Condon and Mayville will be there, and a rousing debate is assured. But the Condon band will not be there, as was jokingly announced in the Record last week.

Abie Kelly's foot was crushed between car-bumpers at Arlington Friday. Train No. 34 had pulled into the station and stopped. Kelly attempted to cross between the cars, and as he stepped on the bumper the train started to back, catching his left foot and crushing the toes badly. The O. R. & N. Co's surgeon, Dr. Geisendorfer, amputated the foot and looked after the man's welfare. He was sent to the Portland hospital. Kelly is a young man and was stealing a ride.

An important real estate transfer was made at Condon Monday. L. W. Darling sold his store building and 75x100-foot lot on which it stands to Charles Earhart, who will open a saloon there about Nov. 1st. Consideration, \$1500. Mr. Darling will move his stock of drugs, the postoffice and his law office into another building before that time, but does not know yet what building he will occupy. Mr. Earhart and his bartender, Gene Smith, are in Portland this week selecting a stock of liquors for the new saloon.

Concerning the overlasting Trevett case, which a correspondent alluded to last week, Mr. Trevett also appears to be pretty well "ripped up" over the case being kept in the courts a life-time. He thinks there is no doubt that the case was started just to get what fees there was in it. The reason he thinks so is that when he refused to pay the \$25 fine and costs—because he was sure he had not violated any city ordinance—a proposition was made to him that the fine would be remitted if he paid the costs. For that reason he thinks that the parties starting the suit ought to be compelled to pay the costs, instead of the city.

A farmer in Eastern Oregon with a drove of fine horses wrote to a friend in Portland asking for information about marketing his stock. The friend sent back the following laconic reply: "No market for horses; street cars are run by electricity, the municipal government by jackasses, and the rest of the people ride bicycles."

The safe in Billy Hoover's store at Fossil was blown open with powder on Friday night of last week and all the money in it, about \$300, was stolen. Of this amount about \$50 belonged to the Rebekah lodge of that place. The thieves effected an entrance to the store by prying a door open with a chisel, and the tools used on the safe were stolen from Morris's blacksmith shop. As yet there is no clue, but there seems to be no doubt that the burglars are "local talent" and live in Fossil, and some sensational developments may be looked for soon. It is only a short time since the safe in Bolton's store at Antelope was robbed in a similar manner.

The bank of Joseph, Wallawa county, was robbed on Thursday afternoon of last week, in regular Jesse James style, by three men, who had been working in that section a year or more. While the robbery was going on the citizens armed themselves and when the robbers came out, opened fire on them, instantly killing one named Brown and badly wounded another named Tucker. The third robber, Cy Fitzhugh, made his escape with the sack containing all of the money stolen, over \$2000, and has not yet been captured. Tucker, thinking he was mortally wounded, made a full confession. But he will recover, and his chance for spending the next 20 years in the penitentiary is very bright. The bank officials offer a reward of \$500 for Fitzhugh's capture.

Of all the ornery bilks that ever came through here, the ornariest is the fellow who stopped here a couple of days the first of this week with his wife and two little children. They travel in a covered hack and his business is to put a sort of glass or celluloid finish on photos; but he doesn't do the work $\frac{1}{2}$ as well as the samples he shows. But this isn't his worst fault. He keeps his worthless hide full of rotgut whiskey nearly all the time and while he isn't drinking he shamefully abuses his crippled wife. Monday night he beat her in such a beastly manner that the landlady, Mrs. Maddock, was obliged to put her and the children in another room and lock the brute out. Our marshal would have jerked him out of his boots had it not been that his unfortunate family would have suffered by doing so. She told here that at Heppner her husband beat her into insensibility. They left here Tuesday, going south.

Mrs. Katie Tobin and her sister, Miss Rose Smith, arrived here last week from their home at Streator, Illinois, on a visit to their sick brother, Peter Smith, who has been under treatment for some time in a Portland hospital for a cancer in his stomach. They also came out to Matney Flat to visit their other brother, W. J. Smith, but came very nearly not seeing him, as he was in the mountains after wood. After waiting three days for his return, they left for Portland again, but were overtaken at Arlington by W. J., who arrived home shortly after their departure. It was 17 years since they had seen each other, and of course the meeting was a happy one. Later, by the time they returned to Portland their brother had suddenly grown worse, and died on Thursday of last week. They had the body embalmed and taken to his old home at Mendota, Illinois, for burial. The deceased was a young man, unmarried, and his untimely death is mourned by a large circle of friends.

Lone Rock Rumbblings.

John Madden has a crew of men out on the roads, putting them in repair for fall and winter use.

John Maidment of Lost Valley has rented the John M. Brown place below town and is running his and some of Mr. Brown's sheep there.

W. H. Colwell has purchased the John Cunningham residence property and he and his wife expect to move to Arlington in about two weeks and remain until spring.

Mr. and Mrs. R. G. Robinson left last Monday for Southern California, where they expect to spend the winter enjoying the many good things that portion of the state produces.

Has Confidence in Silver.

R. H. Kleinschmidt, one of Helena's richest men, sends the following letter to the New York World:

"HELENA, August 26.—I hereby authorize you to publish that I will make a contract for \$100,000 worth of silver, for which I will agree to pay \$1.10 per ounce in United States gold coin, and to be taken as soon as W. J. Bryan, as president of the United States, has signed a coinage bill which will provide for the free and unlimited coinage of silver at a ratio compared with gold at 16 to 1, and if any of those who are talking about 50-cent dollars desire this contract, and are willing to put up a forfeit, I am prepared to secure this offer by a forfeiture of \$20,000.

"I feel confident that I can arrange similar contracts among my circle of business acquaintances for \$20,000,000, to be taken \$1,000,000 a month for 20 months, after the signing of such a bill. R. H. KLEINSCHMIDT."
