We learn with considerable satisfaction that our item last week referring to the nigger outfit that bilked our people out of about \$20 Wednesday night was the means of "busting them up in business," in this county, at least. They had intended to "show" at Mayville on Thursday night, but as the GLOBE got there only a short time after they did, it completely knocked the thing into a cocked hat. They say it was a good deal better than the show to see the manager, the tallest nigger, paw the earth and thrash the air and snort when he saw the item in question. From remarks he made, bystanders were able to gather the idea that he was not overly well pleased with our mention of the show. We believe it is the duty of every newspaper to denounce every fake and snide outfit of that kind that comes along—even if they do receive complimentary tickets, as we did in this case.

For the last couple of weeks the large printing firms of Portland have been giving Glass & Prudhomme particular fits, through the Oregonian, for charging such extortionate rates for printed stationery, and have pretty successfully proven that Glass & Prudhomme are the highest-priced printers on the Pacific coast. They are making a terrific roar because the contract for printing the election ballots was not let to the lowest responsible bidder, and say there are a dozen or more printing houses in Portland that are as well or better-equipped for doing such work than are Glass & Prudhomme, and whose rates are from 100 to 200 per cent less on such work. Glass & Prudhomme were paid about \$2100 for printing the ballots for the June election, and the other large printing firms there say that any of them would have gladly done the same work for \$500. Now Glass & Prudhomme have just secured the contract for printing the ballots for the November election, also without having been let to the lowest bidder, hence the kick. The county court of Lin county let the contract for printing the ballots for the November election to the lowest bidder, and of the dozen or more bids received, Glass & Prudhomme were the highest, being \$54 for 10,200 colored and the same number of white ballots. The contract was awarded to the Silver Imprint, a house paper, whose bid was the lowest, \$20. The Yaquina Post received the contract for printing 9000 tickets for Lincoln county at \$20. Four times as many tickets will be printed in Lin Co. for \$20.—Albany Democrat. (If we are not mistaken, Glass & Prudhomme charged Gilliam county \$75 for only 8000 ballots (4000 of each), for the June election. They were also given the job of printing the ballots for the November election, but it is not likely they will charge more than 1/4 or 1/2 as much, as these ballots will not be over 1/2 as large and will not require one-tenth as much type work as the June ballots.)
