Mrs. F. B. Stevens received the sad intelligence Monday of the death of her niece, Josie Churchill, aged 15 years, who died at her home at Salem, of consumption. The deceased was the eldest daughter of Mrs. Mary Churchill who, with her family, visited at the Stevens ranch last summer.

Isaac Ruddock of Umatilla county, who has had more free advertising during the last year than any other man in Oregon, has just been convicted at Pendleton for the crime of embezzling school funds while acting in the capacity of school clerk, and sentenced to one year in the penitentiary.

T. G. Woodland and family and A. J. Cochran and family of Rock Creek moved to Arlington this week to remain until spring for school advantages. Miss Mattie Jennings, a niece of Robt. Spencer, will make her home with Mrs. Woodland this winter and attend school also. Mr. Cochran has leased his farm for a term of three years to a son of Al Weatherford.

A large crowd was out to the hall last Wednesday evening to hear the speech of J. W. Ivey, a republican campaign orator from Portland. Chas. Hilton of The Dalles accompanied him as far as Condon. Mr. Ivey was also billed to speak at Olex next day at 2 o'clock, but as no crowd was on hand to hear him he proceeded on to Arlington, where he delivered an address in the evening.

A. Anderson, an honest and hard-working young man who came up from Portland last fall and worked here at anything he could get to do, returned home Monday from a 3-months' job of work he had in Crook county. He believes Crook county will give Bryan a large majority, and says that of the hundreds of people he met over there he did not meet one McKinley voter.

The world's wheat crop is short 137,000,000 bushels, which accounts for the gradual rise in the price of wheat. There seems to be no doubt that the price will reach 75c a bushel yet this fall. First-class wheat is selling at that now in Portland. Everybody rejoices when the farmer is prosperous, for when he is prosperous everybody else is. At Chicago last Monday wheat took an upward jump of 4c, and is still jumping.

One by one the sheepmen and herders keep dropping in from the mountains, the last arrive being J. M. Cameron, who summered his sheep near Caleb. Notwithstanding the reported war between the settlers and sheepmen over there, Jim says he never had a quieter summer than this. He says he never saw a better class of people than the settlers over there, when they are treated right. But of course they kick, and so would any one, when some smart ellick herder would for pure cussedness drive his sheep through their grain.

J. H. Downing returned home the first of this week from California. He has not yet closed the trade for the Santa Clara property which he has had his eye on, but is likely to do so at any time. In order to make his land more desirable for a stock ranch he has bought the Bailey place, adjoining his ranch, and proposes to let it all go in the trade. Mr. Downing informs us that E. W. Sanderson, formerly of this county, has traded his 10-acre orchard near San Jose for 800 acres of grazing land, farther back in the mountains, and will embark in the cattle business.

A number of teamsters have spoken to us this week about the dangerous condition of the Rock creek bridge below Crum's mill, and say that it is unsafe to cross an empty wagon, to say nothing of a heavy load. Even one of our county commissioners last week refused to cross the bridge with a load of wheat and drove around it. It is hoped that the county court at its regular session next month will make provision to have it either repaired or rebuilt at once, in time for this fall's wheat hauling. They say that by going that way they can save nearly two miles, besides avoid a much heavier pull up the other Olex hill.

H. Clay Myers of Heppner, formerly of Blalock, has filed an assignment for the benefit of his creditors in the office of Recorder Malcolm in Portland. The assignee is John Myers. The assets consists of acreage valued at \$5000 in Gilliam and Washington counties; six lots in Stephen's addition, valued at \$9000, one-third interest on 1200 bushels of wheat, \$200; 30 head of horses, \$450; farming implements \$300; total, \$14,950. Liabilities are \$9279. The principal creditors are as follows: J. D. Myers, Oregon, \$1800; Susan B. Allen, East Portland, \$800; American Mortgage Company, \$400; MacMaster & Birrell, \$5000; J. W. Smith, Arlington, \$310; estate of Dr. Thessing, Portland, \$300.

Bank-robbing is not the easy snap it used to be. On Thursday night of last week three desperadoes robbed the bank of Meeker, Colorado, and while they were at it the citizens armed themselves and "laid for them." When they came out of the bank, all three were shot down like dogs, but not before they succeeded in wounding half a dozen of the brave citizens. A bank at Sherbourne, Minn., was also held up by two young men, who were served in a similar manner when they came out of the bank. That really is the best way to discourage bank-robbing. It is too bad that the Fossil thugs were not treated to a dose of the same kind of medicine when they robbed Billy Hoover's safe recently, and who have not yet been arrested.

We learn that a most horrible accident befell the family of John Davis at their home on upper Thirtymile last Sunday. Mrs. Davis, her daughter Mattie and three little children were about to start away on a visit to the home of a neighbor and after placing the children in the wagon and the others were in the act of getting on, the usually quiet team became frightened and dashed off at break-neck speed. The three children were thrown violently to the ground, killing two of them instantly and it is thought fatally injuring the third. It was an awful accident and the heartbroken parents are completely prostrated over their terrible misfortune. It seems that no matter how well a horse is broke, he can not be trusted, and is sure to fly off the handle when least expected.

Last June it cost Tillamook county \$25 to have 9000 ballots printed. Last week the county court let the contract for printing 9000 ballots for \$8.50.—Tillamook Headlight. [This ought to serve as a pointer to our county court, which two years ago paid Glass & Prudhomme of Portland about \$150 for 8000 ballots and last June about \$75 for the same number of ballots. All work of that kind and all stationery needed for the county should be let to the lowest responsible bidder, as is done in about all of the other counties, and which the court has exacted from the home printers of this county for what few dollars' worth of county printing they get. Surely the big city firms, that pay no taxes here and are in no way identified with our interests, are not entitled to any better treatment than is shown the home publishers. It is poor judgment to lose \$100 to the big city firms while trying to save 5c from the little home firms, or in other words, "strain at a gnat and swallow a camel."
