Arlington Items.

The Weber dramatic company played here this week to full houses.

Our band has been out on the street several times lately dispensing some of their fine music, which our people enjoy very much.

The sheet and pillow case ball Friday night was a grand success.

The Artisans here gave an entertainment at their hall the first of the week, for their own amusement. Only a few of their friends were invited out.

Landlord Redford had 40 tons of ice brought down from Powder river this week and stored it in his ice house. He intends to keep his customers cool next summer, if ice will do it.

Our city dads have a force of men and teams at work cleaning up the streets and sowing grass seed on the point west of town, to check the sand that has a tendency to drift up from the river.

Earl Weatherford of Shuttler Flat appears to be having more than his share of sickness in his family. His little child is very low with typhoid pneumonia, and his wife is also very sick with fever. At last accounts they were both improving.

The sportsmen of this city propose to build a boat 38 feet long by 10 feet wide, with a deck overhead, on which a cabin will be built, the boat to be rigged with a sail, and will also carry a lifeboat. It is to be used on the river as a hunting and pleasure boat.

The school exhibition last Saturday was a grand success, every one having performed their respective parts to perfection. The teachers deserve much credit, for it is quite a task to train so many children in such an efficient manner. The money will go toward buying a library for the public school.

He was bound over to appear before the next grand jury in the sum of \$400, in default of which he was committed to the county jail. Our people were treated to a genuine blizzard Monday afternoon, it being the severest of the winter.

A Crawford returned home the first of the week from Arlington, where he had been under medical treatment.

The weather the last week has been the worst on stock that we have had yet, the ground being so soft that cattle can scarcely get to their feed, and then they tramp more of it into the ground than they eat.

C. M. Hagood, state organizer of the United Artisans, delivered a lecture here on Wednesday evening and received several applications for membership. He has notices posted to the effect that he will be here on March 23d to organize an assembly.

Did any one about the county see anything of Geo. Crawford's beef that he started in to kill at Lone Rock one day last week? The brute got away from him and started for the Columbia river, head and tail up and tongue out, with George about two miles in the rear. His tongue also out, longer than that of the flying beef. The last seen of them was by Geo. Perry, and he says that at the rate they were going they would no doubt jump the Columbia when they reached it, and likely are making for the British possessions. Our people will have a splendid appetite worked up for beef by the time they return.

It strikes a good many of the people about here that this place is in need of a justice of the peace about as badly as anything we know of at present. Not very long ago our J. P. found law enough to fine one of our citizens \$10 and costs, amounting to \$15, for carrying concealed weapons. But it does not appear that he can find law enough to punish a big bully for brandishing a pistol in the faces of a crowd of respectable, helpless ladies, for the purpose of scaring them out of having him prosecuted. Such is a specimen of the justice our good people have to put up with. However, a few of our best citizens will see to it that the next grand jury is given a chance to air a couple of Lone Rockers in a manner that ought to do them some good.
