## ONLY FAKE TEACHERS ENCOURAGE DANCING

School Supt. Williams of Grant county, publishes the following very sensible letter in the Canyon City News, which will be of interest to many of our readers:

We desire to make a brief discussion of a subject which has long held a place in our mind. It is intended to do only good, and is inspired by the proposal, which we have heard, to give a children's masquerade ball in the near future. We do not wish to go on record, however, as opposing the pleasant pastime of dancing by those who have a right to indulge in that amusement. Parents who have the educational interests of their children at heart, should not allow them to attend dances until they have passed beyond school age, and their school work is over. The reasons which may be urged for this are numerous. They have a lifetime in which to dance, if they so desire, whereas, the time in which most of them can go to school is limited, and should be improved to the best advantage. Teachers who have worked in school where any considerable number of the pupils attend balls, will all testify to its ruinous effect on the work. The dance forms the entire topic of conversation and interest for about ten days before and after. They often stay out a few days beforehand to prepare, and are absent one or two days to recuperate. We do not think that we overdraw the case when we say that they lay awake nights, thinking of the good time ahead. The effect is at once apparent. Interest in school work is lost, lessons are neglected, and discipline is irksome; the cause of education has received another blow. There is a physiological reason which may also be urged against this practice. Childhood is the time in which nature's vital forces are all directed and needed to grow up strong and healthy minds and bodies. Hence those forces should be given a chance to act properly and not be wasted in late hours and dissipation. The place for growing children, when night comes, is in bed, and that at an early hour. Parents who doubt the truth of these statements have only to ask the physician's advice on the same points. If further proof is needed, ask the children themselves. They are more reasonable than you imagine, and understand full well the evil effects of the dance on their school work. If cornered, most of them will own it up. Your restraining influence and advice is all they need to give up these ideas until their school work is over. In conclusion let us say that if it is necessary to allow mere babes, and other pupils in their early teens to attend every dance that is given, then we might as well close the public school at once, it is only a waste of good money and misdirected energy.

John H. Mitchell has offered to get out of the way for anyone who will pay him \$35,000 as reimbursement for the amount of money he has spent in trying to be re-elected to the United States senate. This amount has been expended by Mr. Mitchell and State Chairman Sol Hirsch during the June campaign and during the present struggle in the legislature. Mr. Mitchell realizes that he cannot be re-elected. He knows the hand of fate is against him. But he does not want to lose the \$35,000 he is out in campaign expenses, and so the other day he issued an ultimatum that anyone for whom Mr. Mitchell steps out of the way must put up that \$35,000. Two years ago, J. N. Dolph demanded \$40,000 as reimbursement for his campaign expense, and would get out of the way only on those terms. He was pushed out of the way at that time by the Mitchell element in Oregon republican politics. Now that Mr. Mitchell is in the position occupied then by Mr. Dolph he may have Mr. Dolph's experience and lose both the office and the campaign expenses.

The contrast in the condition of the country between the time of Lincoln's first inauguration and that of President McKinley today is said to be vividly portrayed in an article by Stephen Fiske for the March Ladies' Home Journal. In telling of "When Lincoln was First Inaugurated" Mr. Fiske graphically describes Mr. Lincoln's journey from Springfield, Illinois, to Washington, and the incidents of the inauguration and the attendant festivities. There were grave fears that Lincoln would be assassinated as he rode in the inaugural procession to the Capitol, and every possible precaution was taken for his safety. Mr. Fiske will recall the safeguards placed around the President. Special officers and detectives in citizens' clothes were stationed in numbers among the crowds that lined the sidewalks, and sharpshooters occupied positions of vantage on housetops, etc., along the route of parade. The military escort of the President-elect was heavily armed, ready to promptly meet any hostile demonstrations, and the crowds were kept a distance from the President's carriage—so far that they could not distinguish Mr. Lincoln from Mr. Buchanan, who rode beside him. The police were instructed to arrest all persons making opprobrious threats against Mr. Lincoln, or uttering disloyal sentiments. The tension was great and the whole country was in a state of suppressed excitement. W. A. Pinkerton, son of Lincoln's personal body guard, was on hand at McKinley's inauguration today with a special guard of Pinkerton detectives to protect the new president from any kind of an attack.
