Circuit court for Gilliam county convenes at Condon on April 12th. There are several criminal cases to dispose of, but it is not likely that the session will last over one week.

Rev. E. Corran has decided to preach for another year at Crockett, a suburb of San Francisco, and which is a pleasant and prosperous pastorate. Mr. Corran is still pursuing a course of studies in the Pacific Theological Seminary at Oakland and making rapid progress.

Arlington, situated as it is on the railroad and Columbia river, is the natural outlet for an immense section of country on both sides of the river, extending over 200 miles on the south. As a shipping point it can not be excelled in the state, so let us encourage outside capital to come in and help develop it. As it is, it is yet in a crude or wild state, allegorically speaking.

As the order withholding such lands from settlement was only made pending the consideration of that Bill, I supposed it had been rescinded immediately upon the passage of the same. I will call at the Land Office to see what, if anything, has been done in the premises, and if the order has not been rescinded, will request immediately that it be done.
