Assessor Clarke informs us that 28,443.83 acres of land have been deeded in Gilliam county within the last year, of which 5,675.58 were homesteads, 6,335.97 timber cultures and 16,372.28 cash entries. This is a pretty good showing, and about double the acreage of the previous year.

A. V. Lewis was over from the Mayville country Monday renewing his subscription and attending to other business. He says this last freeze-up has ruined a great deal of wheat over in his section, which was not protected by snow, and thinks a good deal of it will have to be rescued.

The Locust Grove school, below Olex, through their efficient teacher, Miss Grace Cooke, sends us the following for publication: An entertainment will be given by the Locust Grove school on Saturday evening, April 3, 1897. Thos. Woolery of Lone, one of the best-known men in Morrow county, attempted to commit suicide by shooting himself in the head at the Perkins hotel in Portland last Friday. The bullet struck too high and the attempt was a failure. His wife, whom he married only a month ago, was with him in their room at the time, and no reason is apparent why he had become so weary of life.

J. H. Parsons of Twickenham informs us that all the material for the new ferry boat at that place is on the ground and work on the boat will begin in a few days. "Uncle Jerome" says the people along the John Day expect the river to get wild and woolly pretty soon, as there is more snow in the mountains than for many years. That stream has well earned the title of "the treacherous John Day."

Governor Lord Monday gave his opinion that the county judges could not lawfully withhold taxes due the state after the date prescribed by law for their payment to the state treasurer. The motives of the county judges in wishing to withhold taxes were, however, in the governor's opinion, laudable, as they simply desired to afford relief to the counties if possible.—Portland Telegram.

A fine little daughter was born to Mr. and Mrs. P. Skelly on the 4th of this month. Pat was so wild and stunned over the event (it being his first work of the kind for a long time) that he did not come to town for several weeks, which is the reason the little girl's arrival was not mentioned sooner. Pat has recovered so that he is able to move about a little again, and informs us that he has just laid in a supply of paregoric enough to last a year.

The Prineville papers say that "Kid" Buffington (Eaton) is in jail in that town, awaiting the action of the grand jury next May, on a charge of robbing one Charley Wellnitz at Mitchell a few days ago. Last week he and several other prisoners very nearly made their escape by drilling with an old case knife and pounding a large hole through the brick wall of the jail with some stove iron. In a few moments more all of them would have got out. Buffington gets the credit for planning the escape, which shows that he is still possessed of considerable shrewdness.

The U. S. Senate has refused to seat H. W. Corbett, the millionaire banker of Portland, whom Governor Lord recently appointed to take Hon. J. H. Mitchell's place, at which Mitchell is of course greatly pleased. Some of the papers think that the governor will now call an extra session, but our guess is that he will do nothing of the kind. The result is that Oregon will have but one senator for the next two years. It is a safe bet that Simon, Bourne and his highwaymen, or hold-ups, will not be in it the next time, as there will be another election before the legislature convenes again.

Prof. Lake, principal of the Antelope school, evidently has new and approved ideas about teaching morality. Last week the school board fired him out of school and the citizens continued the good work by running him out of town, all because he attempted to ravish one of his 13-year-old girl pupils. He and his estimable young wife and her sister, who stopped with them this winter, have returned to their former home at Hillsboro, Washington county. We learn that some of the more excitable citizens of Antelope were in favor of lynching the fellow, but cooler counsel prevailed and he was told to skiddaddle, and he skiddaddled.

On the 17th of this month, Jim Corbett, the blatant windbag, got just what about nine-tenths of the people of this country have been wanting him to get for the last four years—a devilish good thrashing. It took Fitz 14 rounds of tremendous hard fighting to do the job, but he succeeded nobly. Up to the 10th round Corbett appeared to have the best of the fight. Being by far the more scientific of the two, he was able to hit Fitz whenever and where he pleased, but his blows were too light and lacked the effect of those of Fitz, who did not land so often, but when he did got in a lick it counted. By resorting to his old game of pretending to be almost knocked out, in order to throw his adversary off his guard, Fitz found the opening he was looking for from the first round, and struck Corbett a murderous blow over the heart, and the big bully went down like a dog—the only knock-down in the entire fight. The 5000 people who witnessed the fight will never forget the awful look of horror and anguish on Corbett's face as he realized that he had just lost the championship of the world and the \$25,000. He belched and boo-hoed like a calf, and it was all the crowd could do to hold off Mrs. Fitzsimmons, who also wanted to thrash the whey out of him. The new champion says he will never fight again, but nobody believes it, for that is what they all just after winning the championship. Whatever he does, it is hoped he will not wear the people out by talking them to death through the newspapers like Corbett did.

A few of our farmers will have to re-sow their fall wheat, which was frozen out. Only a small portion in exposed localities was damaged.

Mr Davis, of the firm of Davis & Fairfield, has leased his interest in the blacksmith shop to Mr Fairfield, who will run the shop hereafter alone.

Holding State Taxes.

The editor of this paper having solicited Judge Mariner's opinion upon the subject of holding back this county's state tax, amounting to something like \$6,000, has received the following reply from him, which will be of interest to our readers. The Judge writes:

"Copy of paper received containing marked article, giving the opinion of Judge Northup of Multnomah county, regarding the payment by the counties of state taxes, for which accept my thanks.

"Gilliam county court at the March term discussed this matter and decided that it would be best to call in warrants from first money collected and pay the state tax later on. Just when this payment should be made will be a matter for consideration and to be governed to some extent by future developments. As noted, Judge Northup favors paying about 10 per cent of the state tax and has decided positively that Multnomah county will not pay the balance.

"It so happened that I was in Portland the 9th of this month and made it convenient to call on Judge Northup, with a view of getting the opinion of the county court of Multnomah county on this subject. I found that both the judge and commissioners were in accord and had decided to adopt the course heretofore mentioned. Judge Gray is chairman of the legislative committee of the county judges' convention and was thinking at one time of calling the county judges in convention with a view of securing concerted action in this matter, but afterwards decided to invite all who could conveniently attend to meet with him at the Perkins hotel on the 18th of March and requested those who could not attend to submit their views by letter. On the part of Gilliam county I wrote in favor of withholding the payment of the state tax."
