Through the energy of her wide-awake citizens, Long Creek is about to have a first-class normal school established at that place. Such an enterprise was talked of for Condon some time ago but, like everything else for the town's advancement and welfare, was allowed to fall through.

A Colorado woman was cured of the suffrage craze by reading that there was a "bare quorum" in the legislature, and she does not think such a place fit for a decent woman. Another woman was cured by learning that the seats in the legislative halls were made of "undressed" lumber.

Times-Mountaineer: The branch of the Wasco warehouse at Arlington has already received 100 sacks of wool of the '97 clip, and Mr. Lord tells us the Baldwin Sheep & Land Co. has two 6-horse loads on the way in to the warehouse here, which will be the first of the season received here.

R. H. Weber, the popular and well-known nurseryman of The Dalles, was through this county last week in the interest of his reliable nursery. He was accompanied by C. T. Bayard of The Dalles, formerly of Arlington, agent for the Concordia Loan & Trust Co. of Kansas City. They went from here to Morrow county.

Mr. and Mrs. John Reissacher of Portland arrived at Fossil Saturday and expect to spend the summer in our healthful climate, in order for John to regain his shattered health, caused by lagrippe and pneumonia. He and his mother-in-law, Mrs. T. B. Hoover, were over to Condon Tuesday, the latter on county court business.

The Strickland-Giede sheep trespass case will be disposed of in supreme court at Pendleton next week. Strickland will be represented by Pierce Mays and the other side by W. H. Wilson and T. R. Lyons. One side or the other will have to pay the costs now, without any more delay, which the witnesses and jurors will be glad to learn.

A veteran bronco-buster gives us the following sure remedy to cure a horse from kicking: Tie one of his fore legs with a rope to his hind leg on the other side. As soon as he starts to kick he jerks his front leg off the ground and he goes down on his nose ker-smash. Two or three doses like that will cure the most obstinate cases.

In Michigan 96,000 laboring men have signed a petition asking the legislature to employ state convicts in road improvement. The field for this work is so large that the idea is gaining supporters in every state. Owing to the inability to get outside labor for work on the new railroad to Astoria, the managers are making an effort to have the work done by the convicts of this state.

Last week's Dufur Dispatch says: "The civilization of Dufur and vicinity is such that it would not, we are glad to say, tolerate such obscene publications as the Fossil Journal is guilty of nearly every issue; and we doubt if the U. Judge O. N. Denny has been turned down a second time, by the appointment of Harold Sewall as minister to Hawaii, and Max Pracht has also been knocked out of the governorship of Alaska. Verily, the way of the office-seeker is hard, also full of disappointments.

The Heppner Gazette says that Mr. John Harbe and Miss Ina Gorton were married by the J. P. in that town on Wednesday of last week. The bride has many friends in Condon, where she attended school a year ago, who wish her much happiness. The groom has a beautiful home one mile from Douglas station, where he owns 400 acres of excellent land, nearly all of which are in wheat—besides, he has a bank account of several thousand dollars.

The annual meeting of the Mid-Columbia Association of the Congregational churches is being held at Lexington this week. Three delegates were elected from this place—Mrs. H. B. Hendricks, Mrs. G. G. Farman and Miss Grace Fitzwater. The latter being sick this week, her sister Lulu went in her place, and all three left Monday morning for Lexington. We learn later that Mrs. Farman did not go, for the reason that she expects visitors from the East this week.

Several Indians came to town Tuesday with a race pony, and were "spoiling" for a race. Randall Palmer was in town also with a little racer and accommodated the redskins by relieving them of what silver they had, amounting to several dollars. The Indians remained in town Tuesday night and got "roaring" drunk. Whoever let them have the whisky should be severely dealt with, as they might have burned the town, since there is no fire protection whatever here now. The maximum penalty for this offense is life imprisonment.

Vale Advocate: It is a common practice today to rear a boy, that at the age of 12 or 14 years his parents as well as the community feel the need of sending him to the reform school—a paternal institution intended to take the place of horse sense and a harness-tug. Here the taxpayers are compelled to assist in rearing a criminal that would, with proper training and a few broken doses of strap-oil, have become a useful citizen. Fifty years ago there was little need of public reform schools, for the parent, knowing his duty to himself and society, did the reforming in his own woodshed.

Judge Lowell has filed an opinion in the expense case of the Umatilla county sheriff. He says: "I am of the opinion that the county court has the power and authority to consider and audit the expense accounts of the sheriff of the county, necessarily incurred in the performance of his duties, and that in this case it erred in disallowing charges which seemed to be reasonable and necessarily incident to the proper conduct of the office of such officer. Said claim is remanded with direction to allow the same." The case has been carried to the supreme court, which convened at Pendleton this week.

Our school board has already received five applications for the ensuing term of school, as follows: W. M. Seaman, principal of the school at Genda Springs, Kansas; Miss Nora F. Thompson, of Corwith, Iowa; J. R. Locke, of Merrillville, Indiana; C. E. Woodson, of Eugene, and A. W. Balsiger, of Morrow county. The latter was in town last week making personal application. Splendid recommendations accompany each letter, those of Miss Thompson being unusually good. There being so many more kinds of employment open to gentlemen than to ladies, we believe the board feels rather inclined to give the ladies a show and that a lady principal will be employed this time, for a change.

A dispatch from Salem says: The domestic animal commission has ordered 20 head of horses belonging to C. R. Hougham, in Gilliam county, killed. In accordance with the order, Hougham ordered his men to kill the horses when he left his ranch Monday. His horses are affected with the mange, which is very contagious, being transmitted to an animal that rubs against a tree where a mangy horse has been. Mr. Hougham does not object to the commission's order, but thinks it useless to kill 20 of his horses when there are about 50 on same range similarly affected that have not been ordered killed. [A letter just received from Grant Wade states that he killed and buried the 20 horses and that he will make another killing in a few days—that is, of mangy horses.]

Our town was treated to somewhat of a sensation Monday, by a marriage in "high life." About one year ago a Mr. and Mrs. Hart dropped in here, from Portland, they said. They secured employment for several months with Chas. Fix in his restaurant and the balance of the summer on the Hyde ranch on Hay creek. They left in the fall, but returned again this spring and again secured employment with Mr. Fix, Mr. Hart as mail carrier to Lone Rock. All this time they, of course, lived together as husband and wife. Thinking that perhaps it wouldn't hurt to have the nuptial knot tied a little tighter, they were married "again" Monday by City Recorder H. B. Hendricks, in the parlors of Fix's restaurant, in the presence of only a few select friends. This time they gave their names as Henry Albershardt and Miss Mary Ann Smith. It is needless to add that they were serenaded in the most approved style by the tin bucket brigade.

## How to Live Long.

Some curious figures have lately been made public by a celebrated Berlin physician, which seem to point to the fact that if a man wants to live long and preserve his health and strength he ought to marry. Among unmarried men between the ages of 30 and 45, says Spare Moments, the death rate is 27 per cent. Among married men between the same ages it is only 18 per cent. For 41 bachelors who live to be 40 years of age, 78 married men triumphantly arrive at the same period. The difference gets all the more marked as time goes on. At 60 years of age there are only 22 bachelors to 48 married men; at 70 there are 11 bachelors to 27 who were married, and by the time they reach 90 the married men are three to one, for there are nine of them to every three bachelors. And yet, in the face of facts like these, we still find men daring to remain single! It really is as much as their lives are worth, if they only come to think of it. Men may talk of their lives being shortened by domestic worries and anxieties and cares. That is all rubbish. Statistics must tell the truth, and these statistics of the Berlin doctor say that the man who is a bachelor stands in far greater risk of a shortened span.

The state secretary has appropriated among the counties the 5 per cent received from the sale of government lands within the state during the past year. The total amount distributed was \$1,382.40. Last year it was over \$5,000.

## Teachers' Examination.

Notice is hereby given that for the purpose of making an examination of all persons who may offer themselves as candidates for teachers of the schools of this county, the school superintendent thereof will hold a public examination at Condon, Oregon, May 12-14, 1897, beginning on Wednesday at one o'clock p. m. Examinations for state papers will be given at the same time and place. Teachers who have never taught the required number of months in this county to entitle them to state papers should present a certificate from the county superintendent or board of directors from the county in which they last taught, stating how much time had been taught in that county.
