Billy Keys of Mayville visited The Dalles this week.

Each United States senator costs the country \$4884 above his salary of \$5000 a year.

George and Miss Frankie Schott are visiting their sister here, Mrs. T. G. Johnson.

R. M. Johnson and Riley Fraser of Lone Rock are the latest to join the ranks of the Woodmen at Condon.

Dr. Hogan made a business trip to Portland this week, starting yesterday. He will be absent four or five days.

A physical culture lecturer says that "if woman would eat more onions she would have fewer calls from the doctor."

County Treasurer S. B. Barker is prepared to pay all outstanding warrants against the county, registered prior to March 8, 1896.

Fry Wilson, the well-known Monument stockman, is in town this week as witness in the case of Joe Putnam vs John Madden.

Mrs. Frank Stricklin of Rock creek was up to town Tuesday with a load of fine Royal Ann cherries, which she sold at 5c per pound.

The Vale Silver Advocate, one of the brightest and neatest weekly papers in the state, has just been enlarged and otherwise improved.

When last heard from, the book agent who recently invaded Mississippi with a work on "Irrigation," was only a few rods ahead of the mob.

Portland wool dealers say that enough foreign wools have been imported this spring under the Wilson bill to stock this country for 18 months.

Mrs. H. N. Frazer and Mrs. W. A. Darling were in Portland this week as delegates to the Eastern Star grand chapter, which was held there.

The population of Newberg is 1,200 and of the number 1,000 are church members. It was not learned what is the matter with the other 200.

From Walla Walla and all Eastern Oregon points the O. R. & N. has reduced rates on wheat 40 cents a ton, the rate now being 17½ cents a bushel.

The boys are kindly requested to not ride their horses over the bicycle track around town, as it injures it for bicycle riding, for which it was made and paid for.

Next Monday, 21st, will be the longest day in the year. Stay awake all Monday night and see if you can notice any difference in the length of the next day.

An exchange has made the startling discovery that the girl with one bean to her string stands a better chance of not being an old maid than the girl with a dozen.

An Antelope woman, disgusted at her husband putting 50 cents in the contribution box at church, took out the half dollar and put in a nickel when the plate reached her.

P. A. Fry orders his GLOBE sent to Pine, Union county, where he is stopping for the present with his horses. He says Charley Slater of Beecher Flat is camping with him.

A woman at Grass Valley, Sherman county, whose worthless husband deserted her, refused to apply for a divorce because she said she did not want to spend \$50 on a 5-cent man.

Clarence Meek went to Portland last week to have an operation performed upon him for bladder troubles, which have caused him much pain and inconvenience for some time.

A Kansas editor has discovered that Adam and Eve were not married, but it is not thought the discovery will effect the price of bread stiffs, barley and oats to any great extent.

The cost of transporting a hundred pounds of wool from The Dalles to Boston is 90 cents. From Pendleton it is \$1.05. The Dalles has the benefit of water competition.—E. O.

General Weiler remarked in one of his dispatches from the seat of war that a battle sounds like tearing cloth. He may have been climbing a fence just then, running from the enemy.

The U. S. senate has refused to admit Millionaire Corbett as a member. This leads a number of exchanges to believe that Gov. Lord will call an extra session of the legislature in October or November.

Rev. Bade informs the Weston Leader that he is much pleased with his field of work at Condon, where he expects to remain until September and then take a university course, perhaps at Oakland, Cal.

Portland never has experienced such hard times as at present. A few years ago 240 head of cattle were killed there daily to supply the market. Now only 40 head are killed. Other business shows a similar decrease.

Geo. Gibbons says the grain in the Mayville country all looks fine yet, especially the fall-sown wheat. He says the ground over there in the wheatfields is not dried out over an inch deep yet and that crops are not suffering.

Mrs. H. C. Strickland and children left this week for a couple of months' visit to her old home at Aberdeen, South Dakota. Her health has been good for several months and she thinks that a rest and change of climate will benefit her.

The testimony is all taken in the case of Barker vs Barker, having finished Tuesday night. Atty. Wilson returned home to The Dalles Sunday and was not present this week. Lyons Bros. acted as counsel for the defendant, W. L. Barker, this week.

The trial of the Ladd grave robbers is being held at Portland this week. Montgomery, who turned state's evidence, plead guilty and was sentenced to two years in the penitentiary. It is safe to predict that the other three will get about ten years each, perhaps more.

Miss Louella Maddock, who had been attending St. Joseph's academy at Pendleton for the last nine months, returned home today. She will probably return to the college again this fall. Her brother Frank, who is attending school at Mt Angel, will return home next week.

L. W. Moody of Portland, secretary of the state board of pharmacy, whose duty it is to prosecute such cases, writes to one of our citizens as follows: "J. H. Hudson of your town has been summoned to appear in this city on June 18th for examination for a druggists' license."

There was a slight error in our obituary notice of Claude Henshaw last week. It should have read that six brothers preceded Claude to the other shore, instead of five brothers and one sister. There was but one daughter in the family of eight children, Miss Birdie, the only surviving member.

Murderer Durrant was relieved Friday. Governor Budd decided upon this course in order to settle the question of the rights of the federal courts to interfere in the execution of a sentence imposed by the state court. He has named July 9th as the date on which the sentence shall be carried out.

At the spring term of the supreme court of Eastern Oregon, which recently concluded its labors at Pendleton, forty-six cases were argued and submitted, as against twenty-nine last year. It will probably be three months before the court will be ready to hand down its opinions in all the cases submitted.

It is so dry in California just now that the moon raises a dust as it passes through the sky. The moisture has all evaporated out of the milky way until it looks like a long trail of pulverized chalk, and the farmers throw pebbles on the stables to make the cows think it is rain falling and not become discouraged.

Grasshoppers are doing considerable damage in Morrow county. Gardens have been completely ruined, and in many places entire fields of wheat have been eaten up. W. F. Willis, near Lexington, reports that there is hardly a spear of wheat left standing in a field of 140 acres of spring sowing on his place.

The reports of the head officers of the Woodmen of the World show that since 1890, the membership has increased from 40,000 to 240,000, and the number of camps from 1100 to 4800; that the death rate has decreased from 5.41 in 1893, to 4.60 in 1896, and the cost of management from \$1.62 in 1889, to 61 cents in 1896.

Ed A. Putnam, his brother-in-law, has just sent to Benton Mires his (Mires) saddle to Drain, Douglas county. Bent expects to ride over the mountains next month to his fine farm on West fork and will remain up here awhile looking after his interests in this county. He has been acting as deputy assessor of Douglas county for some time.

The poor sheepmen are catching thunder on all corners. The Idaho cattlemen are at war with the sheepmen who invade their range, break down the banks of irrigation ditches, contaminate the streams and make trouble generally. They have organized the Farmers' Protective association of Camas Prairie, to keep the sheep off the range.

Remembering that Oregon has neither the blizzards and cyclones of the East nor the burning summers of California, it is time Gilliam county was settling up with new settlers. Instead of having a population of only 3,500, this county could easily support 50,000 people. More of an effort should be made to induce immigration to the county.

J. A. McMorris has been engaged as principal of the Condon school and Miss Mabel Halstead for the primary department, for the term commencing August 30th. Mr. McMorris feels greatly elated over the compliment paid him, as he was not an applicant, but says the position was tendered him by the school board without his asking for it.

Charley Fix has just had erected on top of his barn a large water tank, which his windmill will keep constantly full of water. He has pipes leading from it to troughs in his stable, also to his kitchen and store, and it will also be invaluable in case of fire. Charley has spent a great deal of money in improving his place, and deserves credit for it.

The hard times have forced a new style among country editors, and many of them wear a belt instead of suspenders. When they get word from home that there is nothing for dinner they simply tighten the belt another notch and feel too full for utterance.

Mrs. J. W. Ebbert's brother and his wife, Mr. and Mrs. Crabtree, who have been visiting their relatives here several days, left this week for their home at Creswell, Lane county, going overland. Roy Ebbert and his sister Lillie went with them to visit relatives in Lane county several weeks. Roy will bring a header with him when he returns next month.

For various reasons, Condon will not celebrate this Fourth, after all. Our band has not practiced any this summer and could not get in practice in that time; and the death of Claude Henshaw leaves a vacancy in the band that would be impossible for a new man to fill in such a short time. Our people will be content to visit the neighboring celebrations this year.

Hon. W. W. Steiwer, of Fossil, Gilliam county, ex-state senator, is registered at the Imperial. He says that the large sales of cattle and the increased price obtained and the large wool clip are making good times in Gilliam. The grain outlook is also exceedingly good, and, if the hot winds do not prevail to a great extent, there will be an abundant harvest.—Friday's Oregonian.

The present prices are very encouraging to cattlemen. The poorest scrub in the herd is now bringing better prices than the best stock on the ranges did two years ago. But the question is, what will the next few years bring forth? In some instances even calves have been sold and the entire brand shipped out of the country. No wonder young calves are in such demand.

Rev. Bade writes from Weston that Rev. A. R. Olds will arrive at Condon Saturday and will preach here next Sunday, morning and evening. He will also preach every evening next week, and a cordial invitation is extended to all to attend the revival meetings, regardless of their religious beliefs. Rev. Bade will take the place of Rev. Olds at Weston until after the revival here.

Monday afternoon George Husted, of Fossil, while unloading wool at one of the warehouses, stepped on a small rock, turning his right ankle, and breaking the bones of the leg about two inches above it. Dr. Hollister reduced the fracture, and Husted that night expressed his determination to start home next day, but changed his mind and will remain several days.—Dalles Chronicle.

California is going to force wide tires upon its farmers, with threats of fearful punishment. The new law goes into effect January 1, 1900. Any person who sells, purchases or brings into the state after that date vehicles with tires of less width than specified in the law shall be fined \$25 to \$500, or imprisoned 25 days or six months. Tires are to be from three inches to six inches wide, according to size of axle.

For the last couple of months it seems that each week from half a dozen to a dozen GLOBES turned up missing in the postoffice here, which causes considerable complaint among our subscribers. W. J. Bryan has concluded to make a speech at Pendleton in the afternoon of July 13th. A tent will be put up large enough to seat 20,000 people, and the Ry. companies will reduce the rates from all Oregon, Idaho and Washington points. A number of Gilliam countyites will be there to hear the "next president of the United States"—as he is introduced everywhere. His next speech will be at Salt Lake. Even John W. Hanamaker, the great Pennsylvania republican statesman, says it would be as easy to keep the earth from revolving as to keep Bryan from reaching the president's chair in 1900.

The Examiner prize drawing took place last week. Californians won all the big prizes this time. F. Brunner of Sacramento got the \$10,000 farm, Wm. Glasford of Fresno the \$5,000 gold nugget, and Miss S. E. Hughes of Los Angeles her weight in silver. The only Gilliam countyites who won anything are: Chas. Busby of Fossil, a fine sewing machine, F. W. Peaslee of Fossil, a pair of shoes, Mrs. C. C. Wilson of Condon a gold fountain pen, Geo. Leghorn of Arlington a set of Dickens' books, Mrs. Mary C. Geisendorfer of Albany, mother of Dr. Geisendorfer of Arlington, won a fine ladies' bicycle.

The testimony in the civil suit, begun in circuit court last April, of Joseph Putnam of Monument against John Madden of Lone Rock, was taken yesterday at Condon before the referee, L. W. Darling. The suit originated several years ago by Putnam going on Madden's note as security. The amount he is suing for now is something like \$240, which includes the attorney fees and costs of the case. It is a very much complicated affair and will necessitate Judge Bradshaw putting on his best thinking cap in deciding it. Hendricks Bros. are counsel for the plaintiff and Lyons Bros. for the defendant.

Paul Beck, father of John Beck, who was killed at a dance last winter at Cleveland, Wash., by Frank Castle, has a two-column article in the Golden-dendale Agriculturist, roasting the jury, district attorney, sheriff and others whom he thinks had a hand in acquitting Castle at his recent trial. He closes his letter as follows: The history of this trial suggests two things to me very forcibly. One is, that the time has come when the jury system in the U. S. should be abolished in all suits involving murder. And instead thereof the judge of the county or district as the case may be, be authorized to call two judges from neighboring counties, who together with himself shall try the case and decide on the guilt or innocence of the party tried; thus placing the decision beyond the possibility of being given by ignorant, vicious or corrupt men.

Another slight change has been made in the O. R. & N. time table. No. 4, eastbound, arrives at Arlington at 7.54 p. m.; No. 2, eastbound, at 3.09 a. m.; No. 3, westbound, at 6.31 a. m.; No. 1, westbound, at 2.08 a. m. This last train from Huntington now comes around through Pendleton, Walla Walla and Waiilatua.
