The Independence (Polk county) paper says: Alva Holt and Chance Mulkey started Monday for Eastern Oregon, on their wheels. A number of our young men are going off for the summer either for work or to see the country.

Cows are so numerous in the streets of Antelope that the citizens there are thinking of petitioning the city council to have the sidewalks torn up, so as to give the cows the benefit of the grass that the walks deprive them of.

Have you noticed how all-fired scarce flies have been this summer? Usually at this season they are thicker than "dog on a hare's back." Perhaps the cool weather has caused the delay. But when they do come, they'll make up for lost time.

The largest turnips and radishes we have ever seen raised on dry bunch-grass land, without irrigation, are those raised this season by John Knox, 3/4 mile east of town. They are "whoppers" and just as solid and of as good flavor as one could wish for.

It was a mistake about Geo. Gibbons being awarded the contract for painting the Armory hall. Geo. Fletcher's bid was the lowest and the contract was awarded to him. He is to furnish all the material and give the building three coats, all white, for \$175.

Arrangements have been made for W. J. Bryan to speak at Walla Walla next Tuesday, 13th, in the forenoon and at Pendleton in the afternoon. Immense crowds will be out to hear him. It is expected that 75,000 people will hear him at Portland next Monday.

Russia's latest census indicates a total population of 130,000,000. It is a large family to govern without a constitution and the ballot and the czar will some day have troubles of his own; but just now his nation is building up and spreading out as no other excepting only the United States.

Mr. Lanham, a Texas member of the house of representatives has introduced into that body a bill "to reduce the expenditures of the government, to decrease federal salaries, and to discourage the office-seeking industry" by cutting off 33 1/3 per cent from the salaries of federal officials.—New York Sun.

Ten thousand bushels of wheat at Moscow, Idaho, were sold the other day for 56 1/2 cents per bushel. The same wheat could have been sold for 73 cents last fall but the owners were not satisfied with that price, wanting 74 cents, and have lost \$2500 by their holding for a raise that would have amounted to only \$100.

The 4th of July exercises at the church Sunday, both morning and evening, were very good, and highly appreciated by the large congregations present. The band solo in the evening by little Lillie and Florence Clarke was exceptionally good, and brought forth thunders of applause. It is a rare thing to see children their age so proficient in music.

A sleek scoundrel is working the school districts of the state, says the Milton Eagle. He claims to be selling a handsome, new edition of Webster's dictionary. His price is very low, and on every order he demands an advance payment. It is needless to say that he is never heard from thereafter. School directors should watch out for him.

Louis Meadows, the 15-year-old son of S. Meadows, was accidentally shot at Heppner Friday while he and another boy, Elva Dutton, were fooling with a gun left in the office of Gordon's feed yard. The shot took effect in the right groin and passed through the body, and although medical aid was at once summoned, the boy died in a short time.

Pomona, Cal., has a new saloon license, that is a corker. The license is to be \$1000; two saloons are to be allowed in the city, and they are to have no screens or seats for loungers. A man can only enter, get his drink and go out. An exchange wonders where the bums and vags would "get off at" in such a saloon, who hang around waiting to be treated.

Clerk Frazer received a letter Saturday from Judge Mariner, who has been under medical treatment at Walla Walla, by Dr. Blacklock, since last spring for a general running down of his constitution, saying that his health will not permit his being present at the term of county court this week. The commissioners are present, however, attending to their part of the business.

The wheat crop is short in France, short in Russia, almost a failure in Argentina, there is a famine in India, and the American supply is rather less than average. Still, wheat sells in the Chicago market for 67 cents. Twenty-five years ago, under like conditions, it would have been worth from \$1.50 to \$2. What is the matter? Is it evident that money is even scarcer than wheat, asks an eastern paper.

Mrs. H. B. Hendricks and children while attending the celebration at Lone Rock Monday had a fine buggywhip and driving lines stolen from their rig. The culprits are known and H. B. says that if the stolen property is returned the thieves can escape some very unpleasant litigation.

A sister of Grandma Woodfin of Trailfork and her husband and family arrived there this week from the valley and will locate on Trailfork. They say that in all the country between here and the valley they did not see any country that looked like civilization until they reached Gilliam county—which speaks well for this section of the state.

Samuel B. Raxter of Salem, who had been an employee in the Herald office at Antelope for over a year, is now doing similar work in the Globe office for awhile. He is entirely deaf, having been that way for ten years, the result of being kicked on the head by a horse. He was formerly supervisor at the deaf-mute school at Salem and is a bright and gentlemanly fellow.

The 3-year-old daughter of Mr. and Mrs. D. Reese, of Waitburg, became partially paralyzed a few days ago and upon making a careful examination it was found that a sheep tick had been causing the trouble. The tick had bored itself in the back of the child's neck and was hidden by the hair of the head. Since the tick has been removed the child has steadily improved.

It has been reported here that by a surgical operation, removing a broken bone from against the optic nerve, Johnny Keeney has had his eyesight restored to him in Lane county. If this is true, it is indeed a God-send to him, and all of his acquaintances will glory with him in his good fortune. He has been blind since he was two years old, caused by a horse kicking him in the face.

She declares she is not actuated by any feeling of sentiment, not being in love with the murderer, but believes him innocent and wants to see justice done.

Our patience with the U. S.
