Edward Snodgrass, who drove stage on the Arlington-Fossil line until about a month ago, died in the Good Samaritan hospital on Dec. 4th, of brain fever, aged 22 years. Ed., as he was familiarly called, was one of the most courteous and obliging drivers that ever worked on the line, and left many friends in this county who regret his untimely death. His remains were taken to Prineville, where his mother lives, and buried in Mill creek cemetery.—Fossil Journal.

Unless the supreme court should interfere and grant a stay of execution, Claude Branton will pay the penalty of his fiendish crime with his life, at Eugene, tomorrow. The scaffold, upon which he will be executed, has been erected in the jail yard and a passage built to it from the door, consisting of a high fence, so as to avoid any accident. Branton is considered a desperate man, and he will be given no chance to make any fight at the last. LATER—A dispatch from Eugene, under date of Dec. 19, says: Sheriff Withers this evening received notice that the supreme court had granted a stay of execution in the Branton case. Attorneys think this will delay the execution at least six months.

A. W. Patterson, of Oregon, (formerly of the Heppner Gazette), well known in newspaper and political circles of this state, and at present clerk of the house committee on irrigation of arid lands, and a leading student at the Columbia law university, of Washington, D. C.

was awarded first place in the opening public debate of that university last Saturday evening. His strong plea for territorial expansion, the question under discussion, was the subject of favorable comment in the announcement of the judges, one of whom was Justice Harlan, of the supreme court. Mr. Patterson won the first place in the second public contest of last year, also winning the prize debate at the close of the year, which was composed of those who had won in the six public contests. This victory will again entitle him to participate in the university's annual prize event.—Oregonian.

The School Entertainment.

The entertainment given by the pupils of the public school last Friday evening was an unqualified success. The program consisted of music, recitations, dialogues, class exercises, etc., and was rendered in a manner that showed careful preparation and judicious training. Such exercises are pretty good evidence that a lively interest is manifested in the school work by both teachers and pupils, and is a source of gratification not only to the parents and patrons, but to every person in the district who takes an interest in educational matters. If our popular teachers persist in giving many such entertainments the school building will have to be enlarged, or a larger hall secured to accommodate the audience. The school room was taxed to its utmost capacity Friday evening, and we predict that the next time it will be found altogether too small.

After The Book Trust.

The joint legislative committee, charged with the revision of Oregon's school law, has completed its labors and adjourned and the bill will be introduced at the coming session by Senator Daly, of Benton county.

Mr. Daly made a hard fight in the committee against the present method of selecting text books, and was successful in having incorporated in the new bill a provision creating a commission of five, to be appointed by the governor, and composed of business and professional men of recognized ability and integrity and who must be in no way connected with any book house, whose duty it shall be to select text books for the public schools of the state. To prevent collusion or the pooling of issues by the book companies, the commission is given the privilege of selecting any good books without regard to offers made by the publishers. This provision of the new law is considered a hard blow at the book trust and, it is believed, will give much better satisfaction than the present method and at the same time effect a considerable saving.

ARLINGTON.

Spaulding, the goose hunter, killed 90 geese last week down in the Blackfoot country.

The Arlington-Fossil stage has been making better time since the new contractors took charge than it ever did before at this time of year.

The Ladies' Aid Society's social and bazaar held here last week was a success in every particular. There was a good program rendered during the evening.

There was a racket in the lower part of town the other day in which several were interested, but we are ashamed to give the names of the parties that were in it.

The ice is breaking up very fast since the weather moderated. We thought for a time that the ice would get thick enough to put up, but such was not the case. If we have no colder weather during the winter than the last spell we will be compelled to use imported ice next summer.

A man by the name of Keys who lives here, put a brass magnet in "hook" at Dilley's restaurant a few days ago for \$35. He claims that he thought it was gold. He has had it pawned here several times before. He was placed under \$200 bonds to appear at the next term of court to explain matters.

The cold weather froze several water pipes, causing them to burst, some of them being in basements, doing considerable damage when they thawed out. The cellar under the Grand Hotel bar filled with water before it was noticed that the pipe had burst. A crew of men pumped the water out Sunday.

The Ferry Co. will build a large boat here in the spring, one that they can cross the river with at any time. She will have two engines, which will run a stern wheel, and it is proposed to make a very strong boat in every way. The boats that have been used here in the past were not capable of doing the work that is required.

FOSSIL.

The ground is covered with two inches of snow, but the weather is quite warm.

Mr. E. Whitehead has opened up a shoe shop here and will carry, also, a line of confectionery in connection.

J. W. Gilman passed through town Monday with 300 head of cows, which he will winter at Andrew and Paul Greiner's ranch, where he has purchased a number of large straw stacks. This makes something like 500 head of cattle Mr. Gilman has on pasture and feed in the Mayville country, for the winter.

T. L. Stewart, our county surveyor, has been surveying for W. W. Hoover and J. H. Putnam the past week between Mayville and Hoover creek and it is quite a slow job, as most of the corner stones seem to have been moved, or, possibly, were never set by the original surveyor. At best, it seems that a very poor job of surveying has been done throughout the entire township.

W. W. Steiner received a telegram Saturday night announcing the death of Mr. Arthur Horn, of Malheur, and a letter received Tuesday night by Wm. Moore, of this place, from Mrs. Arthur Horn (daughter of Wm. Moore), stated that he died at Ontario, after an illness of but two days, but did not state the cause of his death. Arthur Horn was a son of Jos. Horn, of Twickenham, this county, and was a steady, upright citizen. He was in the stock business in the Malheur country, and leaves a wife and infant son.

The weather is warm and pleasant like spring time. A warm rain storm took all the snow off the surrounding country and the roads are pretty muddy.

Stock of all kinds are in fairly good condition, considering the fact that not much feeding was done during the long spell of cold weather just past, but there is plenty of time for a rocky winter yet. On being taken before the J. P. at Fossil last week, Frank Ralston pleaded guilty to an assault and battery which he had committed on a boy, and the J. P. fined him \$15 and costs, amounting in all to something near \$25. This is the second case within the last month in which men of this place have been fined for assaulting minor children. These are only light lessons for what they might get if such crimes are not brought to an end.
