Died—At Lebanon, Or., Feb. 1st, Mrs. Mary Simons, aged 104 years, 3 months and 12 days. Mrs. Simons with her husband and family crossed the plains in 1853 and located at the place where she died. She was probably the oldest person in the state.

A. J. Shelton, of Mayville, has sold his sheep and bought the bowling alley and restaurant at Arlington, which he will take charge of the 15th of this month. Mr. Shelton is an enterprising man and there is no doubt but what he will succeed in his new venture.

Of those who were so unfortunate as to be compelled to face the weather last week some were frozen, but how seriously we have not learned. One of the drivers on the Arlington-Fossil stage line had his face frozen, and another one's fingers suffered that fate, and one passenger is reported to have frozen his feet in going from here to Fossil.

One of the heaviest snow storms ever experienced in Harney county is said to have occurred on Monday and Tuesday of last week. It was about 32 inches on the level but there was such a gale blowing that it drifted badly, making the roads almost impassable. The Burns-Ontario stage was all night in going 16 miles.

Death of Another Pioneer.

Hon. J. H. Slater died at his home at La Grande Jan. 28, after an extended illness, aged 73 years.

Deceased was one of the many who came to California in 1849, and from there to Oregon in 1859. He settled at Corvallis, and in 1854 was admitted to the bar. He served in the territorial legislature of 1857, 1858 and 1859 as an independent democrat and was also a member of the first state legislature. From 1859 to 1861 he published a paper called the Oregon Weekly Union, at Corvallis. In 1862 he moved to Baker City and in 1863 to La Grande, where he has since resided. In 1873 he was honored by being elected United States senator for Oregon, serving in that capacity for six years. He has held many other positions of public trust, but since 1889 he has led a retired life at his home at La Grande. He was a man of force and high character and was highly respected by all who knew him. A wife and nine children survive him.

BATTLE AT MANILA.

Serious Fighting Between the Americans and Insurgents.

Twenty of the United States Troops Were Killed and One Hundred and Twenty-five Wounded.

The long-expected rupture between the Americans and the Filipinos has come at last. The officers at Manila have not been blind to their situation and had made every preparation for just what occurred. The clash came at 8:40 Saturday evening when three daring Filipinos darted past the Nebraska regiments at Santa Mesa. One was killed and one was wounded. Immediately afterward the Filipino line commenced a fusillade which continued at intervals till daylight. Then a charge was made and the works at Santa Mesa and Paco were taken. Intermitting firing continued at various points all day long. The engagement proved a veritable slaughter for the Filipinos. It is reported that their killed will amount to thousands. Our loss is not known exactly but approximately it is 50 killed and 200 wounded. The Oregon regiment did not take part in the engagement. Five Idaho men were killed, also six of the Washington soldiers. The strength of the insurgents opposed to Gen. Otis is not known. The accounts of their number are conflicting, but the best belief is that they number about 30,000 men. The force under Otis' command number 21,000. Filipinos are not comparable to the American forces in personnel, discipline or quality. Their strong point is their knowledge of the country and a certain fanatical bravery in onslaught that would be formidable to a volunteer force not well trained to stand fire.

AMERICAN VICTORY COMPLETE.

Latest dispatches state that careful estimates place the Filipino losses up to date at 2000 dead; 3500 wounded and 5000 taken prisoners.

The Oregon regiment participated in a sharp engagement with the insurgents late Monday afternoon, but drove the enemy back without losing a man.

General Otis sent a dispatch to Washington Monday which stated that the loss on the American side was but 250, while the loss on the insurgent side is 4000.

Otis and Dewey have been instructed to push forward and fight the Philippine insurgents wherever found.

Death of Thomas J. Young.

After many months of patient suffering from consumption, Mr. Thomas J. Young succumbed to that dread disease, at his home in Condon, Tuesday forenoon at 10 o'clock. The end was not unexpected by his friends who have watched and tended him through his illness.

Deceased was born in Clay county, Mo., September 16, 1844. He came with his parents to Clackamas county, Or., in 1845 and afterwards to Polk county. In 1883 he moved to Gilliam county, where he has since resided. He was married December 31, 1868, to Mary Foster, who survives him. He leaves also a brother and a sister. Mr. Young was possessed of those traits of heart and mind that commanded the respect of all who knew him and endeared him to a large circle of friends who mourn his demise.

The funeral services will be conducted today at 11 o'clock.

Sam Bailly Killed.

On last Wednesday morning, while Sam Bailly, Claude Cooper and Alex McCartney were hauling a load of hay over on Trout creek, the wagon ran into a washout in the road, upsetting the hayrack and resulting in the almost instantaneous death of Bailly. Bailly was lying stretched out on top of the hay, and when the rack upset, he was thrown into a 15 foot ditch, the rack falling across his back. Cooper and McCartney were uninjured and hastened to the assistance of Bailly, but death had claimed its victim before they reached him.

Bailly was a Tennessean, having come to the Antelope country from Knoxville, about a year ago. He claimed to have been a practicing attorney, and papers found upon the body indicate that he was formerly an Alderman of the City of Knoxville. Deceased was about 32 years of age. His friends say that he has a mother, father and brother living in Knoxville, and they have been notified of his tragic death. Deceased also claimed to be a member of the Masonic Order, and if this is found to be true, he will be buried with Masonic honors.
