A Plucky Preacher.

Although encumbered with all his clothing and two heavy grips besides, he chose the latter and boldly waded into the turbulent and treacherous waters. Strange to say he reached the other shore in safety and was still able to reach the Warco settlement the same day.

In Memoriam.

Samuel O. Thompson, the subject of this sketch, was born in McMinn county, Tenn., November 3, 1824; died at Central Point, Oregon, March 14, 1899, aged 74 years, 4 months and 11 days.

He was twice married.—first, February 6, 1853, to Miss Carrie Starnes, in California, and to this union there were five children born. Three of the children and his first wife died at Winnemucca, Nev. He was married the second time to Miss Nancy P. Edington, April 27, 1883, at Dayton, Wash., who survives him, also one son, Austin, and one daughter, Mrs. Lydia Meyer, both of whom live at Condon, Oregon.

Mr. Thompson was an early pioneer of this Coast, coming to California in 1851, and fought through the Indian wars and braved many hardships known only to the pioneers. Since that time he has lived in all the adjoining states at different times. He was a great sufferer the past several years from ulceration of the bones of the left side of his face. He was a kind and devoted Christian man and a loving husband and father. Not a murmur fell from his lips. His patience, endurance and resignation were wonderful.

He has gone to accept the "promised land" for him in the heavens.

The funeral was conducted by Elder O. J. Gist, pastor of the Church of Christ at McMinn, who made words of comfort to bereaved widow and friends. Interment was in Central Point cemetery.

Wool is weaker.

E. Y. Judd, of the Pendleton Wool Scouring & Packing Company, writes from the east that the recent organization of the worsted trust has demoralized the wool market and is largely responsible for the decline in the price of wool, as buyers are at sea as to the future action of the trust and are unable to determine what their own action is to be.

Mr. Judd says that this trust alone will consume 100,000,000 pounds of wool annually, which is one-third of the total annual product of the country. The wool trust have given no hint of their intention. As soon as the uncertainty of their action is removed the market may have a firmer tone and it may not. The outlook for wool this year is not the best, as everybody is timid on a declining market.

Mr. Judd expects to be in Pendleton within a few weeks, at least as soon as there is anything doing in his line.—East Oregonian.
