Dr. Luna was appointed health officer and he at once established a rigid quarantine of the Fix building, in which the Model restaurant is located, and by noon the marshal had that part of the west side of Main street fronting the Fix building, closed to travel. All persons who were in the building at the time will be kept there until all danger of contagion is past and all other possible precautions are being taken to prevent an epidemic.

On Monday a comfortable dwelling house on Mont Ward's farm, about one mile from town, (the old Sing house) was secured and fitted up for a hospital and Tuesday morning the patient was removed there where he will be nursed by Dr. Hogan who, though not an im-mune, has had a large experience in treating this disease, and who volunteered to act as nurse for this case and any others that may develop.

Our city officials and physicians are entitled to much credit for their prompt action in this emergency and it is hoped the disease may be stamped out before it becomes scattered.

The schools have been closed and it is probable that church services and other meetings of a public nature will be discontinued for a week or two or until

There is no cause for a panic but it is the sense of the people of Condon that it is only justice to the people of the surrounding country to call the disease by its proper name. It is the disease that has been prevalent in Eastern Oregon for months and is no doubt a mild form of smallpox. Other towns have called the same disease "chicken pox," "Mamilla itch," "the nameless disease" etc., but Condon people prefer, by the best of their ability, to protect their neighbors by calling a spade a spade.
