Cello Canal.

Capt. Harts, of the United States Corps of Engineers, put the finishing marks upon the report of The Dalles-Cello canal survey, Saturday and the document has been forwarded to the department at Washington. The report is a very long one, as it was found that such an extensive piece of engineering as the proposed canal will be, of necessity must be very thoroughly described before the appropriation is secured, or before an attempt is made at securing it. There are ten maps accompanying the report, besides a large number of photographs that were taken to make the general description more complete. In all probability the report will be made public as soon as it can be printed for the matter it contains pertains to a bill that will come before the congress now in session.
