Sunday's Game.

There was a pretty good game of ball played on the Condon diamond last Sunday between the Condon Reds and a team picked from "the Flowers of Gilliam County." The grand stand was full of people and the people were full of enthusiasm. The players were full of life and "Happy Hooligan," who chaperoned the Flowers in the capacity of Mascot, proved himself to be the only real, live, luck producer for a ball team ever discovered this far west. When Happy stood on his head and waved his nether limbs frantically in the ozone it was a sure indication that trouble was brewing and that somebody was about to get licked. When he gathered the bats all together and "hovered" them as a hen would 14 eggs it indicated that the white winged dove of peace was doing business at the old stand in a seven minute engagement and that as long as Happy could keep the bats under control there would be no serious bloodshed. Had the Flowers given Happy the support which was due him there would have been nothing to it and the Reds would have been known no more forever. The main point at issue at the beginning of the game was which team would win the greatest victory—for it was a sure thing that both sides were going to win. Regular Trains July 1.

It is understood that a regular train service schedule will be established between this place and Arlington on Saturday, July 1st. Some freight has already been taken out and an occasional passenger who could not secure passage on the stage without waiting over for 24 hours has been permitted to

ride on the caboose. A rate of one and one-third fare for the round trip is said to have been fixed for the celebration at this place July 3, 4 and 5.

The railroad company has fixed a rate of 18 cents per 100 pounds of wheat from Condon to Portland. This rate is quite liberal as compared with the old rate of 11 cents from Arlington and will mean a good margin of profit to the farmers.

Drowned in the John Day.

Last Monday evening the John Day river claimed another victim in the person of Melvin Webb, a resident of Mayville. Mr. Webb in company with the other harvest hands at Burnt Ranch, went bathing in the evening after work hours. Francis Easter was out in the river locating a shallow place for the boys who could not swim. Mr. Webb, being one of those left on the shore, slipped into the river which was deep at the bank and met his doom. Those on shore rendered all assistance possible for men to do who could not swim. An oar was reached to the drowning man, who grasped it, and was pulling the rescuer into the river when he had to let go of the oar to save himself. By this time, Mr. Easter had returned to the scene, and was in a row boat reaching for Mr. Webb as he arose the third time, when a sudden gust of wind drove the boat away from the drowning man and prevented his rescue. The body sank from sight after coming up the third time and was recovered Tuesday morning.—Wheeler County News.

Remembered His Nurse.

Will Davenport, of Mayville, who died at Portland last week, and who was buried at Mayville Monday, was a relative of Homer Davenport, the famous cartoonist, who is now at Portland exhibiting his celebrated collection of Arabian horses and pheasants. The fathers of the two men were cousins. E. A. Stinchfield, of Mayville, with whom Mr. Davenport had made his home for the past six years, went to Portland to bring the remains home and he says that deceased had every care and attention which it was possible for any sick man to have during his last illness. A trained nurse was with him constantly as well as the best medical attendants. The nurse is a young lady from California, who by her own efforts, has graduated as a nurse and taken one course of medical lectures. Mr. Davenport was so grateful for the faithful attention she gave him that before he passed away he made the verbal request that a sufficient sum of money be set aside from his property to complete her medical education. With the exception of this and one or two other verbal requests, he died without having made a will.

Building Notes.

W. A. Goodwin reports building operations as promising to be very lively for the remainder of the Summer. Lumber is now being placed on the ground for the following buildings for which he has the contract:

A. N. S. Cotin will build a handsome residence near the Baptist church to cost about \$1500.

Dunn Bros. will erect a warehouse on their lots on North Ward street on the railroad track. The building will be 30x60.

Johnson & Pliter will build a store room on Main street adjoining W. L. Barker's hardware store, for rent. The building will be 42x70.

The Lost Valley Lumber Co. will build lumber sheds and equip a yard on Main street adjoining S. B. Barker's warehouse.

J. M. Stark, a veteran hotel man of Western Oregon, at present a resident of Independence, was here during the week taking a look at the coming metropolis of Eastern Oregon. Mr. Stark was highly pleased with the appearance of the town and surrounding country and expressed the opinion that Condon has a particularly promising future. He was particularly struck with the opening which he believes to be here offered for a strictly modern hotel and may later interest himself in such a business here.

Davenport.

William Davenport, a well-known resident of Mayville, died at Portland last Friday morning, June 23, 1905, of heart complications following a severe attack of inflammatory rheumatism from which he had suffered for the past two or three months. He had partially recovered from the first attack about the first of the present month and being able to travel decided to go to Portland for the sake of change. The change did not bring the hoped for improvement, however, and after two weeks of intense suffering, he passed away as above stated.

Deceased was born in the state of Indiana about 47 years ago. Coming west when yet a boy he followed the life of a cowboy on the plains of Western Kansas and Texas for a number of years later crossing the plains to California with his parents where the family resided for several years. In 1884 the family removed to Oregon, settling near Mayville in the same year. He was the last of the family, his father and mother both having died at Mayville during the last few years.

He was a past grand member of Summit Lodge, No. 130, I. O. O. F. of this city and was one of the delegates from this lodge to the grand lodge of that order which met in Portland early in June.

He was generous to a fault, honorable and square, and true blue to every man whom he hailed as friend. No higher tribute could be given any man than these words, spoken by one who had known him intimately for years, when the news of his death was received from Portland: "He had his faults, as other people have theirs, but those who knew him best loved him best."

The funeral was held at Mayville Monday afternoon with the funeral service of the Odd Fellows lodge and was largely attended.
