PROPOSED AMENDMENT

Gilliam County Needs a High School.

In pursuance to requests from a number of residents of Gilliam county the editor of the GLOBE has made a rough draft of the proposed amendment to the Code of Oregon providing that the question of the location of the county high school being submitted to the voters of the county.

An Act.

To amend Sections 3433 and 3434 of the laws of Oregon as compiled and annotated by C. B. Bellinger and W. W. Cotton.

Be it enacted by the legislative assembly of the State of Oregon;

Be it enacted by the people of the State of Oregon:

Section 1. That sections 3433 and 3434 of the laws of Oregon as compiled and annotated by C. W. Bellinger and W. W. Cotton, be and the same is hereby amended to read as follows:

The county court, at any general election to be held in any county after the passage of this act, upon the presentation of a petition signed by one hundred or more qualified electors, taxpayers of said county, must submit the question of establishing and maintaining a county high school together with the question of its location in any incorporated city or town within said county to the qualified electors thereof. The county court, if they deem it expedient, may order a special election for such purpose. Such election shall be conducted in the manner provided by law for conducting elections. The ballots for such election shall contain the words: "For County High School—Yes," "For County High School—No," "For location of County High school at (here state name of every incorporated town or city within said county.)" and the voter shall indicate his choice as provided in the Australian ballot law.

3434 If a majority of all votes cast on the proposition to establish a county high school are in the affirmative, it shall be the duty of the county court, within thirty days after canvassing said vote, to locate said school in the town or city within said county receiving the highest number of votes at said election. The county court shall also estimate the cost of purchasing a suitable lot, erecting a building and furnishing the same for the accommodation of such school, with the cost of conducting such school for the next twelve months: Provided, that the county court or the high school board, as herein constituted, may rent suitable rooms for the accommodation of the school. If rooms can be secured in the public school buildings in the place in which said school shall be located, they shall be given the preference.
