Suspect sought after credit card theft

The Cannon Beach Police Department is seeking the public's help in identifying a male suspect in a case of theft and fraudulent use of a credit card.

Corporal Joseph Bowman said the victim's purse was stolen in Cannon Beach on Aug. 1 and that her card was used at a Walmart in Tigard. The purse was later found at a Fred Meyer in the Newberg area.

The suspect is a white male with short, brown hair.

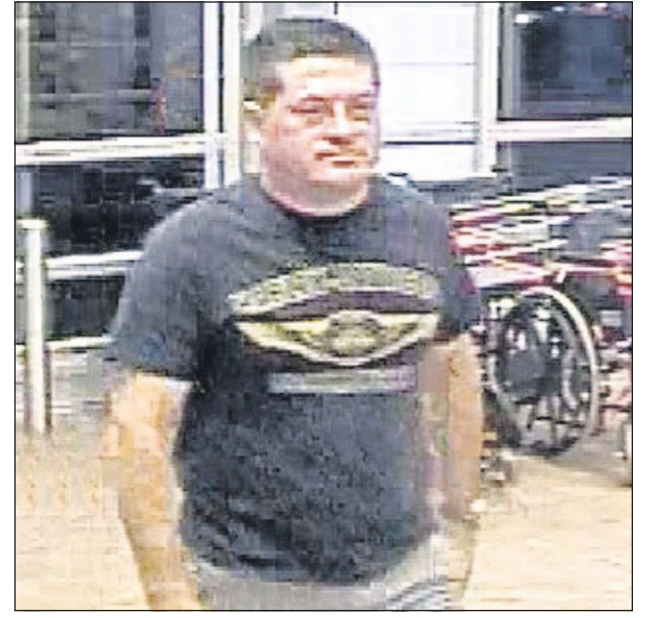
At the time of the fraudulent purchases, he was wearing sandals with a checkered pattern on the

top strap and a watch on his left wrist, Bowman said. He was also seen driving a silver minivan.

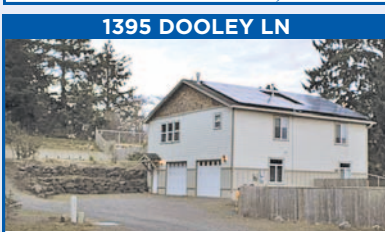
