#### Other updates

As recommended by the Special Districts Association of Oregon, Cannon Beach fire board members will soon use iPads to keep all fire district files and communications in one place and not on personal devices. The change would eliminated some paper waste.

The fire board voted in favor of buying five iPads for about \$500 each. The district has budgeted \$10,000 for office supplies.

In other business, the board will soon hire a full-time employee to replace former

Captain Matt Gardner. The captain would be in charge of training, inspections and human resources.

The fire district responded to 31 EMS calls, six fire calls, three rescues and two surf rescues in July.
