Monroe is to have a co-operative store.

Sheridan has voted \$24,000 school bonds and will build.

The Tillamook Bay Fish Co. will erect a warehouse at Bay City.

Portland Oddfellows have bought site and will erect \$150,000 build ing.

Powers is the name of a new town recently platted in Coos county.

Eugene proposes to drain and irrigate 10,000 acres of rich land between the Willamette and Mc-Kenzie rivers.

Multnomah county will employ 2,000 men on permanent highways to complete the work for which bonds were voted recently.

Cody Warner, who is charged with setting fire to the Petersteiner cafe, where he was employed, and William Jones, charged with a felony, have been indicted by the Klamath county grand jury.

In the neighborhood of 150 attended a function given by the boosters of Beaverton recently. It was a get together meeting in an effort to make a better Beaverton and help in the development of the so week he could not travel, so laid surrounding country.

All but two of the teachers of North Lake county are homesteaders. This was brought out at a teachers' institute just closed at Silver Lake. The two non-homestead instructors are mombers of homestesders' families.

The steamer Zapata, of Tacoma, arrived off the port of Newport this week to engage in halibut fish ing. It is the largest vessel that has yet operated on the Yaquina banks She carries a crew of 40 men, has 12 dories and is equipped with a wireless outfit. Her first catch was over 1000 pounds of first class halibut.

The county commissioners of Gilliam county have decided to hard surface one mile of road this year and if satisfactory arrangements can be made this road will connect with the Condon City payement. The plan of the court is to hard surface at least one mile each year. The first mile will do away with the worst piece of road in the county. There is also considerable agitation in regard to bonding the county for roads and the move has many stanch supporters.

A board of officers to consist of the commanding officer of the seventh brigade, the chief of staff of the western department, Lieutenant Colonel David J. Baker, Jr., of the 21st infantry, is appointed to determine the location of the line in which should be made the final mobile defense of the region immediately south of the mouth o the Columbia river.

The movement to Marshfield of the big government wireless station at Cape Blanco to Coos Bay is practically certain since the official report of Radio Officer O'Connell, U. S. N., sent there to investigate the offered site, expresses satisfaction. George K. O'Hara and five experts from the Mare Island Navy Yard are on hand for the annual overhauling of the station.

While on a fishing trip on the headwaters of the north branch of the Yambill river, above Grand Ronde, V. M. Whitsell and John Meinecke, of Willamina, came upon a Finlander almost completely exhausted. The man attracted by the campfire had by the fishermen, sought to find them but they had left and gone fishing. He tried to find their trail but was down beside a log where the later found him. The poor fellow talked such broken English they were unable to make out much of what he said but learned that he had a homestead in the upper Willimina district and had been working in Tillamook. Being let out of a job he sought to cross the mountains by trail and got lost. For three days he had but one scant meal and was so weak he could scarcely move. The fishermen after filling him up gave him a good supply of grub and put him on the trail.

At a meeting of the swine breeders at North Portland last Tuesday arrangements were perfected for furnishing the boys and girls of all sections of the state with breeding animals with which to make a start in the raising of pork for market. The plan was inaugurated by the Union stockyards some weeks ago, but the call for sows was so great that it was found necessary to enlist the aid of professional hog breeders in order to supply the demand. The stockyards will receive orders for sows, already bred, pass them on to the breeders who have agreed to furnish stock, and on receipt of a Tillamook,

properly endorsed note from boy or girl, the animal will be shipped direct. The notes will become due and payable at the time the pigs are mature and ready for market.
