A Narrow Escape for Mrs. Eizwiler and Infant.

Who is guilty of the fiendish act is not an easy problem to solve and get evidence upon which a conviction could be secured. Kerosene was thrown on the sidewall along the stairway and ignited at about 3 o'clock in the morning. Mrs. Etzwiler and her 4-year-old daughter were sleeping up stairs and Mrs. Etzwiler was awakened by the flash of light. Grabbing the little girl she hastened down stairs and by the use of a little water and a broom extinguished

Some think that the fire was started to burn Mrs. Etzwiler and the child that it might destroy the evidence against Dewey Taylor who is now in Miller, took in the sights at Netarts jail awaiting the investigation of the court on a serious charge preferred by Mrs. Etcweiler in behalf of the little girl. The sheriff and the district attorney, accompanied by a justice of the peace, visited the place Saturday forenoon and the odor of the kerosene was still discernable on the lath. A thorough investigation was made but it was impossible to get a clew sufficient to warrant the officers in making an arrest. Having leased his ranch Mr. McGinnis will as soon as possible move his family to his residence in Cloverdale. He will erect a barn ou his acreage road.


