are all excellent.

Blanc Mange.

Two and a quarter cups milk scalded,
pinch of salt, six teaspoonfuls corn-
starch, one teaspoonful vanilla. Cook
over fire 12 minutes. Stir till thickens.

Prune Whip.

One pound of prunes, cooked and
stones removed, chopped fine and
sweetened, whites of two eggs and one
tablespoon of sugar beaten thoroughly
flavor with banana and serve with
custard.

Devil's Food.

Part 1.—One cup brown sugar, one
cup grated chocolate, one-half cup sweet
milk. Cook together and mix with part
2 when cool.

Part 2.—One cup brown sugar, one-
half cup butter, one-half cup sweet
milk, yolks three eggs, two cups flour,
two teaspoonfuls baking powder, vanilla
flavoring, white icing.

Penocha Candy.

Two and three-fourths cups sugar,
one-half cup corn syrup, one and one-
half cups boiling water. Boil until
brittle. Take from fire, add well beaten
whites of two eggs, one cup walnuts,
flavor and beat about five minutes.

Mayonnaise Dressing.

Cook yolks of four eggs, teaspoonful
salt, two tablespoonfuls olive oil, one
cup vinegar, pinch of redpepper, one
teaspoonful mustard, two tablepoons
sugar.

Nut and Orange Cream.

Three cups brown sugar, one cup
water, butter size of egg, one cup nuts,
one cup orange peel chopped fine. Boil
water, sugar and butter until it forms
soft ball in cold water.
