## SCANDALS RIVAL DAYS OF TWEED

New York Amazed at Reve-  
lations of Irregularities  
on Part of Judges.

New York.—A small, quiet man who  
likes to fish and play golf has as-  
sumed command in New York's latest  
investigation into charges of judicial  
irregularities and political graft on a  
scale unknown since the days of the  
Boss Tweed scandals.

He is Isidor J. Kresel, fifty-two,  
Austrian born and a former United  
States assistant attorney general, who  
has a record for digging up evidence  
which various embarrassed individu-  
als had hoped would remain hidden.

A former law partner of William  
Travers Jerome, Kresel has become  
special counsel to Referee Samuel Sea-  
bury in the investigation of minor  
courts, particularly charges of the  
purchase of judgeships, from the  
Bronx to Battery Park.

Three Years of Inquiry.  
For three years the headlines of  
New York newspapers have shouted  
their story of political and judicial  
investigations in a dozen major scan-  
dals, involving bribes amounting to  
more than \$100,000 and defrauding of  
taxpayers to the extent of from \$5-  
\$100,000 to three times that sum. Since  
the Queens sewer case, which result-  
ed in the sentencing of Maurice E.  
Connolly, president of the borough, to  
a year's imprisonment on charges of  
graft in the construction of sewers,  
the investigations have extended to a  
shortage of county clerk fees, the  
padding of the street cleaning depart-  
ment pay roll and now the magis-  
trates and other courts. As a result:

Five judges have resigned or been  
removed. They are Albert H. Vitale,  
who was removed from the bench on  
charges of borrowing \$20,000 from the  
late Arnold Rothstein, gambler and  
gangster, killed in the Park Central  
hotel, and of discharging a burglar  
friend of Rothstein arraigned on ro-  
bbery charges.

Loan to Tammany Leader.  
George F. Ewald, who resigned after  
an investigation had revealed his con-  
nection with a practically worthless  
mine investment concern, and also  
that his wife had given \$10,000 to  
Martin J. Healy, Tammany hall leader,  
as a loan. W. Bernard Vause, county  
judge, who was found guilty of using  
the mails to defraud and sentenced to  
six years in Atlanta penitentiary.

Francis X. Mancuso, general ses-  
sions judge, who was forced to retire  
because of his connection with the  
City Trust scandal, in which Frank  
H. Wagner, state banking superin-  
tendent, was convicted of receiving al-  
most \$100,000 in bribes. Francis X.  
McQuade, who resigned as magistrate  
because, he announced, of his con-  
nection with the New York Giants Base-  
ball club, at a time when an investi-  
gation was being made into his politi-  
cal activities. County Judge George  
W. Martin virtually relieved himself  
from further service pending outcome  
of an investigation for evidence of  
mail fraud in three companies in  
which he was interested.

Forty-seven per cent of the estimat-  
ed expense of the city of Baker for  
1931 will be met by sources outside of  
taxation. The total estimated expense  
is \$186,532.

The city of Bandon is looking for a  
new dump site. The present site is  
so located that drainage from it flows  
across land used by R. R. Davis for a  
cranberry bog.

The total tax on motor vehicle fuel  
oils during the period January 1-De-  
cember 31, 1930, was \$1,898,409.27,  
according to a report prepared at Salem  
by Hal E. Hoss, secretary of state.  
Sales included 6,803,374 gallons of gas-  
oline and 307,243 gallons of distillate.

All but two small pieces of right of  
way for the last section of the Wil-  
lamette highway between Black can-  
yon and Oakridge have been secured  
and everything is about in readiness  
for the letting of the grading contract  
by the federal bureau of public roads.

Property owners of Roseburg will  
pay taxes this year slightly higher  
than last year. The tax rate will be  
48.5 mills as compared with 44.6 mills  
last year. The increase is due to a  
2-mill tax for the north Umpqua high-  
way and additional levies voted by the  
people.

Completion of a tunnel into the  
Ghost chambers of the Oregon caves  
has been announced by government  
contractors. Regraveling of the high-  
way leading from the Redwood high-  
way to the mouth of the caves is  
under way and will be finished before  
the spring influx of tourists.
