MEXICO'S new ambassador to Washington, Dr. Jose Manuel Puig Casaurane, has received the approval of the American government as persons grata and probably already is on his way to his post at the National Capital, where he succeeds Senor Telles.

Dr. Puig Casaurane is considered one of his country's ablest statesmen, and he has served at home as secretary of education and secretary of industry, commerce and labor. It is not likely that he will find in Washington any problems at present that will give him trouble, for our relations with Mexico just now are entirely satisfactory.

STOCK exchanges of the country, especially that of New York, were warned by Senator James E. Watson of Indiana, majority leader of the senate, that the upper house is likely to adopt a resolution for an investigation of short selling and bear raids. "Many senators," continued Senator Watson, "are of the belief that brokerage houses should not be permitted to lend the securities of their customers unless either expressly ordered to do so by them or their consent is obtained for that purpose. They are of the opinion that an order of that kind by the stock exchange itself would be salutary at a time like this, or falling in that, that some legislation might be enacted that would compel the adoption of such a course."

"They further believe that all short transactions should be thrown open to the public; that the right of sale should be permitted to shine in upon all their deals; and that the names of the individuals and the brokerage houses dealt in should be made known, and that all the details of each transaction should be subject to public scrutiny."

LONDON heard that the former sultan and caliph of Turkey had agreed to resume the duties of the caliphate with certain temporal powers at Jerusalem. The plan, which was conceived by the pan-Islam leader, it was thought might wreck the Indian conference and also revive the Arab-Jewish quarrel in Palestine.

ELECTION of Robert D. Johnson, Democrat, to represent in congress the Seventh Missouri district, succeeding the late Sam Major, gives the Democrats 214 seats in the house, the same number now held by the Republicans. There is one Farmer-Labor member.

DOPE PIUS XI, in an encyclical entitled "Nova Impendit," appeals to "all those of Christian faith and love" to join in a crusade of charity and succor to forestall the evils of unemployment and distress during this coming winter.

The encyclical bears the date of October 2, which, on the church calendar, is the feast of the guardian angels, the protectors of children. The pope lamented particularly that innocent children should suffer from the poverty and hardships in the present economic and financial crisis.

The pontiff's letter dealt with three aspects of international affairs—first, the economic crisis; secondly, unemployment, and thirdly, the race for armaments. He appealed particularly against the rivalry of nations in the matter of armaments, admonishing them against increasing them by enormous expenditures "which might otherwise go to relieve distress."

REPRESENTATIVE LA GUARDIA, Republican, of New York, announced that he proposed to introduce in the forthcoming session of congress a tax revision bill which would assure the treasury \$750,000,000 additional annual income. Mr. La Guardia said this sum would be raised principally through increased taxes in the higher income brackets and inheritance and gift taxes, and the imposition of a 10 per cent tax on automobiles, exclusive of trucks, buses and taxicabs, also on airplanes and yachts.

TOWARD the end of the week the District of Columbia grand jury started on an investigation of the charges that Bishop James Cannon, Jr., and Ada L. Burt had conspired to rough up the federal corrupt practices act during the last Presidential campaign. Miss Burroughs was treasurer of the anti-Smith committee in Virginia, which was headed by the bishop. United States District Attorney Leo A. Rover is directing the inquiry, and he says the charges against the two resulted from a proper report of Cannon's expenditures with the clerk of the house of representatives, as required by law.

The 1928 Presidential campaign activities of the Virginia clergyman are still under investigation by the state campaign funds investigation committee headed by Senator Gerald F. Nye.

FIRST nonstop airplane flight from Japan to the United States was made by Clyde Pangborn and Hugh Herndon, Jr., the young Americans who flew across the Atlantic and then on to Japan, where they were arrested and fined for flying over and photographing fortifications. Starting from Sanpashiro beach and dropping their landing gear, they took the course over Dutch Harbor and down the coast to Seattle. But they didn't stop there. Instead they circled Mt.

Rainier three times and flew on to Wenatchee, Wash., the home of Pangborn's mother, and there made a perilous landing in the dust. The little capital of the apple country went wild over the boys, and a representative of the Japanese paper Asahi handed them a check for \$25,000, the prize for which they were trying.

FRANCE is sending, as its representative at the one hundred and fiftieth anniversary fête at Yorktown, Va., one of its most distinguished soldiers, Marshal Henri Petain, the hero of Verdun. The cruises Duquesne and Suffren are bringing him and his party and will arrive at Yorktown on October 15. In the group are the marquis de Grasse, the marquis de Rochambeau, General D'Almeida, the duc de Noailles and M. Xavier de Rochambeau, all of whom are descendants of Washington's French comrades in arms in 1781.

"I go without official instructions," Marshal Petain said before embarking, "but I shall not be at a loss for subjects to talk about in America. I intend to talk about the American and World War comrades who will meet us at Yorktown and will talk to us about those French soldiers who fought with Washington under the orders of La Fayette, Rochambeau, and De Grasse. For my part I intend to reply by talking about the American soldiers who fought in France in 1917."

PARLIAMENT was prorogued on Thursday and a call was issued for a general election to take place October 27. Prime Minister MacDonald's national government decided not to resign but to go before the electors as constituted. The campaign already is under way. Many of the Liberals pledged their support to MacDonald.

Julius Curtius resigned as foreign minister to Germany because of the attacks of the Nationalists due to his failure to bring about the Austro-German customs union. Next day the entire cabinet resigned and Chancellor Brüning was instructed by President von Hindenburg to form a new government with enlarged powers.

WALL to the knife broke out during the week between Gov. Huey P. Long of Louisiana and Lieut. Gov. Paul N. Cyr. Though elected on the same ticket, the two men have been personal and political enemies, and Cyr has tried repeatedly to get Long out of the office. His latest coup was to take the oath of office as governor on the claim that Long was a United States senator and therefore not governor. This he did at Shreveport, and Long, who was in New Orleans, heard Cyr was moving on Baton Rouge, the state capital. He raced back by automobile and called out part of the National Guard to repel invasion, but the report of Cyr's march proving unfounded, the militia were sent home.

Cyr repaired to his home in southern Louisiana after sending a letter to Long formally demanding surrender of the governor's chair. He said if Long refused he would begin ouster proceedings.

INDUSTRY SEES HOPEFUL SIGNS, BANKERS TOLD

Leading Automobile Unit Expects to Employ More Men This Winter Than Last

MOTOR SUPPLY IN HANDS OF PUBLIC FALLING OFF

Twelve Million Years Less Transportation in Nation's Car Inventory Than Considered Normal, Manufacturer Tells Financiers

ESTIMATING that transportation in the form of automobiles now in the hands of the American public is twelve million "car-years" below normal, and that this deficit will eventually have to be made up, Richard H. Grant, vice president of the General Motors Corporation, recently told the American Bankers Association convention that employment in his company may be greater this winter than last year.

"Employment during the winter months is a very important thing," Mr. Grant said. "So far as our corporation is concerned, in November, December, January and February we will be employing at least as many and probably more men than we did this past year."

In order to gauge the outlook for next year's market his corporation, he said, attempts to set up sales indices based on intensive scientific studies in addition to observation and common sense.

"We are in the habit of looking upon an automobile not merely as an automobile but as transportation," he said. "We figure each automobile produced as six years of transportation. Then by following up records of production yearly, we get a graph which indicates what ought to be a normal inventory of transportation in the hands of the American people, and whether there are more or less miles than might be expected. According to our figures, there are about twelve million years less transportation in this inventory at the present time than has been considered normal since 1925."

The Outlook for Business

"Consequently, if we retain the same purchasing power in this country, it is quite evident that on the first return of business there will be a rush to replace that inventory. In developing this graph, it has come out very strongly that every third year is a big automobile year. The biggest automobile year was 1927 when 4,100,

600 cars were produced for American consumption. This year the industry will produce somewhere between 1,800,000 and 1,900,000 cars. As 1932 is three years after 1929, if economic conditions were normal we could be sure we would do a tremendous business, because the third year is the time when the bulk of the replacing takes place."

He added that there are factors at work that make it uncertain how big the year will be, instancing that "money is being hoarded from lack of confidence and this takes away some purchasing power that we would otherwise have, while family budgets are being cut on account of changes in income conditions, which again means that purchasing power for the automobile, like a good many other things, will be knocked down."

As a result, he said, it was necessary to measure what statistically would be a big year against a practical consideration of the curtailment of expenditures which is going on and determine how big the year will be under these circumstances.

"From a long haul standpoint, regardless of how many automobiles are sold in 1932, we are storing up a big business for the future," Mr. Grant said. "There will be fewer automobiles sold in 1931 than will go to the scrap heap. With 12,000,000 car-years out of the inventory, nine percent more gasoline was used up to August 1, 1931, than was used in 1930. With fewer automobiles, the people must have been running them faster and longer to consume the additional gasoline. This means that we have some 22,000,000 people working hard to make a fine business for our industry when there is an economic recovery."

No False Optimism

"I am not attempting to create any false optimism—I am not speaking without a statistical background. Using the best sense we can, we have drawn conclusions from the figures we have, and I am willing to make the statement that as far as the conduct of our business for the first half of 1932 is concerned, we shall set the indices somewhat higher than the actualities of 1931. We are willing to set our advertising budgets and our selling expense on the kind of indices. With economic conditions as they are, and since the obsolescence is so great and we have sunk so low in this year's sales, we figure that the first half of 1932 must necessarily be better than was the first half of 1931."

Bankers Help

Seven banks of Kennebec County, Maine, cooperated with the county grange, farm bureau, and local creamery, in financing the publication of a booklet, entitled, "The Agricultural Situation in Kennebec County." It presents in a concise manner the farm resources and practices of the county, with suggestions for improvement.

Moro made their first scoring threat in the first half of the game. After Wasco's touchdown they took the ball and drove down the field with line bucks until they were six yards from Wasco goal line at the end of the quarter. The first play of the second period saw them lose the ball and they were never able to get it that far in scoring territory again.

In the last period on another of those successful end runs Wasco crosses the Moro line only to be called back and penalized for holding. A few minutes later though the Moro team softened until Wasco was able to drive through the line for their second score of the game. They did not kick goal as the kick was blocked by McKinney.

Moro's yardage was made by McKinney and Burnett practically all through the line. The young line of the Moro boys did valiant work during the game and probably rose to greater heights of defense than at any time this season, but they were just not fast enough to head the speedy Wasco backs on wide end runs.

For Wasco Williams was the shining light with his passing and running attack, although Walsh as the pass receiver was a sure bet. The entire backfield blocked like veterans.

McKinney and Burnett, the Moro ball carriers, were most in the limelight, but the Moro line young and inexperienced but nevertheless tough, held their ground ably against heavier

opponents. It was the fastest game so far played in this county this year. There was no stalling and the plays were run off in a snappy style that showed good training.
