Senator Steiwer Aids In Taxation Problems

A plan to meet the treasury deficit, without the imposition of special excise taxes is suggested by Senator Steiwer, in his amendment to the Senate Resolution providing for an investigation of Stock market transactions, which passed the Senate March 4th. The Senator's amendment broadens the Resolution to include an investigation of the desirability of the Federal Government taxing securities listed on the stock exchanges. The Senator believes that taxation of stock transactions would provide sources of revenue that would make the excise taxes and nuisance taxes unnecessary.

Congressman Butler and other members of the Oregon delegation, including Senator Steiwer, have taken a stand against the proposed invasion of the gasoline tax field by the Federal Government. This is a tax field enjoyed by the States. It is also believed by members of the delegation opposing a Federal gasoline tax that the tax on gasoline is now high enough, and that additional taxes on this commodity would place an unfair burden on those least able to bear it. The State Highway Department has taken a stand in opposition to a Federal gasoline tax. The same objections are made to the proposed general manufacturer's tax, which adversely affects industries already hard hit. The Oregon delegation has received protests against the manufacturer's sales tax from the canning and other Oregon industries.

Suggested Rations For Growing Chicks Given

With the opening of spring many persons will want to know the best ration for growing chicks and for laying hens. Following is a home-made mash recommended for chicks by F. E. Fox, associate professor of poultry husbandry, which is used with the college flocks:

- 80 pounds ground yellow corn
- 20 pounds ground wheat
- 20 pounds finely ground oats
- 24 pounds millrun
- 10 pounds meat meal
- 10 pounds fish meal
- 15 pounds dried milk
- 8 pounds alfalfa leaf meal
- 5 pounds steamed bone meal
- 5 pounds oyster shell flour
- 1 pound salt

2 per cent cod liver oil, which is about one quart per 100 pounds of mash mixture. In mixing large quantities these proportions may be conveniently multiplied by ten.

The latter part of the third week the chicks are started on scratch feed by scattering some of it over the mash. The scratch feed consists of equal parts of finely ground corn and wheat and is kept before them along with the mash as long as the chicks are in the brooder house.

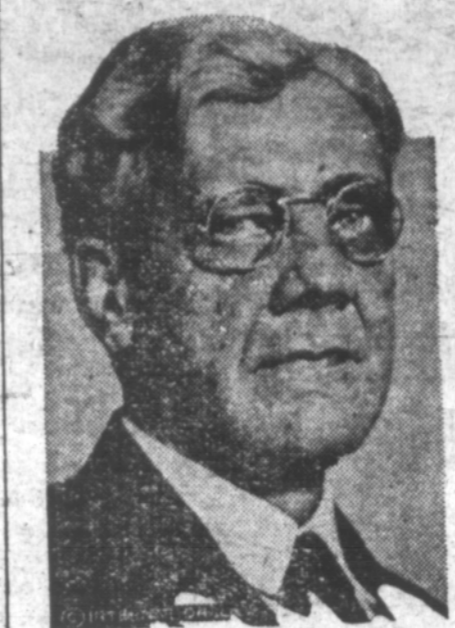
Some modifications are advisable when the chicks are put on the range eliminating 10 pounds of the yellow corn, 5 pounds of the dried milk, and half of the bone meal and oyster shell flour. Ten pounds each of finely ground oats and barley may be added, while the scratch feed may be changed to two parts wheat, two parts corn and one part gray oats.

The mash that has proved satisfactory for laying hens is as follows:

- 320 pounds millrun
- 400 pounds ground wheat
- 400 pounds ground yellow corn
- 200 pounds ground oats
- 100 pounds ground barley
- 200 pounds meat meal
- 100 pounds fish meal
- 100 pounds dried milk
- 80 pounds alfalfa leaf meal
- 50 pounds bone meal
- 20 pounds oil meal
- 20 pounds oyster shell flour

10 pounds salt
 2 per cent cod liver oil in winter

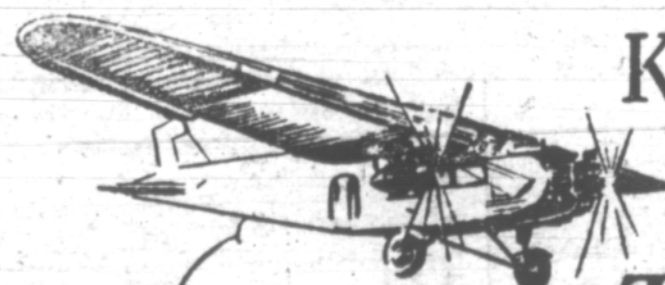
