Brief Resume of Happenings of the Week Collected for Our Readers

Highlights of Monday in the Oregon Legislature

Governor Meier extends bank holidays.

Tithing bill approved by senate. Senate holds whale is not a fish. Bill carrying legislators' per diem approved.

Judge bill is reported out. Governor vetoes four bills. Senate approves bill for constitutional convention.

Moratorium on shutting off service on water, lights, gas and phones proposed in Dunne resolution.

Voters of Oregon will vote for repeal or retention of the amendment of the federal constitution at the first special or general election. Watched by a thronged chamber, 30 members of the senate debated whether or not the people should have a right to elect delegates to a convention such as congress has suggested to the states.

The final vote on house bill No. 523, providing for a convention, was 18 to 12.

Revenue Measure

The senate, with only four dissenting votes, passed a house bill introduced by the joint ways and means committee providing for a "service charge" of 10 per cent on all self-supported state activities which return approximately \$150,000 annually to the general fund.

There was not a dissenting vote on the bill authorizing an appropriation for the payment of per diem and mileage of members of the present legislature. An emergency clause was attached to this measure.

Budget Total Cut Down

Legislative appropriations from the general fund for the years 1933 and 1934, as recommended by the joint ways and means committee of the legislature, aggregate \$5,564,256, as against \$9,755,048 for the 1931-32 biennium, according to a report placed on the desks of the legislators Monday. The statement was prepared by the clerk of the ways and means committee.

Senate Kills Equal Rights Bill

The equal rights bill, guaranteeing to all persons equal rights in public places in spite of race, creed or color, went down to defeat in the senate by a vote of 19 to 9.

Highlights of Tuesday in the Oregon Legislature

Senate passes sales tax bill. Auto license and truck bills passed by the senate.

Special election sought for June 6. Senate overrides veto of Governor Meier.

Bill directed at Judge McMahan fails.

Beer control measure passed. Willamette power development approved.

The general sales tax was passed by the senate by a vote of 19 to 11. The bill carries a provision for reference to the people for approval or rejection at a special election to be held June 6. Slight amendments were made by the senate.

85 Automobile License

The automobile license fee bill and the truck and bus bill, two of the big bills of the present session, both passed the senate Tuesday. The automobile license bill, house bill No. 492, which provides for a flat annual license fee of \$5 with the addition of another cent per gallon to the gasoline tax, and the truck and bus bill, house bill 493, which imposes additional fees upon commercial passenger and freight carriers as well as additional regulations.

Under the provisions of the bill automobile owners will pay \$5 for the license plates for the six-month period from July 1 next to January 1, when the \$5 annual fee becomes operative.

Delinquent Tax Bill Passes House

The house passed the Wheeler delinquent tax bill, after debating it for two hours Tuesday, during which its opponents sought to amend it to weaken it or send it back to a committee.

The bill remits all penalty and interest on taxes delinquent prior to 1931. It then provides that the owner of the property on which taxes are delinquent may pay the delinquency over a 10-year period in semi-annual installments.

The house killed the senate agriculture committee's bill amending the butter grading bill by removing the scoring from the food and dairy commissioner without cost to the creameries and providing that scoring shall be done by a representative of the state-federal grading service for butter and all scores rendered shall be applied upon the basis used in ordinary commercial practice.

Highlights of Wednesday in the Oregon Legislature

Bill creating racing commission enacted.

Bill to compel reduction of all budgets 20 per cent killed. One tax bill recalled from the governor and passed in original form. Thomas utility bill laid on the table in senate.

Resume of Oregon Legislature

Out of 60 days of labor—65 if you count the period of the special session—this legislature has left a trail of legislation behind it stretching all the way from taxation revenue measures to a horse and dog racing law, the latter bearing an emergency clause which proclaims it to be immediately necessary for the preservation of the peace, health and safety of the state and its people. It ranges from the \$5,000,000 a year sales tax to the amendment to the game code which at last gives the city sportsman the right to hunt through a farmer's fields, and to try to pay him for the tracks he leaves with scrip bought of the state game commission.

The sales tax as finally agreed upon by both houses is estimated to yield an annual revenue of approximately \$5,000,000.

In addition to the sales tax the legislature also enacted an emergency addition to the personal income tax, anticipated to yield approximately \$600,000 a year in addition to the income revenue of the present law.

Two other taxation measures were passed of material importance, the one senate bill 75 and the other senate bill 76. The first provides that all penalty and interest on taxes delinquent prior to 1931 shall be remitted. Senate bill 86 provides for the quarterly payment of taxes, starting with March 15 of each year. Interest on delinquent taxes is reduced to one half of 1 per cent a month.

The price-cutting bill was also passed, as was also a bill to remedy recall abuses.

Motor vehicle and highway matters occupied a prominent place in legislative matters. Motorists will pay a flat \$5 fee for the last six months of 1933 and \$5 a year thereafter. They will be asked to pay an additional one cent gas tax, however, which will be effective the first of June. Also drivers' licenses must be renewed each two years, with a fee of \$1.

Truck license fees have been revamped to favor the small truck and to penalize the heavier vehicle.

Licenses on trucks used for agricultural purposes were reduced to two thirds regular fee for a full year license. Seasonal licenses are also provided for agricultural trucks, allowing for a nine months license from March 16 to December 15, for a half-year fee.

Secondary highways and the obligation of completing them was given to the state highway department. For the first time the highway department has been compelled to take over the bonded indebtedness of a road district, as the Salmon river and Umpqua road district bond debt was assumed by legislative action, despite the governor's veto of the measure. The vote to override the veto was almost unanimous in both houses.

For the first time since 1921 a road was placed under the state highway system by the legislature. The Yellowstone cut-off from Valley Falls, near Lakeview, to the Gap ranch near Burns, were added to the system by legislative decree.

Prohibition Legislation

The bill setting up the machinery under which the convention to pass upon the repeal of the 18th amendment to the federal constitution is to be called and conducted.

Power Legislation

"Power" came in for much consideration, resulting in the enactment of two main bills. The first was senate bill 214, which gives added machinery to the law of 1931 authorizing the creation of power districts. The second measure is senate bill 244 which is the enabling act for the power amendment adopted at the 1932 November election.

Old Age Pension

After years of persistence an old age pension act was passed. This provides a pension of not to exceed \$30 a month for persons 70 years and over, who have no children able to support them and who have no property in excess of \$2000 in value.

Unemployment Relief

The machinery under which the unemployment relief work may be carried on, with funds from the Reconstruction Finance corporation, was set up. State funds to the extent of \$250,000 are provided in the sales tax bill.

Then there is the enabling act looking toward the construction of a \$6,000,000 first unit power and water transportation development of the Willamette river.

The "basic science" or "medical fundamentals" bill was passed, together with the other and somewhat companion bill limiting the advertising of dentists.

Certificates of indebtedness of irrigation district, the bond interest of which had been paid by the state and the certificates given the state as security, were canceled, upon the representation that this action would enable the crippled districts to reorganize and refund.

Emergency banking control legislation was rushed through the closing days of the session to meet the financial situation which brought on the necessity for bank holidays, while early in the session the branch bank act was passed.

These briefly are the main high spots of the legislative program though there remains a mass of minor enactments, in the main being amendments of existing laws made for the purpose of bettering administration or enforcement.
