Representative Tells State News

Salem, Nov. 6—The house of representatives voted Wednesday morning in favor of the majority report brought out by the committee on public institutions by 33 to 26 with one absent. Next move is for the two houses to appoint conference committees which will work out the changes necessary to make a bill that can be adopted by the entire legislature.

The senate bill carried by a vote of 23 to 7 while the house bill received a much smaller proportion of the votes cast. There was hard and militant opposition to acceptance of the majority report in the house, but not enough votes could be found to defeat it. The governor's secretary, Josselin, lobbied around the desks of house members until the vote was in progress indicating that perhaps the fine hand of the governor might have been behind the move for the bill.

The house bill empowers the capitol commission to build a capitol building or group of buildings on the old site, with or without additional land or to build on Candalaria heights. Whether or not the Candalaria site was put in the bill for trading purposes, has not been disclosed.

A tax bill that will permit delinquent tax payers to pay their old taxes if they keep their current taxes up was passed by the house the morning and it will undoubtedly receive the signature of the governor making it a law.

It is doubtful if any drastic tax changes will be made at this session to care for the needs of the counties under the old age pension law. A gross income tax bill was defeated in the house. It was held unworkable by a large number of legislators who studied it.

So far the sales tax bill of Snider's is still in the rules committee. It would make a sales tax much like the one in Washington but inasmuch as the voters of the state have refused to sanction a sales tax on two memorable occasions it is likely that this one will be defeated before it goes to the people.

The members of the legislature have settled down to serious work for the third week of the session. More committee meetings, more public hearings and longer sessions each morning and afternoon make it almost necessary that a legislator stay at his desk between spells to catch up on his work, read and study the bills on the calendar and keep up his correspondence.

L.E. Dehler of the Klondike district, was a caller at the court house Thursday to sign his wheat contract, as he is planning a hunting trip into Umatilla county in quest of elk, starting today. Going with Mr. Dehler are his brother, J. E. Dehler, P. G. O'meara, of Wasco, and Austin Kulp, of The Dalles. Mr. Dehler said it was too early to state whether his wheat had been damaged by the cold.

News Of The Legislature

Salem, Ore., Nov. 6—The house was not to be outdone by the senate. Three reports were made by members of the committee and like the senate both minority reports carried the name of but a single man. It is likely that the house, like the senate, will change the majority report before adopting it.

Debate on Tuesday, the first day of capitol building talk had much to do with Candalaria heights which was included in the majority report. Many legislators it seems have suddenly taken an interest in the finer things of life and just discovered that life would hold no pleasures unless the new state capitol was built on the hill south of Salem.

The original site and the site to the north were also included in the majority report, but the talk was nearly all about the desirability of going to the heights and some very good words were used to express the sentiment of the members.

It is an axiom here that speeches other than an explanation of a bill, do no good and there is always fear that some too anxious advocate of a bill will talk it to death. Important measures are talked about in private conversations and decisions that are not easily changed by talking, even with the greatest eloquence.

The session becomes more lively as it grows older. Public hearings of many bills are held each night. The marketing act, that is of great interest to farmers in the Willamette valley was explained, tax bills, social security bills and other of the important legislation had hearings held about it and they will continue until the session is over.

Many of these hearings are very informative for the persons appearing before them are often very well informed on the subject they speak about.

There is good reason to believe that the legislature voted to put the capitol building back on the old site without additional land of some consequence the bill will be vetoed by the governor who has expressed himself as unqualifiedly in favor of a larger site and one with more scenic advantages.

Statistics Given For New Gasoline Refund Law

New regulations in connection with claims for gasoline tax refund enacted by the 1935 legislature and effective July 1 have brought in 5,430 applications for permits to obtain refunds, reports Earl Snell, secretary of state, this week.

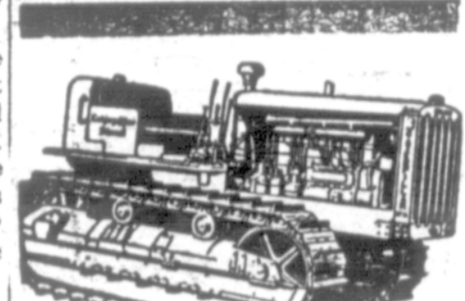
Under the provisions of the new law, all persons claiming refund for taxes paid on motor vehicle fuels on the highways of the state are required to make out a permit, registering equipment used and the purpose for which the motor fuel is purchased. A charge of 50 cents is made for the permit, which is good for one year.

While a rush of applications was received shortly after the new law became effective the first of July, a steady business in issuance of permits has been maintained and it is anticipated that from nine to ten thousand claimants will be on record with the department during the year.

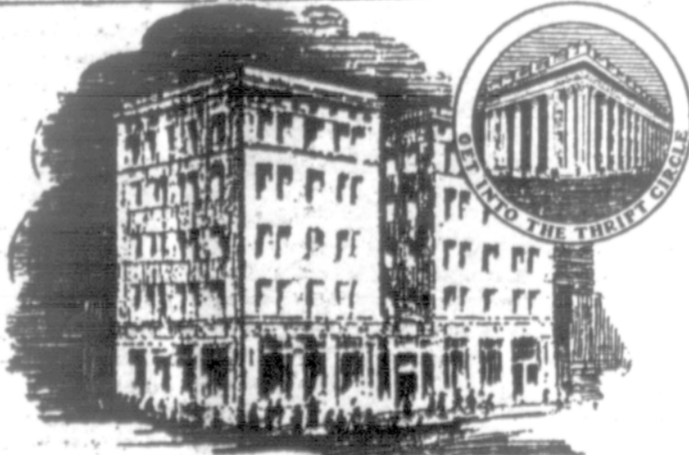

Going After Old Al Capone Taxes



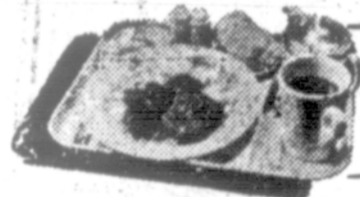
