

C. W. Barzee Tells How County Was Named

Name Of Fulton Refused Because Of Quarrel

Part of this article is written from authentic hearsay and the happenings prior to my settlement in Wasco-Sherman county.

I have not the exact date of the segregation of Sherman from Wasco county but the circumstances connected herewith are well remembered.

The separating of Sherman from Wasco county was made during a session of the legislature when the state was predominantly republican. The state being north of the Mason and Dixon line was born republican with few democrats being elected to the State Legislature. Linn county was one county which always sent a democrat to the legislature. Wasco was a mixed county, politically and Col. Fulton (democrat) had served a term of its session.

Col. Fulton is all the name I ever learned for him. He was a ranking officer in the early day Indian war when men were known for their valor rather than for their education. His popularity led to his election as a member of the Legislature. During this session, this good, honest old soul was endeavoring to put a Bill of his own fathering through when some member moved that the Bill be indefinitely postponed. Col. Fulton, not being a parliamentarian, turned to his colleague seat mate and asked "What effect would that have on the Bill?" This question made considerable merriment for the more learned members. Allow me to say from personal acquaintance with Col. Fulton, that while an education in text books was not his privilege he was a MAN among men. In those early days he was one who was ready to defend this country from the marauding Indian.

I mentioned that Oregon was predominantly republican, Wasco county was a mixed county while Linn was always democrat, likewise Baker. Those were stirring days that followed in the wake of the Civil war. It was not popular to be a democrat and this was Col. Fulton's politics. Digressing slightly to establish this unpopularity, let me speak of one of my early childhood Willamette Valley neighbors who, as was the custom in sparsely settled communities, entertained two travelers over night. After the evening meal while frisking the subject of the civil war came up. This good neighbor being republican, learned that these strangers sympathized with the south. Upon learning this fact this man (Waldo by name) ordered the men to get their horses and leave. "Vamoose," as the Indian would say it. The men insisted they had money to pay for their nights lodging and insisted on not going out in the rain away from his entertainment. Mr. Waldo told them he "did not want any 'soffers' money and they departed. Soon after that Mr. Waldo found his barn destroyed by fire. This is written to give you an insight into the reason why Sherman county was named after the second great civil war general instead of Col. Fulton as was first proposed. Col. Fulton was not so well liked as was Sherman so a compromise was effected by naming the new county, Sherman. Some members of the legislature wished to soothe any feelings the change in the Bill had made, and Col. Fulton was appointed Judge of the new county, as a list of the county officials must be made in the bill. Whereupon Col. Fulton promptly appointed O. M. Scott County Judge, saying he was barely able to attend to his personal affairs and did not wish the burden of that of the county. Thus O. M. Scott became the first county judge. At the next election John Fulton, Col. Fulton's eldest son was duly elected Judge. At the election following Mr. Cuney, a civil war veteran, sought the Judgeship but was defeated by a second term given to John Fulton. So certain was Mr. Cuney of this election in a predominantly republican county that his wife, in company with a group of women on the day of election said, "I am going to stay with the Judge tonight." Some of the women of the group having long acquaintance with the Fulton family remarked, "If you do you will stay with John Fulton."

This will assist in making up the record of early day incidents and the popularity of the Fulton family.

HI-WAYS TO HEALTH

There is probably no one dessert more generally popular than chocolate cake. Whether it is a butter cake with chocolate icing, a chocolate with boiled icing, or an all round chocolate cake, it will find favor with the entire family. And most unusual, indeed, is the housewife who doesn't enjoy baking a cake, a chocolate cake, particularly. However, the experiment will not end successfully unless the housewife follows a few rules set up for cake baking.

In the first place, cake baking once started should be a continuous process. All ingredients specified and utensils needed should be arranged on the work table. And be sure to use good ingredients. You can't do first rate baking with second rate materials. Fine ingredients gives to cakes a flavor and consistency that you can get no other way. Use fresh sweet butter and eggs of fine quality. Don't cut down on the amount the recipe calls for. And remember to measure all ingredients accurately. Then mix the ingredients carefully, following exactly the mixing directions given in each recipe. Remember that the way you combine and handle your ingredients is important.

Don't guess about your baking temperatures. It is amazing the accuracy with which experienced cooks can test an oven with their hand, but inexperienced cooks should never leave baking temperatures to chance. If your stove doesn't have an oven regulator, use a portable thermometer. And finally after baking remember to handle the cakes carefully. Place your butter cake and pan on a cake rack for about five minutes. Then remove from pan and turn top side up on the rack to finish cooling.

The recipe is most important, of course. We suggest a Prize Devil's Food Cake and a Seven Minute Frosting.

Prize Devil's Food Cake
Two cups sifted flour
Two and three fourths tsp baking powder
One fourth teaspoon salt
Two thirds cup butter
One and a half cups sugar
