LABOR LEGISLATION

Farmers throughout the state have been instrumental in having introduced in this legislative session several bills designed to prevent strikes that interfere with the shipment of farm products especially those of a seasonable or perishable nature.

For the other side of the controversy there is another point of view. All labor organizations oppose the bills heartily because it is claimed that the purpose behind them is to restrict the labor unions in a manner that would eventually destroy them.

The principal one of the bills would make it mandatory that all industrial organizations be incorporated under the laws of the state and that unless it provides the corporation commissioner with full information regarding its officers, its place of business and the sums of money collected and expended each year, it shall lose its permission to operate in this state.

It is probably a certainty that no farmer will be able to see the danger of this bill to any labor organization that intended to be fair with its members and the company or companies for which it worked.

No student of industrial history in this country can fail to be impressed with the similarity between the fight of labor against regulation and the fight against regulation that was made, and is still being made, by the so called capitalistic groups.

Yet, so far, we cannot even legally inquire of a labor union, how many members it has, who they are nor how much money was collected or spent.

People of the United States, not members of any class or group, will be the ones who will insist that eventually there be regulation of all kinds of organizations that have to do with the public's business and this will certainly include those who hew wood and draw water as well as those who direct them.

SUPREME COURT

It certainly was not expected by the writers of the constitution that at some future time members of congress would become entirely subservient to the will of the executive power.

Secondly, while the condition whereby one branch of the government gives up to another is bad enough, if the consolidation results in the weakening of the judicial, or third, branch of the government so that the will of one man is able to decide questions of state, there will be no democracy.

The average man cannot imagine the conceit of a man, even the president of the United States, who insists that the whole structure of government be shaped to suit his whims and fancies.

The proposal to enlarge the court is not based on the senility of the members nor upon a lack of ability. It is being done because the present court cannot agree with the sweeping changes ordered by the president are constitutional.

There is no doubt that the court is sometimes out of step with the demands of the day. It sometimes changes its own rulings. It is sometimes proven wrong. That is true of all men and all branches of government.

Representative Grant wants to bring the "insidious" interests that back many of the legislative measures out into the open.

C. M. T. C. Camp

Vancouver Barracks, Washington will again be hosts to the C.M.T.C. Camp for 1937. This year's camp will be held July 1st to July 30th inclusive. Boys from all counties in Oregon and from Clark, Cowlitz, Klickitat, Wahkiakum, and Skamania counties of Washington will be entertained at the camp.

The object of these camps is to bring together young men of high type from all sections of the country on a common basis of equality and under the most favorable conditions of outdoor life, to stimulate and promote citizenship patriotism and Americanism.

To attend camp a boy must be at least 17 years of age, in good physical condition, of good moral character and able to read and write. The complete expenses of attendance at camp are furnished by the government which include \$0.05 a mile paid to the boy for his transportation to and from the camp, a bountiful supply of well-prepared and balanced food, uniforms, quarters and bedding, and full use of recreational facilities.

Requests for information and applications should be made immediately to the C.M.T.C. Officer at Vancouver Barracks, Washington, as it is not always possible to accommodate all who wish to attend.
