Stanfield over blocking of the scattered school lands may lead to the courts. This week the State Land Board received a letter from K. W. Kivette, Stanfield's secretary, indicating that Stanfield may refuse to pay the second half of his lease money on 118,820 acres of this grazing land which he bid in several months ago.

The Oregon Unemployment Compensation commission has leased the entire second floor of the old Salem high school building and will move into the new quarters as soon as remodeling now under way is completed.

Continued from page one. displayed the only Jerseys at the show winning first respectively on bull under two years and bull calf.

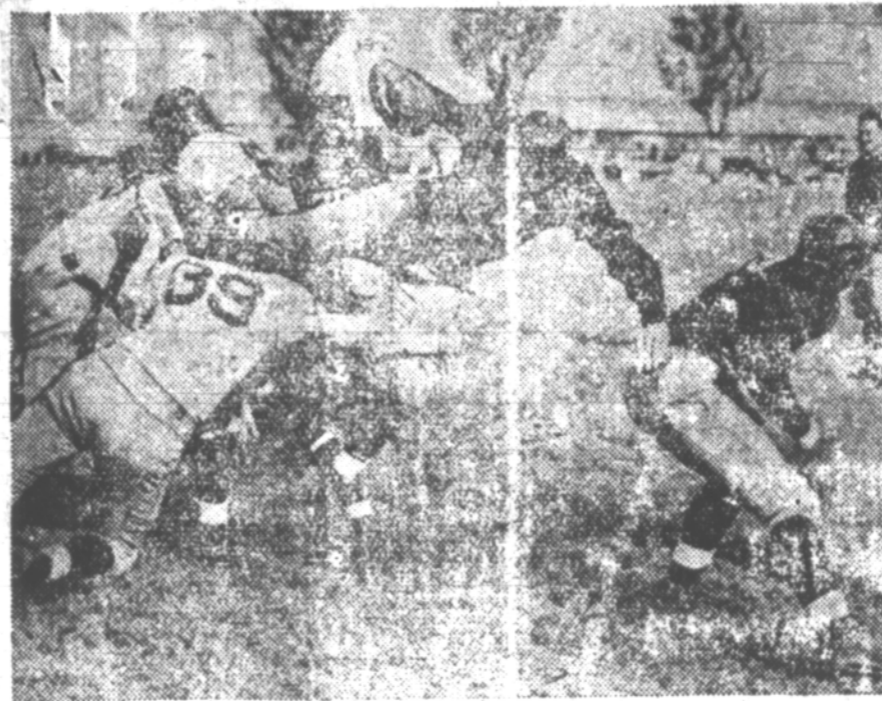

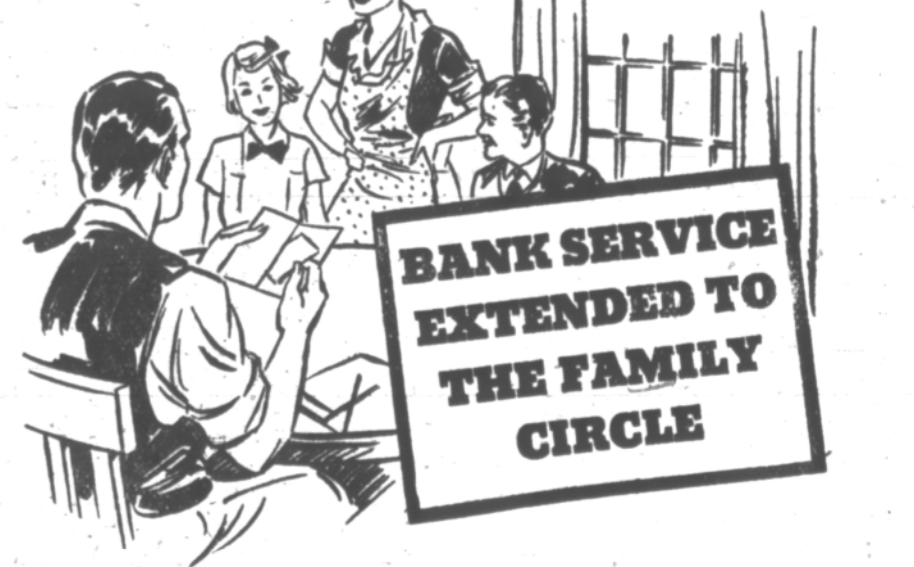
