 LABOR BILLS

Petitions are now being circulated throughout the state to put a bill on the ballot this fall which would protect farmers from interference by anyone in marketing, delivering, processing or handling agricultural products. Purpose of this measure is to make certain that growers will be able to haul and sell their products.

Other provisions of the bill make it unlawful to hinder or molest anyone from seeking to engage his services to any person, firm or corporation. Guarantee is also given to labor union members that they may inspect the books of their unions and that such organizations shall not build up a fund to be used for other purposes than the expressed aims of the unions.

The bill has been initiated so that citizens of the state may have a chance to express themselves about the labor situation that has brought so much of strikes, beatings, shut downs and ill repute to the state in the past two years.

It should be so clearly explained and so generally understood by election time this fall that every voter could and would make his ballot either for a continuance of labor conditions as they are, or for a change designed to force more public responsibility onto leaders of labor.

It is expected that labor leaders will make as hard a fight against the bill as moneyed men of another day made against the income tax and the first steps toward control of industry by government. If it is proper for the nation or the state to regulate industry—and there is little dispute of this nowadays—it is also proper that union leadership be regulated. It will be up to the voters to decide on the matter this fall.

**ELECTIONS**  
 The current problem in political ethics is whether or not it is justifiable for the administration to attempt to influence voters in the several states in their choice for senator and governor.

It is not entirely a new problem for it has been done before but in a much more reserved manner. President Wilson tried it with disastrous results and other presidents have intimated cautiously that they would like to have certain supporters re-elected. The business of trying to dominate elections in practically every state is new, however.

Under this administration the voice of the government is more powerful than it has ever been before because of payments and loans and grants and jobs that are either being given or made available to those who can qualify. Terms of qualification are often at the discretion of federal agencies without definite instructions in the law. The wishes of the administration are therefore very important to many citizens.

If the practice becomes general it will be impossible for voters to express their real sentiment at the polls because of fears of reprisal at the hands of the government they are supposed to honor. It will be government by fear and intimidation.

It has always been considered wrong to inform voters that unless they voted for a certain man the plant in which they are working might be closed, although this has been done. In times when jobs are fairly plentiful this might have little effect. For men who are working on WPA or other government work at a time when jobs cannot be had from other sources it is highly immoral, and bordering on downright dishonesty, to try to influence elections by pleas to voters by the head of WPA who gives more jobs than anyone in the nation.

Tammany and other huge city political machines have made a success of this type of politics, but country people have never been so

lacking in scruples or so easy to bend to the bluff. It is doubtful if it can be made to work in the nation as a whole. If it can we are a long ways on the road to some place where democracy is but a memory—and a faint one.

 sop Saturday to erect tents and prepare mess halls and kitchens for the arrival of the main body of the Guard next Tuesday.

Units from Portland, Astoria, Tillamook, St. Helens, Milwaukie, Newberg and Gresham will be transported to camp by motor trucks. More distant units will be transported by train. The movement toward camp will get under way shortly after Monday midnight when eastern and southern Oregon units will entrain. Five troop trains consisting of 23 tourist sleeping cars, 24 coaches and 18 baggage cars will be required to move these units and their baggage.

The Oregon Guard this year is at the greatest strength in its entire history, according to Major General George A. White who expects 3602 officers and men to attend the 15 days of field training.

The Board of Control has approved an application to the Public Works Administration for a federal grant to help finance construction of a heating plant for the capitol group of buildings. Cost of the building and equipment is estimated at \$125,000 but some of the equipment in the present plant will be salvaged to reduce this cost. The state will finance its share of the cost of this project out of the appropriation for the new library building.

An appropriation of at least \$100,000 will be asked of the next legislature for needed improvements at the state prison, according to Warden James Lewis. Included in the improvements under consideration are the replacement of the cells in the old wing with more modern equipment and the construction of a new cell block. It is also planned to enlarge the space within the walled enclosure, Lewis said.

Election officials here are giving consideration to possible restrictions for the privilege of writing in the names of candidates on election ballots. The privilege, designed to serve a useful purpose, is being ably abused, according to officials here. Many ballots have been found to contain a dozen or more names written-in, many of them the names of fictitious characters. The practice is said to seriously slow up the work of counting the ballots and to clutter up the tally sheets.

Thirty-five persons out of every 1000 in Oregon were on direct relief during April, according to a report of the State Relief Committee to Governor Martin. Baker county, with 49 persons per 1000 on relief, topped the list. Sherman county had the lowest relief ratio, nine out of every 1000.

More than 100 law school graduates have signed up for the state bar examination to be held in Salem July 19 and 20, according to Arthur S. Benson, clerk of the supreme court.

Sewage disposal needs of a number of state institutions are to be studied by a committee consisting of Dr. Frederick D. Stricker, secretary of the state board of health; C. E. Green, staff member of the board, and C. E. Stricklin, state engineer. Their findings will form the basis for appropriation requests to be presented to the next legislature, according to Wallace S. Wharton, state budget director.

**VICTOR TREVITT'S SHAFT USED FOR GUIDE**  
 A granite shaft marks the burial site of Major Victor Trevitt, early day settler, gambler, tavern keeper and politician of The Dalles, where he sleeps alone on Memaloose Island, former death haunt of the mid-Columbia tribes. "I'll take my chances with the Indians in the resurrection," Trevitt often said before his death in 1883. "They are more honest than the whites." After he was buried on Memaloose Island, 12 miles below The Dalles, the Indians took many of their dead away. Finally, months ago, when it was known that Bonneville dam would raise the upper river waters, causing them to overflow much of the island's three-acre extent, the remaining Indian bones were disinterred from the sandy grave pits and removed to the Washington mainland. Today Victor Trevitt sleeps alone on the shrunken half-acre island, the shaft over his grave a landmark for river mariners.
