For a round trip by railroad to both World's Fair at New York and the Golden Gate International Exposition at San Francisco, the railroad fare will be identical for residents of every state in the Union.

The Northern Pacific, Milwaukee, Great Northern, Southern Pacific, S. P. & S. and Union Pacific railroads have announced a blanket fare of \$90 for coach tickets and \$135 for first class tickets for the round trip from home to both world's fairs and back home again. All railroads in the United States are joined in quoting these special low fares which vary only when indirect routes are used. No additional charge will be made from branch line points.

"For instance, starting from any locality, the traveler may go to the New York Fair by any direct route, thence to San Francisco by an ordinarily traveled route and then by direct route back to point of origin; or he can go to San Francisco first, then to New York and back home. The tickets will be available from April 28 to October 28 with return limit of two months from date the ticket is purchased. Stopovers will be allowed at all points on both the going and return trips. Tickets issued at coach fares may be made valid for travel in sleeping cars or parlor cars on payment of additional amounts usually required."
