BONUS AMENDMENT

The measure on the ballot to give a bonus of not to exceed \$500 for each soldier or sailor or marine who fought in World War II is one that would naturally receive many votes out of the public's natural generosity toward the veteran.

However, it does not have the sponsorship of any major veteran organization and local veterans do not seem enthusiastic for it. There are two very good reasons why. First is that most veterans feel that \$500 is pretty small and that money in any quantity is poor recompense for the hardships undergone. Second is that the bill probably leaves out the men of the 41st division who entered service before December 7, 1941. Exact wording is: "Any person who was enlisted, inducted, warranted or commissioned after December 7, 1941, or who reenlisted subsequent to December 7, 1941, and who has served honorably in active duty in the armed forces of the United States, at any time between the 7th day of December, 1941 and the 5th day of September 1945"—and who had been a resident of Oregon a year. That specifically cuts out the men who enlisted before Pearl Harbor although putting them in again by inference.

It is a constitutional amendment and the legislature could not change it.

Bonds would be issued up to three percent of the assessed valuation of the entire state.

There are several sentences of the bill that are poorly written and would need clarification. For instance: "The unmarried widow, or child, or dependent father or mother of any person who died in the service and who would have been entitled to a bonus hereunder had such person lived, shall be eligible to receive such bonus."

Does that mean that only dependent parents or children or widows are eligible? First it says dependent and then says they are eligible—if the deceased would have been—and all who served between the above mentioned dates are eligible.

As practical matter this bill should be defeated and if the veterans want a bonus the real veteran organizations should carefully write a bill—not a constitutional amendment—and not let it be done by some political upstart as was this one.
