BONUS BONDS The state, by itself, and without benefit of bond buyers who are afraid of federal rulings, will soon pay the bonus voted by the people a year ago. That is proper.

This is probably the poorest time in the nation's history for me to receive a bonus because it will definitely aid inflation and prices are already so high the veterans will get little when buying. But these are matters that the people decided last November. They are an argument against the bonus, not against paying one that has been voted.

Funds for the veterans will come from surpluses in the workmen's compensation and unemployment funds. If the state goes on without disturbance in the use of labor everything will be alright; if there is widespread unemployment or major disasters to laborers there may be a shortage in those funds. As of this time the gamble looks safe enough.

THE ART OF CRITICISM

There are so many kinds of criticism, someone perhaps Dale Carnegie, should write a book classifying them.

The usual American method is by real or simulated rallery which often consists of what would be deep insults without the rallery. Among friends such repartee passes for humor.

There is also the brutal method akin to the use of a club in combat; the victim is floored and beaten to the ground. Accompanied by profanity or not it brings on fights, shootings and the eternal hate former privates reserve for sadistic sergeants.

A similar type is more like the use of a rapier, sharper than the club but equally fatal. As the sword is a more civilized instrument than the club the rapier method is used by more civilized people than is the club method. Victims seldom recover—never forgive.

There is a feather pillow kind of criticism which is not damaging unless the victim is smothered, and then there is the Lucretia Borgia kind of criticism consisting of small but incessant doses. It is maddening because the victim doesn't know which one to blow up over.

The character of the critic and the criticize are to be considered. Robert Frost tells of a hard taskmaster of a New England farmer who sang out "Let'er come" from the haymow to a hay pitcher and was promptly covered up for his brashness. There is a story of a Sherman county farmer who in kindly tone directed his hired man to hitch up the driving horse while he got ready to go to town. Said the hired man, "We'll both get ready; we'll both hook up the horse and we'll both go to town." Some are touchy.

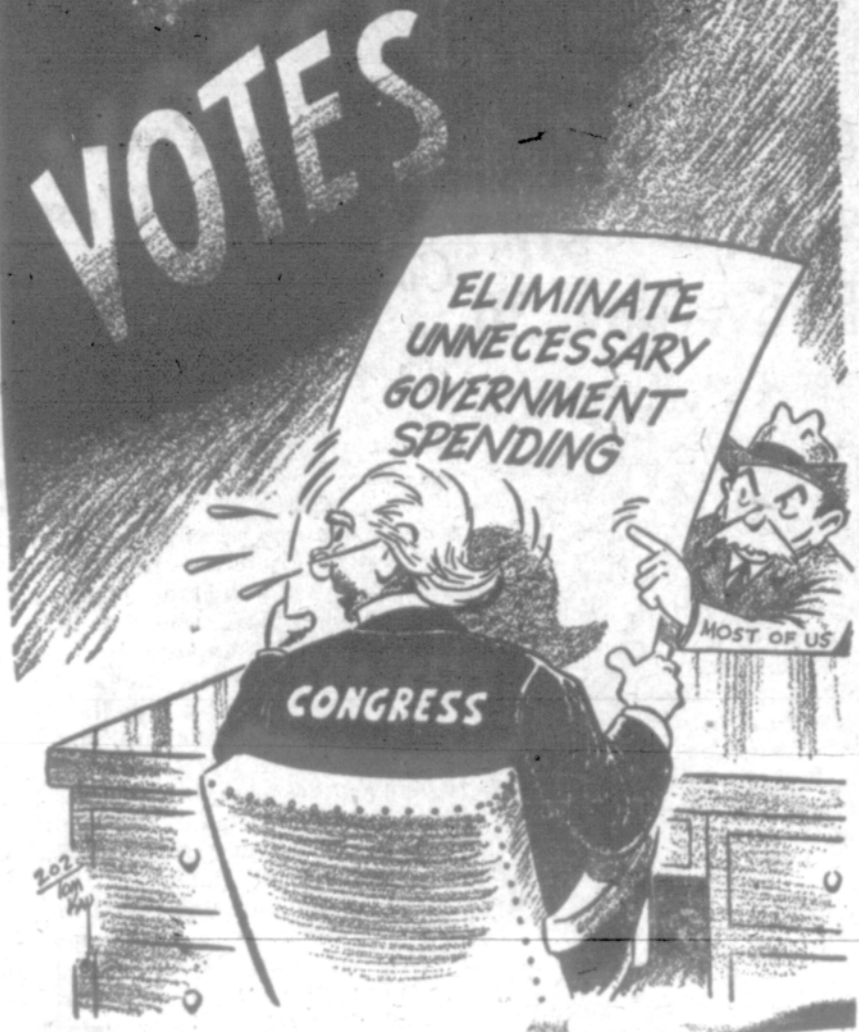
We think it has been said—and if not should be—that the most effective kind of criticism is that which is like salt in food, not quite enough to be noticeable but still enough to enhance the taste. As if it were true that the only use of criticism was to make praise believable.

Voltaire went to England from France and wrote his "Letters on the English" in which he praised them for the phases of their government that were superior to that of the French. Thus he criticized his countrymen without mentioning their names.

There's the man who broke his wife from making soggy bread by praising her biscuits indicating that there's wisdom to be gained from a study of criticism and its benevolent sister—praise.

A newspaper, "The Southern Conservative" arrived some time ago assuring us that the south is not going to be 100 percent in the Truman camp. Presumably the paper is not indicative of the normal thinking of the southerners but the directness of the writing will bring the "Conservative" a number of readers. We've always wondered why southerners should have only one party.

If newspapers are over-full of feature material that is not news it is because the people want it that way.

And since we have started the subject this is as good a place as any to remark that a public spirited and conscientious man in the newspaper business can probably do more good for his community and the people in it than if engaged in any other business. And contrarily, if he is a self-centered cuss with nickels in front of his eyes he can probably do as much harm.

TWO CAMPAIGNS

Both the campaign for sale of U. S. bonds and for the Crusade for Freedom are below requirements in Sherman county. Success of both is advisable from the viewpoint of public interest.

The government is trying to sell some bonds to keep down the supply of money in the hands of citizens as a means of holding inflation to controllable limits. The county quota is small, a mere \$40,000, no more than individuals bought per drive in the war days. Yet the response is unfavorable.

Purpose of the Crusade for Freedom is to raise enough money to expand the program of sending information behind the iron curtain. The county quota is \$400. A small check sent to Mrs. B. Estrella Halley at Wasco or the Journal will aid this fund which is one to give American citizens an opportunity to share in the battle against a foreign ideology.

The government can perform the job that both of these campaigns would give to the people but it would cost more that way. For those who say that more responsibility should be left to the people and less given to the government here are two ways to assure that very thing.
