THE NATION'S ECONOMY

In recent weeks it has been possible for any reader of newspapers and magazines to get a lesson in economics by doing his home reading with care. There have been many reviews of the national economy and a lot of prophecies about what is to come and Secretary Humphrey has been testifying before a senate committee and that brought a lot of opinions and the information on which they were based.

A layman can get informed by his reading and can have his own opinions about it all. His opinions may not be correct, but those of the experts may not always be correct, either.

There is general agreement on some of it. The nation is growing and the population, boosted by millions of babies born in war time and subsequently is soon to be boosted again as these babies start having children of their own. This means greater demand for food and for houses. It will also stimulate most service industries and the sale of cars and household appliances both of which are a little slow right now.

Need for food is being met so easily by greatly increased farm production that prices may not increase as fast as other prices.

Industry, if big steel is its leader, is inclined to raise prices for every wage boost and tack on something for itself. Such tactics will hasten the time when buyers will reduce their demands and could cause a lull in the march of economic growth.

The saver has been having a hard time since the war and interest rates have been low. The saver and the persons on set salaries and pension incomes are the victims of the recent trends in the economy. Harder money will change this condition. That is desirable because it is difficult to imagine a nation with a stable economy without savers. Unless someone saves money there isn't any for investments; with no investments there is no growth except by government.

There is almost universal optimism in looks to the future, mostly on the basis of long looks. There may be some adjustments in the next few years. But generally the optimism comes from the mathematical certainty that 200 million people will eat more than 150 million people, wear more clothes, use more gasoline, have more children. And that the economy will have to expand rapidly to keep up with them.

HISTORICAL TOUR

Something new interested and informed well over a hundred members of the Oregon Historical society last week end and proved to others that history does interest people. It was the first summer meeting of the society. Included was a talk about a little known adventurer and a trip to visit some points of historical interest.

Dr. Dorothy O. Johansen, professor of history at Reed college and co-author of the "Empire of the Columbia" gave the talk and held 130 listeners attentive while she told them of David Thompson, first white man to ravel the length of the Columbia river. The battle for furs was the prime interest of the companies and nations involved 150 years ago when he was establishing trading posts from Spokane to the big bend of the river in Canada.

Sunday visitors to The Dalles from Medford, Roseburg, Eugene and closer points had breakfast at the surgeon's quarters, served by the national guard, visited the new dam across the Columbia and drove out through Wasco county stopping frequently to hear about the emigrant road and the stage stops of nearly a hundred years ago and note the effect that geography had on the history of the area in view.

Many had prepared for the tour by reading the history of Wasco county and all were primed with questions about early day residents or points of interest. All together it was a fine thing to create interest in Oregon history and The Dalles area. That town has one of the longest histories among Oregon towns and might well

make its history a larger part of its publicity.

The day was pleasant, the tourists happy and glad to be learning more about their state and while no great knowledge can be crowded into one day, however busy, each of them will feel a little more familiar with Oregon and a little more attached to it because of the information they obtained.

BEAUTY CONTEST

We are among those who have been intrigued by the battle of the bosoms that so quickly undignified the selection of an Oregon contestant to a California beauty contest. As an amateur judge of livestock it seems that very likely the contest depends too fully on one characteristic. Stock judges fall into habits of that kind. One will put major emphasis on straightness of line, another on depth of heart, one of shape of head, one on fullness of loin. Before a calf gets far in the contests he must be able to qualify on most important points. In this beauty contest it is presumed that the judges all will have the same weakness and that the girl with the biggest busts will claim the prize.

Before long it is possible that women will rebel at this sort of judging. Not that women do not like to be pretty and certainly go to great lengths to meet the supposed demands of men by altering their shape with corsets, coloring their lips with red, etc., but few women can excel at such a contest. Eventually they succeed, if at all, by performance and by other characteristics that have little to do with the points emphasized in beauty contests.

HART MOUNTAIN

Shortly after this is printed the editor expects to start another of the annual pilgrimages to Hart mountain with a party from this area.

It is the meeting of the Order of the Antelope, a distinguished order because it is different from any other. It was started by the Lakeview chamber of commerce some 25 years ago to publicize their need for a through highway and to bring attention to the need for a refuge to preserve the then depleting antelope herds on the south slope of Hart mountain. It succeeded in both.

First gathering consisted of about sixty newspapermen, highway commissioners and civic minded citizens who camped near a long-gone pole cabin and told great tales and made great plans around a camp fire. They liked it and invited others to come in July, and watch the antelope run across the wide flats of the old lake beds and sleep under the stars on a camp site called the Blue Sky hotel.

It is a masculine order. Members pursue the not always strictly masculine activities of talking and lying and renewing acquaintances as well as doing as they please in the way of relaxation. Trips are made to the antelope haunts, some climb the ridge that is Hart mountain, some lie on their beds and talk. The conversation may be desultory and meaningless or it may be stimulating, depending on the men making it. Some of the best conversation in the state is made there. Politics is a favorite subject and doctors, lawyers, editors expound their ideas and argue their points in the shade of the pine trees and the quaking aspens in a manner less restrained than in more formal surroundings.

There is much interest in history and in geography and the group from this area usually returns by Frenchglen and the Blitzen valley to see that fertile spot that is now a bird refuge.

There is more talk of the Brannan plan and farmers may be on the dole in a few years for that is what that scheme amounts to. When did you last hear the expression "the independent farmer?"

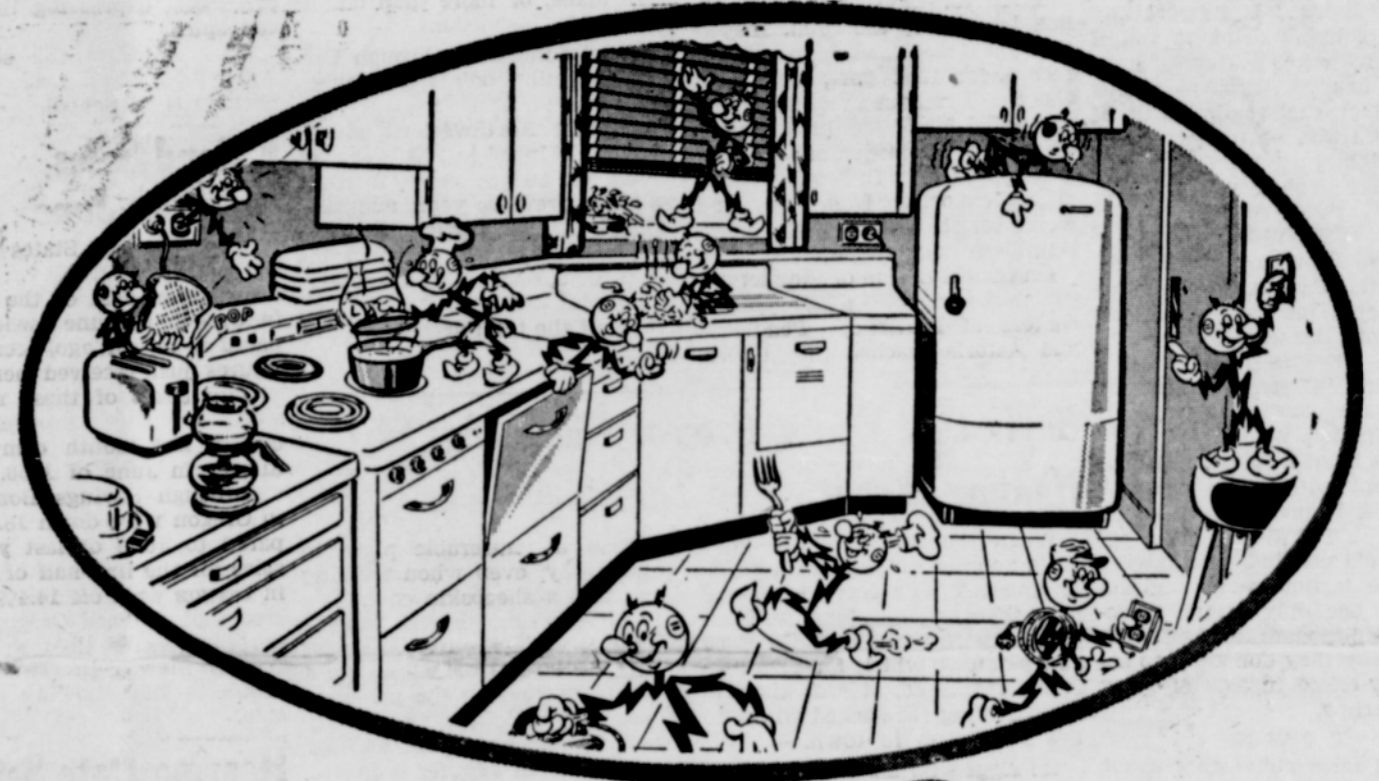
