REWARD AND PUNISHMENT
There are two ways of obtain-
ing obedience. A mother can say
"If you are a good girl, I'll bring
you an ice cream cone" or she can
say "If you do anything bad I'll
spank you good." Neither, of
course, is effective without full
fillment.

There are economic systems
that permit the most able citizens
to accumulate a lot of money,
which seems to tickle them. And
such systems usually have punish-
ments for the less able in the way
of non-accumulation, which seems
to pain them.

If human nature permitted we
might devise a system under
which everyone would receive
the same reward in the way of
monetary returns and the com-
forts of life. Human nature would
not permit because humans
wouldn't produce much if there
were no reward or punishment.
There just would be nothing to
divide.

One of the problems of a gov-
ernment and of an economic sys-
tem is to find a means of encour-
aging citizens to do their best. In
Russia, we read, the theory of
punishment has often been tried.
If a farmer doesn't produce he
loses his land; if a factory work-
er doesn't keep up he is sent to
Siberia. Whether that is true or
not it is an example of one way
to treat human beings. And it is
seldom successful.
