PRESIDENTIAL PRIMARY

A lot of words, not many of them complimentary, are going to be uttered about the new Oregon presidential primary law. We can't imagine how it was passed.

It orders the secretary of state, through his elections division chief, to place on the ballot the names of all persons who may become candidates for the presidential nomination. Any prominent politician may ask that his name be omitted but apparently if there is a petition signed by 1000 voters of his party filed with the secretary of state his protest does not count.

Consequently the Oregon ballot will be top heavy with names of all sorts of persons. In 1960 the Democrats will have the largest number because that party has the most candidates for the nomination next year. Another year it may be different.

Actually a presidential primary is a useless thing at best. That a man is popular in one of the 50 states or that he has a better known local politician as his manager would decide the primary. Candidates for the office of president are chosen by the old pros of the party about nine times out of ten and the other time he is defeated anyway. That is proper Popularity is not a qualification for the presidency although it is for a candidacy.

But then the more absurd the Oregon lawmakers make the primary law the quicker it will be discredited and if we have to go through with it let's get on with the business.
