MORE SURVIVORS NEEDED.

Nearly 3000 Soldiers in the Hospitals at Manila.

Manila, July 22.—Chief Surgeon Woodhill considers that the increase of the military force in the Philippines will necessitate the employment of additional surgeons.

Woodhill's report is not approved by General Otis. There are nearly 3000 soldiers in the hospitals, and the chief surgeon reports that large numbers of soldiers on duty are unfit for service.

THE MARKETS.

Argentine Shipments of Wheat for the Week 1,344,000 Bushels.

Chicago, July 22.—Following is a review of yesterday's grain markets: Wheat opened easy and 1-8c lower at 70 7/8 for September.

Liverpool was slightly higher but receipts were larger and crop prospects good. September sold off immediately to 70 5/8. Argentine shipments for the week were reported at 1,344,000 bushels as compared with 16,000 bushels last year.

THE DEATH OF INGERSOLL

Noted Orator and Author Passes Away at Dobbs Ferry.

His Death Sudden and Unexpected

Fell a Victim to a Stroke of Apoplexy—A Short Sketch of an Eventful Life. His Most Prominent Works.

New York, July 21.—Robert G. Ingersoll died at his home at Dobbs Ferry, N. Y., this afternoon of apoplexy.

Ingersoll went to his summer home at Dobbs Ferry two days ago apparently in good health. Shortly after the cause of death, he was found in his room and shortly before he was struck he was talking to his wife and children.

He was 67 years of age. He was a Quaker and was a member of the Quaker church. He was a noted orator and author.
