Presented to Dewey at City Hall by Mayor Van Wyck.

CROWDS CHEER DEWEY AND SCHLEY

The Admiral Introduces His Captains to the Assembly and Gives Them Credit for the Great Victory at Manila.

New York, Sept. 30.—The second day of New York city official

HUNDREDS OF BOATS WERE IN LINE
