H. R. Neil exhibited a bunch of Australian salt bush, grown on his place near Fulton station. He planted the seed late last spring and with no irrigation it grew to a large size this season. The soil contained a large amount of alkali, and the spot was an unusually dry one. The plant weighed 7 1/2 lbs. and some of its stalks were 3 ft. long. The plant resembles alfalfa somewhat in general appearance, and is said to make first class hay and pasturage.
