Hates the Red Men

Henry Wiseman Lives
Only For Revenge
on Indians.

They Killed and Mangled His
Children Forty Years Ago
and He Took an Awful
Oath of Vengeance.

Fifty miles west of Sioux City, Neb., high above the Missouri river, among the wild, picturesque hills of northern Nebraska, lives an extraordinary man, whose life has been a thrilling romance, full of tragedy, revenge and hatred.

Henry Wiseman was one of the first white inhabitants of Cedar county, set

ting there before 1800. He hailed from Kentucky, was over six feet and straight as the barrel of his long carbine, a fact well known to his enemies both in Kentucky and the west. He was an abolitionist, who left his southern home because of slavery. When he went to Nebraska he had a wife and six children, a number later increased to eight by the birth of twins. The oldest was a boy about twenty. The next oldest was a girl of sixteen.

Wiseman built a log cabin on the side of a hill near the Missouri river in a region that is still wild and romantic. Woods are dense in the valleys. They abounded with game in the early days. Indians were numerous. They passed up and down the river in their canoes and roamed by hundreds over the hills.

At first Wiseman lived on friendly terms with the red men, some of whom were his guests daily, and life in the wilderness was enjoyed by the Wiseman family. But the friendly relations between the Kentuckian and the Indians ended in a awful manner, giving place to a deadly hatred and enmity.

When the civil war broke out Wiseman sent his grown-up son to the front to fight, and the boy fell in battle. Wiseman himself joined a regiment of soldiers to protect the settlers on the frontier against the Indians, who became warlike and bloodthirsty when hostilities began in the south. Thus Mrs. Wiseman and seven children were left at home unprotected.

During the summer of 1862, while the family was in this precarious situation, Mrs. Wiseman was obliged to go to Yankton, N. D., on business. The distance she had to travel was not great, being less than thirty miles, but progress through the wilderness was slow, and she was gone two or three days.

When she returned to her home an awful discovery awaited her. The white door knob was stained with blood. The alarmed woman did not dare enter, but walked around to the rear of the house to look in through a window.

The worst fears took possession of her. Where were her children? Why did they not come running out to meet her and why did she not hear any sounds from them?

Behind the house lay a bleeding Indian the point of death. He had just strength enough to raise himself on his elbow and meet Mrs. Wiseman with a look of unspeakable malice and disgust. That look was never effaced from her memory.

Filled with terror and not having the heart to look into the house, Mrs. Wiseman fled from the place and hurried for help to St. James, a frontier hamlet three miles away. A few hours later she returned with a company of men. They entered the house, where they found stretched upon the floor the dead bodies of the five oldest children. The corpses were horribly disfigured, showing that the victims had been butchered in a most brutal manner.

The two youngest children, the twins, could not at first be found, and it was believed that the Indians had carried them away alive to be reared by squaws. But such was not the case. In searching about the house one of the men opened the door of the oven of the kitchen stove, where lay, roasted to a crisp, the bodies of the infants.

The effect of these shocking disclosures upon Mrs. Wiseman was crushing that she broke down both

mentally and physically, and her life was despaired of. She rallied physically, however, but her mind was partially deranged from that day till her death, thirty-three years later.

It is supposed that during the absence of Mrs. Wiseman a band of Indians approached the house, probably with no hostile intent. The children saw them coming and were filled with fear.

The eldest boy, a lad of about fifteen, seized a loaded gun and when the Indians were a few rods from the house fired at them, wounding the leader. This enraged the rest, and the massacre followed. The dying Indian found by Mrs. Wiseman was the victim of the boy's deadly aim.

It was some time before Wiseman heard of the awful tragedy and returned home. His seven murdered children had been buried in a common grave on the hilltop near his house. There he fell on his knees and swore an oath of vengeance against the red men, that he would kill every Indian that should expose himself to his rifle. And well did he keep his oath.

Mrs. Wiseman died two years ago at an advanced age, but Wiseman still survives. He is over eighty, in good health and still cherishes the same intense hatred for the red men.

New German Game For Women.

Schlagen ball is the newest game for athletic members of the fair sex. It comes from Germany, where it occupies the same position as hockey does in this country.

At present schlagen ball is very little known, and the Battersea Polytechnic is the only place where it is played. Miss Morse, the instructor in the gymnasium, introduced the game, believing it would be a welcome change from hockey.

Schlagen ball is a cross between rounders and baseball, and as translated the name means "strike ball." The players are armed with a wooden "schlagen," some two feet long, with which they have to strike the ball when bowled to them.

The game is played on an open space seventy yards long by fifty wide, and no hits are allowed beyond the boundary. There are eight players on each side, but during actual play only one of the side which is "in" is on the field, although the whole side has to run to the opposite end of the field and back when a hit is made.

Points are scored by runs, catches and hits, points being scored by their opponents if one of the running side is hit by the ball before she has crossed the boundary.

Standing Won From Latham. George Standing, American professional racket champion, successfully defended his title in a match with Peter Latham of England, the world's champion, at the New York Racket and Tennis club recently. Standing won by three games to love in thirty minutes of the fastest racket ever seen in the United States. The scores were 15-6, 15-10 and 15-10. A purse of \$2,000 was at stake.

Standing hardly failed to improve an opportunity, Latham only getting four aces from him on misses. Standing got eleven aces by opponent's misses. Only by service Standing gained only one point in thirteen for Latham, but the Englishman could not do as well as Standing in volleying, and the American gained twenty-three aces by placing balls that could not be returned to fight by placing for Latham. Standing was accurate in racket service and volleys and excelled in footwork.

Sidney Dillon's Property Is Sold. The largest sale of trotting stock at private sale made for many years was consummated at Santa Rosa, Cal., recently, when Sterling R. Holt of Indianapolis, Ind., purchased twenty-five head of the property of Sidney Dillon, the sire of Lou Dillon. The sale was made through Milford Sanders, the driver of Lou Dillon when she made her unequalled record, who is a prominent horseman of Santa Rosa. Eleven of the animals are unnamed yearlings. The money involved in the transaction approximated \$10,000.

Racing Auto Weight Standard. Chairman Robert Lee Morrell of the racing board of the American Automobile association says that perhaps the weight standard for racing cars will be changed next year; but, at any rate, the American Automobile association will have more weight as the national governing body.

Umpire John O'Brien. John O'Brien of Lewiston, Me., the well known former second baseman who did such excellent work on the New England league staff of umpires last season, has been appointed to and has accepted a position on the staff of 1906, for which the league is to be congratulated.

See a Financial Cloud.

Jacob H. Schiff, the New York financier who recently attracted wide attention by predicting that unless our currency system is reformed a panic may ensue, is the head of Kuhn, Loeb & Co., one of the most powerful banking institutions in the country. Mr. Schiff's statement was particularly noticeable because of his well known conservatism in financial matters.

He is opposed to the recommendation of the secretary of the treasury made in his report to congress dated Nov. 6, 1905, to permit national banks to issue a volume of additional government guaranteed currency equal in amount to 50 per cent of the bond secured currency maintained by them, but subject to a tax of 5 or 6 per cent until redeemed.

Referring to this recommendation, he said: "I don't want it to be understood that I am in favor of the recommendation. I think it is a very poor recommendation. I believe if our banks are permitted to issue 50 per cent of their present circulation without security that it will go just where it ought not to go—it will go into speculation. Legitimate business, the merchant and the manufacturer, cannot stand a tax of 5 or 6 per cent on additional currency, but speculation can stand it, and the promoter will pay it, and it will go just where it ought not to go. But we ought to have an elasticity of our circulating medium."

FOR THE CHILDREN

"In the autumn," remarked a naturalist, "the birds and beasts of the countryside occupy themselves in preparing their supplies of winter clothes and bedding just as human beings would do."

"And by their winter clothes," he continued, "I do not mean merely the strict suits of fur or feathers, but all kinds of artificial rug and blankets, which they manufacture themselves."

"Take, first, the water rats, which are famous blanket makers. They fill their lairs in autumn with sheets of the gray vegetable down that grows on various plants in the marshes and by the banks of rivers and brooks. Their beds are often composed of the soft beds of reeds that have been dried and ripened by the autumn sun, with rushes and vegetable down for bed clothes."

"Then there are the field mice, which make their winter beds with layers of dried grass and dead leaves. They are also fond of a few stray feathers and moss, but most of all they prize the white stuff of a kind of grass which makes for them a luxurious mattress. Curiously enough, they do not care for sheep's wool or the hair of any animal, warm as it would be."

"Weasels, on the other hand, despite feathers and are partial to hay and also dried thistles (a prickly sort of bed, one would suppose). They hunt for wool or hair and when they have collected sufficient weave it up with the hay into a very snug bed."

Why the Sea Is Green. The green color of ocean water depends upon the number of medusae and other minute animal forms which inhabit it. The deep green northern seas literally swarm with these minute creatures. In some places as many as 150 of them have been found in a single cubic inch of water. In this proportion a cubic foot of water would contain 221,184, a cubic fathom 47,770,744 and a cubic mile 48,770,000,000.

From soundings made in the districts where these creatures are found in such immense numbers it is probable that the waters will average a mile in depth. Whether these forms occupy the whole depths is uncertain. Provided, however, the depth to which they extend is but 250 fathoms the above immense number of one species may occur within a space of one square mile.
