DEVELOPMENT LEAGUE WORK.

The Sherman County Development League, recently organized by the farmers and business men of Sherman county held a business meeting at the court house in this city Wednesday, March 3d, the circuit court room being well filled with members.

A committee appointed to wait upon the county court which was in session, for aid in advertising the resources of the county, reported that the court had set aside \$1,000 to be expended as the executive committee may see fit.

In the matter of an experimental farm, authorized by the legislature to be instituted in Eastern Oregon by the state and federal governments jointly, the executive committee was authorized to guarantee the experimental farm experts any money, land or improvements desired.

The so-called expert rainmaker, who has operated in Sherman county for two seasons, was set down upon by the League, and his advocates were refused the support of the League in a petition to the county court for \$1,500 to carry on further operations this season. It was the almost unanimous opinion of those present that Sherman county has in the past received too much adverse advertising as a dry farm county, through the rain makers' efforts, regardless of whether rain was produced, which some of the speakers did not concede had been accomplished by the rain experimenter.

One hundred thousand envelopes were ordered, advertising the county, to be circulated by the business interests. A pamphlet was ordered out later on.
